INDIANA STATE NURSES ASSISTANCE PROGRAM

Tom Bissonette, Program Director of the Indiana State Nurses Assistance Program (ISNAP) was present. He reported that there are a total of 341 nurses being actively monitored. He informed the Board that the educational outreach remains a high priority. Tom addressed the students in the audience.

DISCUSSION

In the matter of Donna Ross, LPN, Re: Respondent's Objections to Findings of Fact, Conclusions of Law and Order and Request for Hearing:

Respondent was not present, but was represented by Laura Engleking regarding this matter. Shelly Johnson, Deputy Attorney General represented the State of Indiana. A motion was filed by the Respondent objecting to the wording of the Findings of Fact, Conclusions of Law and Order. Ms. Engelking informed the Board that the motion was filed in a timely manner, but the matter was not set for a hearing timely. Upon advise of counsel, the Board informed Ms. Engelking that it was past the thirty (30) days and that the Board has no jurisdiction to make changes after the thirty (30) days have past. The Board moved that the order will remain as it is.

Advanced Practice Nurse Pharmacology Rule Subcommittee Update:

The subcommittee submitted a draft of the rules for the Board to review. After discussion the Board moved to APPROVE the rule draft and directed Ms. Kelley to continue on to the next step of having the rules approved by the Medical Licensing Board of Indiana.

EDUCATION

Indiana University Northwest – Model for Clinical

Linda Delumas presented a model for clinicals that the school would like to put into operation beginning Spring 2004. They would contract with the hospital to have a full-time master's prepared faculty member on site at all times to oversee a baccalaureate prepared faculty member that would oversee ten (10) nursing students. This would increase the ratio from 3:20 instead of 2:20. This would increase the number of students doing clinical in the hospital. The Board informed Ms. Delumas that this is a very good idea, however at this time, the model is not in compliance with the Board's rules. This is a concept that the education subcommittee has been recently discussing. Their model will be presented to the education subcommittee at their next meeting.

Ivy Tech State College – Request to add an extension site to the ASN program in Muncie

Robert Jeffs, Ph.D., Chancellor, Nancy White, RN, MA, NsgEd, Chair, Cathy Woodward, MS, RN, Health Sciences Division Chair, Gail Chesterfield, Dean and Janet Kramer, MSN, RN, Chair, appeared before the Board concerning an extension site to the ASN program in Muncie. They presented to the Board information regarding extending the ASN program to the Anderson Campus. They would start with twenty (20) students possibly going up to forty (40) students. They would have a full-time program chair. They would have a department chair to cover all three (3) sites. They are currently

searching for faculty members and are working with Community Hospital in Anderson. After discussion the Board moved to APPROVE the extension site.

Rules Subcommittee Update

The Board was informed that the committee went through the entire rules step by step and will have a new draft shortly. Specifics that were considered were the use of full-time faculty, and pass rate criteria. The subcommittee will meet again in August 2003.

Ivy Tech State College Kokomo – Request to increase student enrollment

Laurie Peters, MSN, RN, Division Chair, was in attendance to discuss with the Board the request to increase the annual enrollment from 80 to 100 students per year. They will continue to admit 60 students into the full-time track and will increase the part-time track from 20 to 40 students. They would like to begin this August 25, 2003 with the Board approval. After discussion the Board moved to APPROVE the increase in enrollment.

Vera Cline, MSN, RN, ASN Chair submitted a request to the Board to receive the Board's approval to increase the fall enrollment by 25%. PERSONAL APPEARANCES

EXAMINATION APPLICANTS

Stephanie Kay Burthay – Applicant appeared before the Board and was not represented by counsel regarding a positive response on her examination application. Ms. Burthay has had four (4) DUI's since 1995. She admitted to the Board that she has a problem with alcohol. She has been sober for one and a half (1 ½) months. She attends AA meetings but not on a regular basis. Brenda Breivogel, Lila Roth and Joyce Edwards were sworn in as witnesses for the State. Ms. Breivogel testified that she did the investigation concerning the Respondent. She found that the Respondent had called the residents names, and that she neglected to give a resident fluids indicating that she would catch up later. She also found that the Respondent made a statement to the effect that she wanted to hang a nurse on the first shift. She was employed on April 16th and was terminated on May 3rd. Ms. Edwards testified that she saw the Respondent hit a resident twice and saw her shove a resident that was in a wheel chair down a 46-foot hallway and let go of her. The State of Indiana was represented by Shelley Johnson, Deputy Attorney General and the court reporter sworn in for this matter was Lori Keen. The Respondent by way of counsel requested the Board issue a Summary Judgment. After discussion the Board moved to DENY the request.

CONSENSUS

Sydney McElroy and Doris Oleavis were sworn in as witnesses for the Respondent. Ms. McElroy testified to the Board the in the years she has worked with the Respondent she has never seen or heard her abuse a resident. The Respondent submitted proof to the Board that since 1997 she has taken 120 hours of continuing education. She admitted to the Board that she does have a forward mouth on her, but she never called the resident a hubba bubba. While in the Nurses station during a conversation with another Nurse she admitted that she told the Nurse the resident was a hubba bubba. She told the Board that she has never in her life abused a resident verbally or physically. After having considered the evidence presented, the testimony of the witnesses and taking official

notice of its file in this matter the Board moved to issue a LETTER OF REPRIMAND.
This vote failed to pass.

After further discussion the Board moved to DISMISS the complaint. This vote did not receive a second.
