#### INDIANA STATE BOARD OF NURSING

June 15, 2006

### I. CALL TO ORDER & ESTABLISHMENT OF QUORUM

Ms. Peters called the meeting to order at 8:34 a.m. in the Auditorium of the Indiana Government Center-South, 302 West Washington Street, Indianapolis, Indiana 46204 and declared a quorum, in accordance with IC § 25-23-1-5(b).

## IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT

Ms. Parker arrived at the meeting.

Charles Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of May, 2006, 450 active clients, 23 new intakes, 68 intakes in process and 21 RMA's returned. Mr. Lindquist informed the Board that he represented ISNAP at Fairbanks' "Circle of Hope" dinner/fund raiser on May 15, 2006. Mr. Lindquist stated that fund raising letters for the "scholarship fund" went out to our providers and other potential sponsors. Mr. Lindquist informed the Board that Robin Riebsomer, Intake Coordinator, has developed a system to more effectively complete the intake process in forty-five days or less. Mr. Lindquist also informed the Board that Witham Laboratory has instituted their new ID system that gives ISNAP more flexibility in their random urine drug screening. Mr. Lindquist addressed the audience as requested by the Board.

### V. EDUCATION

### A. Brown Mackie College, Michigan City - Report of Survey Visit

Paul Worcestor, DNS, RN, CFNP, conducted a survey visit at Brown Mackie College, Michigan City on April 10, 2006. Lisa Peterson, RN Nurse Consultant, appeared before the Board. Ms. Peterson informed the

Board that she has a Masters Degree and will be the Program Chair upon approval of the program. She also informed the Board that she will handle the administrative duties. She stated that Brown Mackie College would like to start this program in September, 2006. She also informed the Board that they have not hired any nursing faculty staff as of yet. They will have a library on site; it will be small but they intend to add more computer space. There will be one instructor per ten students in the clinical settings.

A motion was made and seconded to approve Brown Mackie College, Michigan City, on Initial Accreditation.
