### I. CALL TO ORDER & ESTABLISHMENT OF QUORUM

Mrs. Peters called the meeting to order at 8:30 a.m. in the Auditorium of the Indiana Government Center South Building, 302 West Washington Street, Indianapolis, Indiana 46204 and declared a quorum, in accordance with IC § 25-23-1-5(b).

# IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT

Charles Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of May 2007, 468 active clients, 17 new intakes, 36 intakes in process and 20 RMA's returned.

Mr. Lindquist stated that the quarterly reports for January – March 2007 are completed. The significant non-compliance rate has dropped from 25% to 10%. ISNAP met on the 15<sup>th</sup> of May to review those who have applied for the needs assistance fund. They reviewed eight applications, four qualified for assistance, and vouchers were mailed. Mr. Lindquist stated that ISNAP has increased the number of vouchers available to applicants who qualify from 1/3 to 1/2 of the scheduled UDS's that ISNAP will pay for. Additionally, the nurse is eligible to reapply every three months.

Mr. Lindquist stated that ISNAP has completed the review of the nurses whose licenses were suspended with an expired status. Twenty two of the twenty seven nurses have renewed or are in the process of renewing and the other five cases have been closed.

Mr. Lindquist addressed the audience as requested by the Board.

### V. EDUCATION

#### 1. J. Everett Light Career Center - Request to Increase Enrollment

Katherine Callahan-Thompson appeared before the board on behalf of J. Everett Light Career Center. They are requesting an increase in their current enrollment from forty students biannually to sixty students biannually for a total of one hundred twenty students per academic school year. Ms. Callahan-Thompson informed the board that J. Everett Light Career Center will hire another full-time faculty and another part-time faculty this summer. The Board requested to see an update on their progress in the future.

**Board Action:** A motion was made and seconded to approve J. Everett Light Career Center's request for enrollment.

## Vincennes University – Changes in Philosophy, Conceptual Framework & Program Outcomes Request for an Increase in Enrollment for ADN Program at Jasper & BSN Program at Vincennes & Jasper

Jane Vieck appeared before the board on behalf of Vincennes University. In the information submitted to the board, They are requesting the following items to be approved:

- Approval of the revised philosophy, conceptual framework, and program outcomes for the practical nursing program, associate degree nursing program, and the RN-BSN completion option.
- Approval for an increase in first-year enrollment in the associate degree nursing program on the Jasper campus.
- Approval for an increase in enrollment for the RN-BSN completion option at both the Vincennes and Jasper campuses.

Ms. Vieck stated they are now requesting that the Jasper campus be approved for an increase in the fall of 2008 in order to make sure they have enough faculty in place.

The Board informed Ms. Vieck that the philosophy change is an institutional change.

**Board Action:** A motion was made and seconded to approve Vincennes University's request for both their ADN and BSN programs.

#### 3. Marian College - Discontinuance of Admissions to the Generic Associate in Nursing Program

Marian Pettengill appeared before the Board on behalf of Marian College. Ms. Pettengill stated that Marian College has seen a decline in applicants for their ASN program and an increase in students for their BSN program. Ms. Pettengill informed the Board that Marian College has stopped new admissions to the program effective May, 2007.

**Board Action:** A motion was made and seconded to approve Marian College's request to discontinue admissions to their ASN program.

# 4. Ancilla College – Proposal to add LPN to RN Bridge Program

Ann Fitzgerald appeared before the Board on behalf of Ancilla College. The tentative date to open the Program is May, 2008. Ms. Fitzgerald stated they are requesting to begin with a class of twenty LPN students. The LPN students must successfully complete the NR 102 and NR 103 during the summer session. Completion of these programs will allow students to receive verified credit for NR 110, NR 210, and NR 260. The bridge students will then join the ASN cohort for the last two semesters of nursing study. The Bridge program will take one calendar year from May through June to complete. The Board requested Ancilla College submit a table format of curriculum with a course description of all nursing courses. When Ancilla College resubmits the items that are clarified, Laurie Peters, Board member will review them.

**Board Action:** A motion was made and seconded to approve Ancilla College's proposal to add an LPN to RN Bridge Program.

#### 5. Brown Mackie College, Merrillville - Resignation of PN Administrator

Lisa Peterson will not longer be the PN Administrator effective July 1, 2007. Lashun R. Aron is the Interim Dean. FYI For the Board.

## 6. Ivy Tech Community College, Valaparaiso - Resignation of Program Chair

Mary Denise Nesius will not longer be the Program Chair of the ASN program effective May 5, 2007. FYI for the Board.

### A. Appearance by Applicants for Licensure

#### 1. Carl Carnes

Mr. Carnes has been continued until the July 19, 2007 Board meeting.

#### 2. James Drake

Mr. Drake appeared before the Board regarding the positive response on his application for licensure by examination. Mr. Drake pled guilty to a DUI in May of 2001. On September 18, 2003 he was arrested and charged with interfering with a flight crew member. He is currently on probation, which will be finished in January, 2008. Mr. Drake informed the Board that his date of sobriety is September 11, 2003. Ms. Slagle recommended Mr. Drake be made eligible to sit for the examination. Once he passes the examination, his license will issued and placed on Indefinite Probation for the duration of his criminal probation.

#### 3. Shandra Ingram

Ms. Ingram appeared before the Board regarding the positive response on her application for licensure by examination. On March 13, 1999 Ms. Ingram was incarcerated for failure to pay a fine. In 2005, Ms. Ingram admitted herself to Wellstone Regional Hospital for alcohol abuse. Ms. Ingram informed the Board that she has been sober for two years. Ms. Slagle recommended Ms. Ingram be evaluated by ISNAP. Once we receive approval from ISNAP, her license may be issued.

#### 4. Tammy Wall

Ms. Wall did not appear before the Board regarding the positive response on her application for licensure by endorsement. On October 31, 2005 Ms. Wall admitted herself into Brentwood Hospital because of health concerns related to her reliance on prescribed pain medication. Ms. Slagle recommended Ms. Wall's application for licensure by endorsement be denied.

#### 5. Rhonda Sanchez

Ms. Sanchez appeared before the Board regarding the positive response on her application for licensure by endorsement. Ms. Sanchez received a DUI in 2000. A complaint was closed on her license in California on October 19, 2005, which included a fine in the amount of \$500.00 dollars. On March 7, 1989, Ms. Sanchez had a violation of possession of a controlled substance. She completed a drug program. On October 10, 2000 Ms. Sanchez had a violated of driving under the influence of alcohol. On July 16, 2005 she received a civil citation for consuming alcohol. Ms. Sanchez informed the Board that she has contacted ISNAP and been evaluated. Ms. Slagle recommended Ms. Sanchez's license be issued.

#### 6. Becky Berger

Ms. Berger appeared before the Board regarding the positive response on her application for licensure by examination. Ms. Berger was terminated approximately ten years ago for not calling the DON when a patient fell. Ms. Slagle recommended Ms. Berger's license be issued.

### 7. Kimberly Lee Martin

Ms. Martin appeared before the Board regarding the positive response on her application for licensure by examination. Ms. Martin was incarcerated for assisting her husband with burglarizing homes. She was convicted of several felonies and spent 4 ½ years in the Department of Correction. Ms. Martin was released on April 7, 2005 from prison. She was released from parole on April 7, 2007. Ms. Slagle recommended Ms. Martin's license be issued.

#### 8. Sarah Burch

Ms. Burch appeared before the Board regarding the positive response on her application for licensure by examination. On November 3, 2006 Ms. Burch was charged with driving under the influence and operating a vehicle with endangerment to another. Mr. Burch informed the board that the charges were reduced to public intoxication and she was placed on probation for one year. Ms. Slagle recommended Ms. Burch be evaluated by ISNAP. Once we receive approval from ISNAP, Ms. Burch's license may be issued on Indefinite Probation for the duration of her criminal probation. If Ms. Burch is not deemed as a candidate for ISNAP, her license will be issued on Indefinite Probation with quarterly supervisor reports.

#### 9. James Lakin, Jr.

Mr. Lakin, Jr. appeared before the Board regarding the positive response on his application for licensure by examination. In 1999 Mr. Lakin, Jr. was ticketed for underage drinking. In 2000 Mr. Lakin, Jr. was arrested and charged with illegal possession of alcohol by consumption. In 2002 Mr. Lakin, Jr. was charged with disorderly conduct. Ms. Slagle recommended Mr. Lakin, Jr. license be issued once he passes the examination.

### 10. Stormy Fiscel

Ms. Fiscel appeared before the Board regarding the positive response on her application for licensure by examination. Ms. Fiscel attended four county counseling center for drug and alcohol abuse from August 1999 to February 2000. Ms. Slagle recommended Ms. Fiscel's license be issued once she passes the examination.

### 11. Ashley Kenyon

Ms. Kenyon appeared before the Board regarding the positive response on her application for licensure by examination. Ms. Kenyon has been and is still being treated for an addiction to narcotic pain medication. Ms. Slagle recommended Ms. Kenyon be made eligible to sit for the examination and be evaluated by ISNAP. Once we receive approval from ISNAP, Ms. Kenyon's license may be issued on Indefinite Probation for the duration of her ISNAP contract.

### 12. Amie Selke

Ms. Selke appeared before the Board regarding the positive response on her application for licensure by examination. In November, 2002 she was charged with misdemeanor of driving while intoxicated. Ms. Selke had her driver's license temporarily suspended, attended alcohol education classes, community service and was placed on probation. Ms. Selke informed the Board that she has completed all requirements. Ms. Selke also informed the Board that her date of sobriety is March 10, 2006. Ms. Slagle recommended Ms. Selke be made eligible to sit for the examination and be evaluated by ISNAP. Once we receive approval from ISNAP, Ms. Selke license may be issued on Indefinite Probation for the duration of her ISNAP contract.

### 13. Leah Dilts

Ms. Dilts appeared before the Board regarding the positive response on her application for licensure by examination. Ms. Dilts was arrested for driving while intoxicated in July 1997. Ms. Slagle recommended Ms. Dilts license be issued.

### 14. Kymberly Cobb

Ms. Cobb appeared before the Board regarding the positive response on her application for licensure by examination. On July 6, 2006 Ms. Cobb was terminated for practicing outside of her scope of practice. Ms. Slagle recommended Ms. Cobb's license be issued.

### 15. Kimberly Schaefer

Ms. Schaefer appeared before the Board regarding the positive response on her application for licensure by examination. In 2002 Ms. Schaefer admitted herself to the St. Jo Behavioral Health Drug

and Alcohol Dependence Program. Ms. Schaefer stated that her date of sobriety is February 5, 2003. Ms. Slagle recommended Ms. Schaefer be made eligible to sit for the examination and once she passes the examination, her license may be issued.

#### 16. Derek Kuehner

Mr. Kuehner appeared before the Board regarding the positive response on his application for licensure by examination. Mr. Kuehner was charged with criminal recklessness on January 19, 2007. Ms. Slagle recommended Mr. Kuehner be evaluated by a psychologist, specifically addressing coping skills and anger management. Additionally, Ms. Slagle requested Mr. Kuehner to submit reports from his son's counselor in social services with Randolph County. Once all of the reports are received, Ms. Slagle will review them for approval.

### 17. Lisa Wagler

Ms. Wagler appeared before the Board regarding the positive response on her application for licensure by examination. On May 24, 2002 Ms. Wagler was convicted of operating a motor vehicle with .08 or more gram of alcohol, which is a class C misdemeanor. Ms. Wagler received one year of probation, eighty hours of community service, driver's license suspended for thirty days, then probationary license for one hundred eighty days and attended eight sessions of substance abuse psychoeducation. Ms. Slagle recommended Ms. Wagler's license be issued.

#### 18. Mary Gerlach

Ms. Gerlach appeared before the Board regarding the positive response on her application for licensure by examination. On September 5, 2004 Ms. Gerlach was arrested for illegal consumption of alcohol by a minor. On April 22, 2005 Ms. Gerlach committed the violation of minor consumption of an alcoholic beverage with a BAC of .03. On May 12, 2005 Ms. Gerlach was ticketed with minor consumption of alcohol. Ms. Slagle recommended Ms. Gerlach be evaluated by ISNAP. Once we receive approval from ISNAP, Ms. Gerlach's license will be issued on Indefinite Probation for a period of six months of continuous compliance with ISNAP.
