I. CALL TO ORDER AND ESTABLISHMENT OF QUORUM

II. ADOPTION OF THE AGENDA

A motion was made and seconded to adopt the agenda as amended. Burghduff/McIntosh 7-0-0

III. ADOPTION OF THE MINUTES FROM THE MAY 19, 2011 MEETING OF THE BOARD

A motion was made and seconded to adopt the May 19, 2011 nursing board minutes. McIntosh/Laux 7-0-0

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

The Indiana State Nurses Assistance Program gave a brief report. There are currently 554 active ISNAP participants, 28 intakes are in process and 35 closures took place in the month of May with 22 successful completions.

V. EDUCATION

A. IVY Tech Gary ASN Program: REQUEST FOR CORRECTIVE ACTION PLAN, discussion:

Pass Rates: 2007-74.07%, 2008-85.1%, 2009-78.69%, 2010-82%

Ivy Tech Gary presented its corrective action plan to the Board. The campus representatives indicated that they have implemented improvements such as: increased clerical support; filling of a full time vacant position; made improvements in classrooms and labs; faculty is much more involved in student learning and outcomes; and they have begun utilizing programs looking at peer review of tests. Admission is now limited to 20 students; previously they were admitting 33 students. They are also reviewing Mountain Measurement reports. In the past, 10% of their students did not complete

general education courses and so now all students have a faculty advisor during progression through the program. Admission criteria are now completed biannually. They are using the TEAS 5 version and proficiency level for admission.

Board Action: A motion was made and seconded to accept the Corrective Action Plan. Narwold/Ogle 8-0-0

B. IVY Tech Sellersburg ASN Program: REQUEST FOR CORRECTIVE ACTION PLAN, discussion:

Pass Rates: 2008-66.2%, 2009-75.86%, 2010-72%

Ivy Tech Sellersburg has decreased their enrollment 20% for the Summer 2011 session for transition students. Their new ASN program is decreasing by 12%. Improvements to their campus include: engaging students in NCLEX prep; increased rigor of examinations; incorporated assignments with improved critical thinking skills; identifying exam deficiencies and working on correcting those areas. The faculty at the campus is working on their own development in exam writing through an online program given by NCSBN and is now involved in the curriculum development process. Six of the ten full time faculty are in an educational plan working on their masters degree and will complete in approximately 1 ½ years. In past year, this campus has implemented an advising plan that starts when students first enroll and as they are accepted into nursing program have a personal advisor that follows them throughout the nursing program.

Board Action: A motion was made and seconded to accept the Corrective Action Plan. Narwold/McIntosh 7-0-1 (Hall abstains)

C. IVY Tech Kokomo ASN Program: REQUEST FOR CORRECTIVE ACTION PLAN, discussion:

Pass Rates: 2008-63.4%, 2009-73.68%, 2010-80%

Ivy Tech Kokomo has decreased enrollment by 40% and will admit 30 ASN candidates two times a year and 30 transitional students once a year. Improvements to their campus include: working on increasing the ratio for masters prepared faculty; faculty is now working as a group looking at ATI results; the campus recognized that it needed improvement in pharmacology as of January 2010 and has now shown increases; 12 full time faculty are present with 10 masters prepared and 2 currently undergoing masters preparation. The campus will have 2 adjuncts for the fall with baccalaureate degrees but they are both on a master's track. The campus has increased the base salary in region in order to retain masters prepared faculty and they will benefit from state wide advising dollars.

Board Action: A motion was made and seconded to accept the Corrective Action Plan. McIntosh/Ogle 8-0-0

D. IVY Tech Valparaiso ASN Program: REQUEST FOR CORRECTIVE ACTION PLAN, discussion:

Pass Rates: 2006-50%, 2007-71.43%, 2008-71.7%, 2009-72.88%, 2010-84.1%

Ivy Tech-Valparaiso has made improvements in labs and classrooms; is currently reviewing Mountain measurement reports, and remediation now includes written assignments.

Board Action: A motion was made and seconded to accept the Corrective Action Plan. Narwold/Ogle 8-0-0

E. Medtech Greenwood: RN Program site visit and certification

The Board reviewed the final program evaluation. McIntosh and Laux reviewed all documentation and concurred.

Board Action: No vote required.

F. Medtech Fort Wayne PN and RN programs

Narwold conducted a full site visit on May 4, 2011 for the RN and PN programs for full accreditation. This campus is scheduled for an October site visit by NLNAC. Narwold is confused with the PN and RN programs having the same number of credit hours (104 total). Medtech Fort Wayne representatives explained that the PN program was originally a diploma program, and the RN program was previously 144 hours and 8 quarters but was changed. Tuition did not change and is being looked at on a systematic basis. Campus representatives acknowledged that pass rates for the NCLEX are an issue with low numbers. In order to get NLNAC accreditation the campus must have state accreditation. The campus is working on faculty resources and is working on a build out for the nursing department right now.

Board Action: A motion was made and seconded to approve the PN and RN programs for full accreditation. Narwold/McIntosh 5-3-0.

I. Brown Mackie College- Fort Wayne Campus: Request for Curriculum Change

Brown Mackie Fort Wayne Campus would like to make changes to the RN program to allow students to explore further areas of nursing and add dosage calculations to their curriculum. Brown Mackie is in the process of renumbering all courses to integrate with new software.

Board Action: A motion was made and seconded to accept the proposed curriculum changes. McIntosh/Narwold 8-0-0

J. Brown Mackie College- All Indiana Campuses (South Bend, Fort Wayne, Indianapolis, and Merrillville): Request for Curriculum Change

Brown Mackie College is working on strengthening their PN program in Indiana. At all Indiana campuses they would like to delete the following courses: Microcomputers, Entry to Nursing, and Preceptor to Practice. Brown Mackie would like to replace these courses with the following: Essentials of Student Success.

Board Action: A motion was made and seconded to accept the proposed curriculum changes. McIntosh/Narwold 8-0-0

K. FYI – Harrison College Indianapolis Dean of Nursing is Margaret Broadus as of May 15

L. Purdue University School of Nursing: Request for Curriculum Change

Purdue University proposes a change in the sophomore year to include a clinical component and would like to introduce the following: Population Health, Research and Evidence Based Practice.

Board Action: A motion was made and seconded to accept the proposed curriculum changes. Narwold/Ogle 7-0-1 (McIntosh abstains)

VI. DISCUSSION

A. Frederick Nicoulin – Issue with address and NOPD

Board Action: A motion was made and seconded to set aside the default in this matter and reset the matter for July. Burghduff/Laux 7-0-1

B. National Conference Delegates for August 3-5, 2011

A discussion was had regarding the National Conference for the National Council of State Boards of Nursing which will be held in Indianapolis this year. McIntosh and Laux cannot attend.

Board Action: Burghduff and Narwold will be the delegates for the Indiana State Board of Nursing will be Ogle/Laux 8-0-0

C. Election of Officers- Officers were elected earlier this year but were not recorded in the Board’s official minutes.

Board Action: A motion was made and seconded in order to record the election of officers in the official minutes of the Board. Jerry Burghduff will continue to serve as the President of the Board, Lynda Narwold will serve as Vice President, and Constance McIntosh will serve as the Secretary. The next election of officers will be in March 2012. Ogle/Laux 7-0-1 (McIntosh abstains)

D. Donna Murphy, R.N. License No. 28149964A- Request for Voluntary Surrender

Board Action: A motion was made and seconded to deny Ms. Murphy’s request to surrender her license. McIntosh/Ogle 8-0-0

VII. BOARD DIRECTOR REPORT

Crawford gave a brief Board Director’s report regarding the status of the transition to director and welcomed new Board members Dolk, Hall and Presley.

VIII. PERSONAL APPEARANCES

8:45 a.m.

A. Appearances by Applicants for Licensure

The following personal appearances and ALJ recommendations by McIntosh and Laux were accepted by the Board by a vote of 7-0-0 unless otherwise noted:

1. Janice Smith

Ms. Smith appeared before the BON re: application for licensure by examination after 5 previous failures and finishing school in 1998. McIntosh & Laux recommended that her application be denied until she shows documentation of 95% or higher probability of passing test as provided by a refresher course.

2. Rosalynn Anderson

Ms. Anderson was issued a temporary license based on answering no to all questions on the application. Since then, it has come to the attention of the BON that she has had discipline on her IL license. A personal appearance letter was issued for May and Ms. Anderson requested it be rescheduled for June. On 6/13/11 she left word that she could not come in. Her meeting will be rescheduled.

3. Ryne Robbins

Mr. Robbins appeared before the BON re: licensure by endorsement. He disclosed discipline by employer for using medical supplies to treat an intoxicated nurse at the request of other nurses. He stated the matter is resolved. McIntosh and Laux recommended that his license be issued free and clear.

4. Daniel Sturgis

Mr. Sturgis appeared before the BON re: his application by examination. He disclosed DUI arrests in 2005 & 2007. McIntosh & Laux recommended that he have an ISNAP evaluation and sign an RMA if he meets criteria and that he be allowed to test, then his license would be issued on probation for the length of the RMA. If he does not meet criteria, his license will be issued free and clear.

5. Derek Watson

Mr. Watson appeared before the BON re: his application by examination. He disclosed 3 arrests related to accepting stolen property and past drug usage. He reports sobriety since 2001. McIntosh & Laux recommended that he have an ISNAP evaluation and sign an RMA if he meets criteria and that he be allowed to test, then his license would be issued on probation for 3 years with quarterly reports with restrictions on the population he can work with. It does not appear he disclosed these arrests to his nursing school. He may not work in pediatrics, home health agencies or hospice.

6. Allison Davis

Ms. Davis appeared before the BON re: licensure by examination. She reported a DUI in April 2011 while in nursing school. McIntosh and Laux recommended that she be allowed to test and her license be issued free and clear.

7. Tarah Blasko

Ms. Blasko appeared before the BON re: licensure by examination. She reported a DUI in 2004 and minor consumption charge in 2005 while on probation for the DUI. McIntosh and Laux recommended that she have an ISNAP evaluation and sign an RMA if eligible. She would be allowed to test. License can be issued after she completes her ISNAP evaluation.

Board Action: Accepted the recommendation 6-1-0 (McIntosh abstains)

8. Amanda Valdez

Ms. Valdez appeared before the BON for licensure by examination and reported 4 past incidents related to termination, alleged drug use at work, bad check charges and fighting. The last incident was in 2009. McIntosh and Laux recommended that she be allowed to test and her license be issued free and clear.

9. Kevin Jackson

Mr. Jackson appeared before the BON re: licensure by examination. He reported felony arson and insurance fraud charges for setting fire to his house during divorce proceedings. He states the matter was resolved after he complied with all orders of the court. Ms. McIntosh and Ms. Laux recommended that he seek an MMPI II assessment and present the results of this test to the BON. If he is deemed safe to practice, he may be allowed to test and be issued a license free and clear.

10. Jayme Clark

Ms. Clark appeared before the BON re: licensure by examination. She reported an OWI in 2003 and an arrest for trespassing in 2008 on charges made by her mother. Today she also disclosed a DUI in 8/2010 which was not reported on her application. McIntosh and Laux recommended that she have an ISNAP evaluation and sign an RMA if eligible and that her license be issued on probation for the duration of the RMA. If she is not eligible for ISNAP, her license will be issued free and clear.

11. Jessica Thomas-Armor

Ms. Thomas-Armor appeared before the BON re: her application by examination. She reported being on probation until 8/11 for driver's license being suspended for several unpaid tickets and traffic violations. She also reported a termination for attendance. Ms. McIntosh & Ms. Laux recommended she be allowed to test and her license be issued on probation for the length of her criminal probation.

12. David Guimond

This individual appeared before the full Board. Applicant worked in Indiana on an expired temporary permit and signed patient charts with "RN".

Board Action: A motion was made and seconded to grant the license and refer the matter to the OAG for practicing without a license. Burghduff/Narwold 5-0-2 (McIntosh and Laux abstain)

13. Harold Wurster

Mr. Wurster appeared before the BON re: his lic. by endorsement. He reported three arrests for incidents involving anger/alcohol. He stated he has completed all terms of probation and anger mgt. classes. Ms. McIntosh & Ms. Laux recommended he be issued a free and clear license.

14. Jennifer Logston Examination 5 previous failures

Ms. Logston appeared before the BON re: RN lic. by examination. She has failed the test 5 times. Ms. McIntosh & Ms. Laux recommended that her license application be denied. She may reapply if she submits documentation showing she has done a refresher course and has 95% probability of passing the NCLEX.

15. Tracy Wailes

Ms. Wailes appeared before the BON re: licensure by examination. She has failed the test 6 times. Ms. McIntosh & Ms. Laux recommended that her application be denied until she can show documentation from a review course that she has a 95% probability of passing the NCLEX.

16. Larry Beeler

Mr. Beeler appeared before the BON re: his lic. application by endorsement. He reported that he was charged by Drug Task force for trading drugs for rent when he was a drug salesman. He denied the charges but complied with all court orders and the matter is resolved. Ms. McIntosh and Ms. Laux recommended that he be issued a free and clear lic.

17. Kimberly Green

Ms. Green appeared before the BON re: license application by exam. She reported criminal history for writing bad checks and burglary. Ms. McIntosh and Ms. Laux recommended she be allowed to test and her license be issued on probation for 1 year with quarterly reports from supervisors.

18. Ellen Clancy

Ms. Clancy appeared before the BON re: her lic. application by exam. She reported a 2002 DUI and a charge for illegal consumption the same day the DUI was adjudicated. She states she no longer drinks. Ms. McIntosh and Ms. Laux recommended that she be allowed to test and her lic. be issued free and clear.

19. Richard Parke

Mr. Parke appeared before the BON re: his lic. application by exam. He reports a Jan. 2008 DUI and Nov. 2008 minor consumption charge prior to nursing school. He served jail time; in both incidents had BAC below legal limits. Ms. McIntosh and Ms. Laux recommended that he be allowed to test and license be issued free and clear.

20. Genesis Easton

Ms. Easton appeared before the BON re: lic. by examination. She reports a 2003 DUI and minor consumption in 2003 with BAC of .2. She has had treatment and reports last drinking in 2009. She also reported driving on suspended license, speeding. Ms. McIntosh and Ms. Laux recommended ISNAP eval. and sign an RMA if eligible. Then she may test and be issued a license on probation for the duration of the RMA. If she is not eligible for ISNAP, the license will be issued free and clear.

21. Lisa Benet

Ms. Benet appeared before the BON re: lic. by endorsement application. She disclosed that employer and KY BON scrutinized her lic. due to medication administration practices but her lic. was not disciplined. Ms. McIntosh and Ms. Laux recommended that her lic. be issued free and clear.

22. Emily Sill

Ms. Sill appeared before the BON regarding lic. by exam. application. She has failed NCLEX 4 times and finished school in 2007. Ms. McIntosh and Ms. Laux recommended that her application be denied and she may reapply with proof of passing test with 95% probability from review center.

23. Courtney Althoff

Ms. Althoff appeared before the BON for review of her ap. for lic. by exam. She is currently being treated for alcohol abuse and has a DUI in Jan. 2010. She is on probation until June 2012. Ms. McIntosh and Ms. Laux recommended that she complete an MMPI II assessment and send results to the BON for further review. Upon further review, she may be

deemed allowed to test and referred to ISNAP for an evaluation. License may be issued on probation at that time. MMPI must be done first, however.

24. **Brigette Howard**

Ms. Howard appeared before the BON re: her license application by endorsement. She did not disclose that her KY license had been disciplined because the matter had been resolved. She had received a censure/reprimand. Ms. Laux and Ms. McIntosh recommended that her lic. be issued free and clear.

25. **Mary Harrison**

Ms. Harrison appeared before the BON re: her lic. by exam. She reports 3 arrests for OWI and marijuana. States she has not drank for two years. There are also underlying stress/emotional issues. Ms. McIntosh and Ms. Laux recommended she may test; license will be issued free and clear.

26. **Derek Tennell**

Mr. Burghduff appeared as ALJ. Applicant has been convicted of minor possession of alcohol and leaving the scene of an accident. Mr. Burghduff recommends that applicant be evaluated by ISNAP. Recommend to allow to test and be issued full and clear. If applicant fails to contact ISNAP he will be sent back to the Board.

27. **Brandi Wilson**

Ms. Wilson appeared regarding her application by examination. She reported 4 alcohol related convictions. She failed to place one on her application but supplemented her response today. Mr. Burghduff recommends that applicant be evaluated by ISNAP. Recommend to allow to test and be issued a probationary license. Can petition to have lifted after 3 months of full compliance with RMA or after a not meets criteria diagnosis.

28. **Laura Wilson**

Ms. Wilson appeared regarding her application by examination. She reported 3 alcohol related convictions. Mr. Burghduff recommends that applicant be evaluated by ISNAP. Recommend to allow to test and be issued a probationary license. Can petition to have lifted after 3 months of full compliance with RMA or after a not meets criteria diagnosis.

Board Action: A motion was made and seconded to accept the recommendation. 6-0-1 (Narwold abstains)

29. **Tiffany VonBehrens**

Ms. VonBehrens appeared regarding licensure by examination. She reported an alcohol related arrest during nursing school. Applicant was sentenced for DUI, probation 1 year, eligible to get driver's license back. Is still on criminal probation until December 2011. Mr. Burghduff recommends to allow to test and have an ISNAP evaluation and to be issued free and clear upon passing.

30. **Mariam Obiero**

Ms. Obiero applied for licensure by examination and has failed the test 4 times since completing nursing school in 2008. She requested that her meeting be rescheduled.

31. **Robin Cano**

Ms. Cano applied for licensure by examination after 4 previous failures. Mr. Burghduff recommended denying her request to test and that she provide proof of 95% probability of passing the examination. Her ISNAP and criminal conviction issues cannot be addressed today because of the denial.

32. **Corey Stinson**

Mr. Stinson applied for licensure by examination and was charged with DUI but charges were dropped. He appeared before the full Board. It was unclear as to what extent he notified his nursing school of this, if at all.

Board Action: A motion was made and seconded to deny the application. Burghduff/Hall 5-0-1 (Narwold abstains)

33. **Wendy McMullen**

Ms. McMullen appeared before the BON and presented proof of completion of the refresher course as requested by the BON. Ms. McIntosh and Ms. Laux recommended that she be licensed by end.

34. **Emily Cartier**

Ms. Cartier appeared before the BON re: her application for lic. by exam. She has failed NCLEX 3 times and finished school in 2008. Ms. Laux and Ms. McIntosh recommended that her application be denied and she must submit proof of 95% probability of passing the text as shown by a review course if applying again.

35. **Rebecca Rutz**

Ms. Rutz appeared before the BON re: her application for license by exam. She has failed the test 8 times and finished school in 2002. Ms. Laux and Ms. McIntosh recommended that her ap. be denied and she may reapply with proof of review course stating she has 95% probability of passing the test.

36. **Ebony Glenn**

Ms. Glenn appeared for licensure by examination before the full Board. She reported arrests but no convictions.

Board Action: It was recommended to let her test and issue license free and clear. Burghduff/Ogle 6-0-0


