### III. ADOPTION OF THE MINUTES FROM THE FEBRUARY 19, 2015 MEETING OF THE BOARD

### IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Darrell Davis addressed the audience. He gave them an overview of the ISNAP program. He presented the February report to the board members. Now if they see a pattern of partial compliance they will monitor for 2 months then extend the RMA. There was an error on the report and that was corrected. Anne Ogle suggested that something different should be done regarding partial compliance instead of extending the RMA.

### V. EDUCATION

#### A. Indiana State University Site Visit Report (Dr. Lea Hall)

Toni Herron gave the board her site visit report for Indiana State University. This was a schedule site visit that took place in December 2014. Ms. Herron recommends they be removed from plan of correction. Marcie Everly and Lea Hall appeared on behalf of Indiana State University. Motion to accept McIntosh/Ogle 7-0-0

#### B. Indiana University-Purdue University Columbus Request for Separate Accreditation (Dr. Beth Sharer)

This matter was not addressed due to no one appeared on behalf of Indiana University-Purdue University Columbus.

#### C. ITT Tech Merrillville Monthly Report (Kimberly McIntyre Borum)

Kimberly McIntyre Borum, Myra Wood, Ronald Hamm, Dean, appeared on behalf of ITT Merrillville. Ms. Hall addressed concerns over the computerized testing concerns the board had received from students. This is a new testing system for ITT. Per Ms. Wood the instructor had input in the first phase and during the second phase instructors will be able to write questions for the exam. They do not have an actual 20% input to each exam. Instructors are trained how to write exam questions. Mr. Hamm stated that the questions that have been vetted by

faculty come back for review and are then uploaded to the system. Ms. Wood stated that everyone at all campuses is given the same exam during the 1<sup>st</sup> phase but at some point the instructor will be able to pick different questions. The time frame for work order on a question is 24/48 hours. The students' grades can change based on the work order on the questions. The instructor determines whether or not to accept the recommendation on work order questions. They are following the NCLEX blueprint test plan. The test questions are connected to the material being presented during the lecture. There is a mapping process so the questions are asked in relation to what is being taught. Mr. Hamm stated that he reads all the complaints and takes them very seriously. He stated there are 11 complaints from 5 campuses. They are focusing on those campuses to address the complaints. Ms. Wood stated that each test question is tied to a page in the reading so they are covered prior to giving the exam. She has seen an improvement in one course, but is not sure about the others because the first phase just ended. Ms. Laux has requested that this information be placed in the next monthly report. Mr. Hamm stated that they plan on doing a comprehensive evaluation, but do not yet have a date. Ms. McIntyre Borum stated that every facility is represented on the committee for test questions. Ms. McIntyre Borum has had 3 full time faculty members resign since September 2014 out of 9 total faculty members. Those have been replaced and there has been one turnover of program chair. Ms. McIntyre Borum stated the grades can change depending on faculty and that this grade change can go either way. They do send work orders for questions quite often. Ms. Hall stated this is an issue that needs to be addressed. Mr. Hamm stated he agreed with that. They will look into this matter. This test change was put in place at the beginning of the quarter. The process started 18 months ago. It is suggested by the board that some risk analysis be done on this process. Monthly report needs to include some analysis on how phase 1 worked. The board has received more than 11 complaints.

1. information regarding changes in course performance between paper and computerized testing
2. perform risk analysis regarding implementation of process of computerized testing
3. develop process to address grade changes after release to students which may affect student standing in the program

**A. Appearances by Applicants for Licensure**

1. **LaToya King** **RN Exam** **Positive Response**  
LaToya King appeared for a Personal Appearance on March 19, 2015. Ms. King applied for an RN license by examination. She answered "yes" to question 4 on her application for being termination of employment due to not meeting expectations of administrator. Kim Cooper recommends that the license be issued free and clear upon passing the NCLEX exam.
2. **Kathryn Will** **RN Exam** **Grad Date of May 2009**  
Kathryn Will appeared for a Personal Appearance on March 19, 2015. Ms. Will applied for an RN license by examination. She graduated in 2009 and since then has taken the NCLEX exam once in 2010. She hasn't tested again due to having surgery on her right eye at which time she had trouble reading. Ms. Will has worked in home health care and has gotten side tracked with work as oppose to retaking the NCLEX. Ms. Copper recommends that her license be issued free and clear after completing a refresher course and receiving a 95% probability rate of passing before being approved to take the NCLEX exam and passing.
3. **Makisha Lewis** **LPN Exam** **CBC Hit/ Positive Response**  
Makisha Lewis appeared for a Personal Appearance on March 19, 2015. Ms. Lewis applied for an LPN license by examination. She graduated in 2011 and since has taken the NCLEX three times. She is current completing a refresher course with Kaplan that ends in May 2015. She was arrested in 2013 for theft. Ms. Lewis mentioned she has three kids. Ms. Cooper has concerns about Ms. Lewis judgment after graduation from nursing school and children already in picture and therefore has allowed her to test after completing a MMPI-2 and the ISBN receiving results. Once results are received, her application will be reviewed again.
4. **Trista Boxell** **RN Exam** **Four Failed Attempts**  
Tista Boxell appeared for a Personal Appearance on March 19, 2015. Ms. Boxell applied for an RN license by examination. She graduated in 2012 and since has taken the NCLEX four times. She has completed a refresher course with Kaplan. Ms. Cooer recommends that Ms. Boxell's application be denied. She needs to contact her College to find out if they will work with her to complete a course audit in the areas of failing.
5. **Keisha Aldridge** **RN Exam** **CBC Hit**  
Keisha Aldridge appeared for a Personal Appearance on March 19, 2015. Ms. Aldridge applied for an RN license by examination. She graduated in 2014 and has yet to take the NCLEX exam. She answered "no" to question #3 on her application when she should've answered yes. Ms. Aldridge received a ticket, failed to pay, was summons to court and after having her picture taken and finger printed she wasn't aware that she's been arrested. She explained to the Board that she was not trying to deceive the Board and wanted to submit a copy of her criminal history she obtain that doesn't show the arrest. Ms. Cooper recommends her license be issued free and clear after taking a refresher course and upon passing the NCLEX exam.
6. **Daniel Anglin** **RN Endo** **CBC Hit/ Positive Response**  
Daniel Anglin appeared for a Personal Appearance on March 19, 2015. Mr. Anglin applied for an RN license by endorsement. He holds an active license in Michigan. Mr. Anglin has been arrested twice and each time alcohol was involved. Although his Michigan license is free and clear, Ms. Cooper recommends six months probation on active license with the Board receiving quarterly reports from employer.
7. **Manisha Brown** **LPN Exam** **CBC Hit/ Positive Response**  
Manisha Brown appeared for a Personal Appearance on March 19, 2015. Ms. Brown applied for an LPN license by examination. She answered "yes" to question 3 and 4 on her application. Ms. Brown's brother passed away to death while working for Kendricks, although she had FMLA she failed to follow proper procedures in using it and was terminated. She has had one arrest for suspended license. She allowed an ex-boyfriend to put a vehicle in her name. The boyfriend was involved in an accident and she was sued. Ms. Cooper recommends her license be issued free and clear after passing the NCLEX exam.
8. **Deborah Stewart** **LPN Endo** **Positive Response**  
Deborah Stewart appeared for a Personal Appearance on March 19, 2015. Ms. Stewart applied for an LPN license by endorsement. She answered "yes" to question 4 on her application. The resident had a red area on his coccyx that eventually opened. She followed protocol as far as cleaning and reporting however, she was

terminated because she didn't document the incident in the computer, not completing documentation. She has been a nurse since 2002, licensed in Kentucky and worked at facility for 17months. Ms. Cooper recommends her license be issued free and clear.

9. **Jasmine Plough** **LPN Exam** **Positive Response**  
 Jasmine Plough appeared for a Personal Appearance on March 19, 2015. Ms. Plough applied for an LPN license by examination. She answered "yes" question 3 on her application for disorderly conduct over marital dispute. Alcohol was not involved. Ms. Plough pleaded guilty in order to move forward. Ms. Cooper recommends that the license be issued free and clear upon passing the NCLEX exam.
10. **Shelby Von Oepen** **RN Endo** **CBC Hit/ Positive Response CONTINUED**
11. **LaKeisha Johnson** **RN Exam** **Grad Date of December 2011**  
 LaKeisha Johnson appeared for a Personal Appearance on March 19, 2015. Ms. Johnson applied for an RN license by examination. She graduated in 2011 and has not tested due to giving birth and she has had deaths in the family. Ms. Johnson has completed a refresher course at Kaplan and Hurst and need to submit her letter of probability with at least a 95% chance of passing to the board. She did submit to the Board a copy of Hurst review service transaction receipt. Ms. Cooper recommends license be issued free and clear after she submits her probability letter from Hurst and she passes the NCLEX exam.
12. **Amber Doehrman** **RN Exam** **Positive Response**  
 Amber Doehrman appeared for a Personal Appearance on March 19, 2015. Ms. Doehrman applied for an RN license by examination. Ms. Doehrman answered "yes" to question 3 on her application for attempted to steal a \$30 watch from Kohls and was charged with an Class A misdemeanor. She was ordered to complete a diversion program, complete 40 hours of community service, and attend a conversion counseling class. Ms. Doehrman has submitted copies of her diversion agreement and verification form, copy of certificate for the behavior program, and order to dismiss from the diversion program. Ms. Cooper recommends probation with six months active practice.
13. **Michael Bullock** **RN Exam** **Four Failed Attempts**  
 Michael Bullock appeared for a Personal Appearance on March 19, 2015. Mr. Bullock applied for an RN license by examination. Mr. Bullock graduated in 2013 and has failed the NCLEX exam 4 times. Mr. Bullock states he has signed up for the Kaplan refresher course and is currently taking a refresher course with ATI. He states he has test anxiety so Ms. Cooper suggest that he get an evaluation from a physician to determined what type of help is needed to help with his anxiety. Also, he is to contact his college to find out if he can audit courses. Ms. Cooper denies his request until he completes the evaluation.
14. **Kimberly Osborne** **RN Exam** **Four Failed Attempts\***  
 Kimberly Osborne appeared for a Personal Appearance on March 19, 2015. Ms. Osborne applied for an RN license by examination. Ms. Osborne graduated in 2011 and has failed the NCLEX exam 4 times. Although she has taken the refresher course with Kaplan, the exam scores of her last attempt in 2014 were considerably low. Ms. Cooper suggests she request to audit courses at a College and therefore denies her request for licensure by examination.
15. **Kimwana Brown** **LPN Exam** **CBC Hit/ Positive Response\***  
 Kimwana Brown appeared for a Personal Appearance on March 19, 2015. Ms. Brown applied for an LPN license by examination. She answered "yes" to questions 3 and 4 on her application. Ms. Brown failed to pay for a speeding ticket that resulted in an arrest, currently she does not hold a drivers license. Also, she was terminated due of patient dissatisfaction. A resident that she was taking care of complained to someone new in administration about shower and breakfast he received that resulted in her termination. Ms. Cooper recommends her license be issued free and clear upon passing the NCLEX exam.
16. **Anna Perry** **RN Exam** **Grad Date of May 2009\* CONTINUED**
17. **Nikka Culpepper** **LPN Endo** **CBC Hit/ Positive Response\***  
**Ms. Culpepper did not appear, matter to be rescheduled one time.**
18. **Laurie Ragland** **RN Endo** **CBC Hit\***  
**Ms. Ragland did not appear, matter to be rescheduled one time.**
19. **Jessica Small** **RN Exam7** **Failed Attempts/Grad Date of May 2004\*VACATED**
20. **Rachel Stetler** **RN Exam** **4 Failed Attempts\***  
**Ms. Stetler did not appear; reschedule the matter one more time.**
21. **Jennifer Calvert** **RN Exam** **Grad Date of June 2006**  
**Ms. Stetler did not appear; reschedule the matter one more time.**
22. **Jessica Worrell** **LPN Exam** **CBC Hit/ Positive Response**

Jessica Worrell appeared for a Personal Appearance on March 19, 2015. Ms. Worrell applied for an LPN license by examination. She answered "yes" to question 3 on her application regarding a Class A misdemeanor for forgery and corrupt business influence. Ms. Worrell was arrested in 2014 for incorrectly billing Medicaid. She is currently on a 2 year criminal probation and she must complete community service and restitution. Ms. Cooper recommends that Ms. Worrell license be issued on indefinite probation for 2 years or the duration of her criminal probation upon passing the NCLEX exam. She must have her employer submit quarterly reports.

23. **Yandeh Taylor** **LPN Exam** **Positive Response**  
 Yandeh Taylor appeared for a Personal Appearance on March 19, 2015. Ms. Taylor applied for an LPN license by examination. Ms. Taylor answered "yes" to question 4 on her application. She was terminated from her place of employment due to transportation issues. Ms. Cooper recommends her license be issued free and clear upon passing the NCLEX exam.
24. **Jaime Townsend** **LPN Exam** **Positive Response**  
 Jaime Townsend appeared for a Personal Appearance on March 19, 2015. Ms. Townsend applied for an LPN license by examination. Ms. Townsend answered "yes" to question 4 on her application. Ms. Townsend was terminated from her place of employment for leaving a patient unattended in while in the restroom. The last 9 years she has been terminated from 3 jobs while employed as a CNA. Ms. Cooper recommends that her license be issued on indefinite probation for 6 months upon passing the NCLEX exam. She must have employer submit quarterly reports.
25. **Brittney Foster** **RN Exam** **Grad Date of June 2011**  
 Brittney Foster appeared for a Personal Appearance on March 19, 2015. Ms. Foster applied for an RN license by examination. Ms. Foster graduated in 2011 and has taken the NCLEX exam once in 2014. Currently she is taking a refresher course with ATI. Ms. Cooper denies her request to test and recommends she goes to ATI for additional remediation due to her being below standards in a couple of areas on exam.
26. **Laci Littrell** **RN Exam** **4 Failed Attempts** **CONTINUED**
27. **Chanc Mastain** **RN Exam** **CBC Hit/ Positive Response**  
 Chanc Mastain appeared for a Personal Appearance on March 19, 2015. Mr. Mastain applied for an RN license by examination. Mr. Mastain answered "yes" to question 3 on his application for theft in June of 2014. Ms. Mastain was accused of leaving Wal-Mart with shoes and a watch without paying for them. Someone was watching him reported it and a warrant was put out for his arrest. He turned himself in, entered into a diversion program and charges were eventually dropped. Ms. Cooper recommends his license be issued free and clear upon passing the NCLEX exam.
28. **Carrie McKee** **RN Exam** **4 Failed Attempts**  
 Carrie McKee appeared for a Personal Appearance on March 19, 2015. Ms. McKee applied for an RN license by examination. Ms. McKee graduated in 2014 and has failed the NCLEX examination four times. She has completed Kaplan's refresher course and has consulted with a physician. Ms. McKee was prescribed medicine for anxiety. Ms. Cooper has denied Ms. McKee request to test due to never having above passing standards in any area of testing and therefore, recommends she goes back to school to audit several classes.
29. **Carolyn Ellison** **LPN Exam** **CBC Hit/ Positive Response FULL BOARD**  
 Ms. Ellison appeared for her personal appearance regarding her application for licensure. Her LPN was revoked because she applied for an RN license under a false name and practiced under a false name and license. Seven years has passed since the revocation. She went and did course work for an RN degree. However, she wants to sit for her LPN exam. During those seven years, however, she went to RN school. She states that she does not know why she did it. She was charged with getting an RN license under a false name. She got her LPN license in 1982. The incident happened in 1997. She has not had mental health therapy and she was not evaluated at that time. She has had 6 months of psychological evaluation since then. She was working while drawing disability. She applied as Sue Willoughby because she was married to a Robert Willoughby. She did identity deception. She graduated in Kentucky. She had no other names. She then stated her maiden name was Hatch. She applied for a license under another name. She brought documentation about her ex husband that she was trying to escape from by stealing the identity and making money, but she did not submit it. She had no evidence about her psychological status. She had practiced for 20 years without terminations, but cannot say why she did it. A motion was made to deny her application. Motion was granted. Ogle/ Laux 6-0-0
30. **Valarie Terrill** **RN Exam** **Grad Date of December 2011**  
 Valerie Terrill appeared for a Personal Appearance on March 19, 2015. Terrill applied for an RN license by examination. Ms. Terrill graduated 2011 and has failed the NCLEX two times. She is currently taking the ATI refresher course. Ms. Cooper recommends Ms. Terrill completes the course and submit the probability letter before retaking the NCLEX exam.

31. **Lakesha Berryhill** **LPN Exam** **Grad Date of September 2011**  
Lakesha Berryhill appeared for a Personal Appearance on March 19, 2015. Ms. Berryhill applied for an LPN license by examination. Ms. Berryhill graduated in 2011 and has taking the NCLEX once. Ms. Berryhill states that she is a primary care giver and a grandmother as reasons for not taking the exam sooner. Ms. Cooper recommends that she completes a review course and provide the board with documentation showing at least 95% chance of passing before retaking the NCLEX exam.
32. **Antrinique Sanders** **LPN Exam** **Positive Response**  
Antrinique Sanders appeared for a Personal Appearance on March 19, 2015. Ms. Sanders applied for an LPN license by examination. She graduated January 2015. While working as a CNA, Ms. Sanders made a bad discussion to take a patient to the restroom by herself using a lift. The patient slipped out of the lift and suffered from a broken leg. Ms. Sanders was terminated from her position. Ms. Cooper recommends Ms. Sanders license be issued on indefinite probation for one year with active nursing practice and quarterly reports submission from her employer upon her passing the NCLEX exam.
33. **Howard Bailey** **RN Exam** **CBC Hit/ Positive Response**  
Howard Bailey appeared for a Personal Appearance on March 19, 2015. Mr. Bailey applied for an RN license by examination. He answered "yes" to question 3 on her application. Mr. Bailey suffers from depression and has several alcohol related arrest, the last being in 2010 for disorderly conduct. Mr. Bailey states he hasn't a drink in two years and he is currently being treated for his depression. Ms. Cooper recommends Mr. Bailey be evaluated by ISNAP and license is issued on indefinite probation for one year or the length of his agreement with ISNAP, whichever is longer.
34. **Kristina Taylor** **LPN Exam** **CBC Hit/ Positive Response**  
Kristina Taylor appeared for a Personal Appearance on March 19, 2015. Ms. Taylor applied for an LPN license by examination. She answered "yes" to questions 3 and 4 on her application for being convicted of theft in 2013. Ms. Taylor took a wallet that was left on the counter of a gas station. She was terminated from her place of employment because of said arrest. Ms. Cooper recommends Ms. Taylor's license is issued on indefinite probation upon passing the NCLEX exam with a minimum of six months of active practice. She must submit quarterly employer reports to the Board.
35. **Michelle Elliot** **RN Exam** **Four Failed Attempts**  
Michelle Elliot appeared for a Personal Appearance on March 19, 2015. Ms. Elliot applied for an RN license by examination. She graduated in 2014 and has failed the NCLEX exam four times. Ms. Elliot has completed a refresher course. Ms. Cooper recommends that her application be denied. She needs to contact a College to audit classes.
36. **Renee Balay** **LPN Exam** **Grad Date of July 2010**  
Renee Balay appeared for a Personal Appearance on March 19, 2015. Ms. Balay applied for an LPN license by examination. She graduated in 2010 and has failed the NCLEX exam three times. Ms. Balay has completed a review course with Hurst and NCSBN. Ms. Cooper recommends that Ms. Balay completes a refresher course and allowed to test for the last time.
37. **Takiea Thedford** **LPN Exam** **CBC Hit/ Positive Response**  
Takiea Thedford appeared for a Personal Appearance on March 19, 2015. Ms. Thedford applied for an LPN license by examination. She answered "yes" to question 3 and 4 for being arrested for theft and terminated from her place of employment. Ms. Thedford states she has been terminated three times, the most recent in November 2014 for falsifying records with the agency she worked for. On her way to work her breaks went out. She never made it to the clients' home but told the agency she did. Ms. Thedford has been terminated for accepting money from a client and claims of abuse. She was arrested for being with a friend that stuffed a dress into her purse. Charges were dismissed for Ms. Thedford but not her friend. Ms. Cooper recommends that Ms. Thedford license is issued on one year indefinite probation upon passing the NCLEX exam with active practice and submission of employer quarterly reports.
38. **Erica Schmeltz** **RN Exam** **Positive Response**  
Erica Schmeltz appeared for a Personal Appearance on March 19, 2015. Ms. Schmeltz applied for an RN license by examination. She graduated in 2013 and has failed the NCLEX four times. Ms. Schmeltz was denied to test by the board December 2014. The ISBN recommended she be tested by a physician for ADD and seek tutoring. She has submitted letters as proof of completing ATI refresher course, remediation, and physician diagnosis. Ms. Cooper recommends Ms. Schmeltz is issued free and clear upon passing the NCLEX exam.
39. **Amy Sturgis** **LPN Exam** **CBC Hit/ Positive Response**  
Amy Sturgis appeared for a Personal Appearance on March 19, 2015. Ms. Sturgis applied for an LPN license by examination. She answered "yes" to question 3 on her application. In 2009 she was arrested for battery.

Someone approached her and proceeded to hit on her, in defense she fought back. She received a DUI in 2009. Ms. Cooper recommends that Ms. Sturgis receives an evaluation by ISNAP and that she is issued on indefinite probation for the period of one year or the length of her RMA or whichever is longer. She must submit quarterly employer reports to the Board.

40. **Akasha Smith** **LPN Exam** **CBC Hit/ Positive Response**  
 Ms. Smith appeared for her personal appearance regarding her application for licensure. She is a recent nursing graduate and she has been terminated and arrested and they went hand in hand. She was working at a pharmacy in the community. There were some medications that had expired and were not disposed of properly. It was Hydrocodone and it was 123 pills. She took them home and gave them to her boyfriend. The boyfriend sold them. She was a pharmacy tech and her license was revoked. This occurred in 2009. She was charged with diversion for intent to earn money by selling drugs. She disclosed this information when she applied for school. She does not know if the hospitals were aware of it or not. She was originally charged with dealing and possession and theft and pled to the theft charge. Since she had no other trouble and was young they gave her the theft charge and after 3 years probation it can be reduced to a misdemeanor. This happened when she was 19 and she is now 25. She took the meds because her boyfriend sent her a message and told her to. She was fired from her job. He knew other people that told him how to get the pills that had done it before for him. Pharmacy Board has already said no to her. The boyfriend had no pain issues. A motion was made to deny the application. Motion granted. Cooper/Laux 5-1-0 (Hall abstains)


