IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Chuck Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of February 1, 2011, 573 active clients, 14 new intakes, 46 intakes in process, 20 closures in monitoring and 21 new Recovery Monitoring Agreements returned.

Mr. Lindquist presented copies of an article titled: "Helping Nurses Fight Addiction Also Helps Their Patients."

Mr. Lindquist addressed the attendees at the Board Meeting at the request of the Board President and described the nature of the ISNAP program, which provides monitoring and assessment / treatment referral services to nurses licensed in Indiana who meet the program's monitoring criteria.

V. DISCUSSION

A. Suboxone use by licensees / ISNAP participants.

Discussion regarding situation encountered recently by the Board for licensees who were required to complete ISNAP prior to eligibility for withdrawal of probation and who successfully completed ISNAP but began addiction treatment with Suboxone prior to requesting the withdraw hearing – The Board may either approve or deny the request to withdraw the probation at the withdraw hearing, but may modify the terms of the existing probation to address the suboxone use issue if the licensee agrees.

B. Personal appearances – new/renewal applicants.

Board staff is now identifying and scheduling for personal appearances new license applicants who have attempted and failed on three or more previous attempts to pass the NCLEX or who have graduated from nursing school more than 3 years prior to application for licensure. Discussion on guidance for staff on what to inform applicants in this situation will continue.

C. Genevieve York – Requesting renewal of licensure – Has decided that she will no longer agree to a probationary license per ALJ recommendation from a personal appearance conducted on March 3, 2011.

Ms. York previously appeared before the Board's ALJ on March 3, 2011 on her renewal application and agreed to a probationary license. She did not appear at this meeting but sent correspondence to the Board informing of her decision to not accept a probationary license. A motion was made and seconded to deny her renewal application.


