I. CALL TO ORDER AND ESTABLISHMENT OF QUORUM

II. ADOPTION OF THE AGENDA

A motion was made and seconded to adopt the agenda as amended. Burghduff/Laux, 7-0-0, motion carries

III. ADOPTION OF THE MINUTES FROM THE FEBRUARY 16, 2012 MEETING OF THE BOARD

A motion was made and seconded to adopt the February 16, 2012 nursing board minutes. Burghduff/Laux, 6-0-1, motion carries, Dolk abstains

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM ("ISNAP")

Charles Lindquist presented for ISNAP. In February 2012, ISNAP reviewed 7 Needs Assistance Fund applications with 5 qualifications. ISNAP is moving into Phase 2 of implementation of their electronic case management system and will make a presentation to the Board at the April 2012 meeting. A copy of the quarterly compliance report was presented for October, November and December 2011 with 72% of participants demonstrating full compliance in this quarter. The Board also received a copy of the January 2012 ISNAP newsletter and an article regarding the easy availability of controlled substances. Mr. Lindquist then addressed the members of the audience regarding the ISNAP Program.

V. EDUCATION

A. Review of Site Visit for ITT Tech/Breckenridge School of Nursing-Indianapolis (Marcia/Natalie)

Ms. Laux and Ms. Hall presented several areas of concern, among them:

- NCLEX pass rates below the average the last four years
- NLNAC denial in 2011

- Budget and curriculum were controlled by the corporate office and the site visitors expressed concerns regarding faculty input into budget.
- There have been problems with administrative turnover and faculty having adequate knowledge of their syllabi and how it operates.
- The syllabi had not been changed and they can fail every exam and still pass the class.
- The other concern was that when NLN came to see them they had their own offices but when the Indiana State BON visited all faculty were in a congested area and confidentiality was a concern.
- The main concern was consistent substandard performance on NCLEX. They changed their composite score but dropped off science testing.
- The recommendation is for conditional accreditation with one year of scores at or above national standard on NCLEX pass rates. The school was denied NLNAC initial accreditation and that is what prompted the visit. The other concern was inability to get clinical settings due to their accreditation status which will require more simulations. They have no designated full time person for their simulation lab. Students expressed positive sentiments regarding the faculty but concern over the distance to drive to clinicals sometimes over an hour.
- The staff was present and indicated that they have met several of the initiatives that were spoken about today. The Board expressed concern about the decision to drop preadmission testing in the sciences. The staff indicated they have dropped the testing requirement for science because they are teaching these classes in the nursing curriculum. The staff has been following the raw scores for 2012 and, according to their unofficial tracking, the program is at approximately an 80% pass rate at this time.

Board Action: A motion was made and seconded to accept the site surveyors' recommendations. Burghduff/Narwold, 7-0-0, motion carries

B. FYI Only: All ITT Tech/Breckenridge School of Nursing campuses have changed their ASN program school names to Breckinridge School of Nursing and Health Sciences (formerly Breckinridge School of Nursing) effective 2/24/2012

This matter was taken under advisement.

C. Ivy Tech Columbus- Addendum to Fourth Quarter Report and Appearance

Staff from Ivy Tech Columbus appeared before the ISBON and indicated the following:

- The campus submitted an addendum to the fourth quarter and they have improved their pass rates. In 2010, their pass rate was 65.5% and in 2011 was at 86.73%. Presently, in the 1st quarter of 2012 their tracking of unofficial raw scores indicates the program is at 97.9.
- There is a clear expectation regarding syllabi and they are consistent from one course to another for both students and faculty. Any student who fails an exam at 75% or below must meet one on one or two on two with the instructor and complete a self audit. At midterm they review any student failing or at poor performance must sit with the instructor one on one and develop a success plan.
- They have embedded ATI testing into each course and the predictor at the end.
- They have their own nursing advisor as of the Fall 2010 who keeps track of students and they cannot register until they meet with the nursing advisor.
- They have increased preparation for the NCLEX through ATI review and reimburse for this. State wide initiatives: empowering their faculty all committees are resurrected including curriculum, each faculty must participate in at least 2 committees, library resource committee and professional development committee as well. Faculty also is responsible for planning the two yearly retreats.
- There is a Dean mentoring program in place that meets once a month. There is an ongoing review of nursing curriculum via committee.
- Admission criteria have increased as well and the Dean is going to teach the Capstone course. Capstone has 2 clinical credits and 1 credit for the remainder.
- Every student preparing for graduation must sit with faculty one on one for preparation for an NCLEX plan, improvement and success. They have a daily study calendar that the student must put into place. They are also making personal phone calls to students after graduation to insure they are studying.

The Board commended this program on the great strides they have made in improving their program. The program continues on conditional accreditation at this time, no vote or board action was required.

D. Everest College RN Program- Report on Initial Accreditation Site Visit and Appearance (Lynda/Karen)

Ms. Narwold and Ms. Dolk reported on their two trips to Everest College. In September 2011 the school was not ready to open the ASN program as construction was not complete. Their PN program is very successful. A second visit was made in February 2012 with a well organized facility with resources and faculty in place. All faculty teaching in this program are masters prepared. The curriculum is complete and well put together. The site visitors recommend initial accreditation for the ASN program.

Board Action: A motion was made and seconded for initial accreditation. Narwold/Laux, 7-0-0, motion carries

E. Harrison College ASN Program (Indianapolis East and Fort Wayne Campuses) - Request for curriculum revision
Staff was available from Harrison College regarding their requested change in ASN curriculum revision. The board expressed no concerns regarding their curriculum changes.

Board Action: A motion was made and seconded to accept. Laux/Burghduff, 6-0-1, Hall abstains

F. FYI Only- Letter from parent of Ancilla College Student

A site visit is scheduled in April 2012 and these concerns will be addressed at that time.

G. FYI Only- University of Southern Indiana-Dr. Nadine Coudret is on sabbatical from 1/3/12 to 6/31/12 (sic) and is retiring effective 6/31/12 (sic); Dr. Ann White named Interim Dean as of 1/3/12. (Correspondence dated 3/7/12)

The Board took this matter under advisement.

H. FYI Only- Medtech College, Indianapolis Campus RN and PN Programs-Brandi London, MSN RN has been named Program Director of Nursing effective 3/1/2012.

The Board took this matter under advisement.

VI. DISCUSSION

1. **Office of the Attorney General-** David Miller appeared behalf of the Office of the Attorney General ("OAG"). The Board members expressed concerns about board processes. The Board reviewed the six issues from the memo sent to the OAG in November 2011 and some additional information. Miller says the information was received in November and reviewed internally. After that a meeting was held with the AG based upon questions raised, the OAG felt it was appropriate to do a one to one meeting with each board specifically. Miller indicated the chief of staff, chief deputy and himself will go through this process in the meeting. They envision doing the same thing with the Board of Nursing. They are also reviewing the quarterly report from the OAG and are going to modify the report to suit our needs and to get their numbers to reconcile. Mr. Burghduff wanted to know the framer's intent on some of these statutes, specifically the informal board meeting process, and why that went away. Mr. Miller indicated that the OAG is willing to work through alternative ways of doing this but they are concerned about statutory prohibitions. The next steps will be that the Board and its designees will meet with the Chief of Staff, Chief Deputy and Mr. Miller. The Board also expressed its ongoing concerns as to the lack of nurse analyst in the OAG and the lack of information they are receiving in the Board summary process. Mr. Miller indicated he was unaware of these concerns and will address them.

VII. BOARD DIRECTOR REPORT

1. **Staffing-** Lori Grice has put her notice in effective 3/30/12. Her position will be posted for hire as soon as possible.
2. **Midyear recap-** The NCSBN midyear meeting provided a great deal of information regarding education reform, strategic planning and a great networking opportunity.
3. **Long term strategic plan session-** Ms. Crawford will be requesting funding through the NCSBN to fund a long term strategic planning retreat for all board members.
4. **Ms. Crawford requested that the Board entertain a motion to change the question on their initial applications for licensure to include arrest information so that the response will be more in line with what is coming through on criminal background checks. A motion was made and seconded to accept this recommendation. McIntosh/Ogle 5-0-0, motion carries**

VIII. PERSONAL APPEARANCES

Board Action: All personal appearance recommendations made on this date were approved. McIntosh/Laux, 5-0-1, Hall abstains

1. Marcy Fegett

Ms. Fegett appeared regarding her application for licensure by endorsement. She is currently in a monitoring program in IL until July 2013 due to a positive drug screen and her application for MO licensure was denied. She is in compliance with that monitoring program. ALJ Hall recommended that she contact ISNAP and complete an evaluation and then her license will be issued free and clear.

2. Koneta Wright

Ms. Wright appeared regarding her application for licensure by examination. She graduated in 2005 and has failed the NCLEX 6 times. ALJ Hall recommended that she complete a review course and provide documentation of 95% or higher probability of passing the NCLEX and then she may test again.

3. Kevin Thompson

Mr. Thompson appeared regarding his application for licensure by examination. He graduated in 2007 and has failed the NCLEX 6 times. ALJ Hall recommended that he complete a review course and provide documentation of 95% or higher probability of passing the NCLEX and then he may test again.

4. Jennifer Lewis

Ms. Lewis appeared regarding her application for licensure by examination. She graduated in 2007 and has failed the NCLEX 3 times. ALJ Hall recommended that she complete a review course and provide documentation of 95% or higher probability of passing the NCLEX and then she may test again.

5. Elissa Veloz

Ms. Veloz appeared regarding her application for licensure by examination. She graduated in 2003 and has failed the NCLEX 2 times. She reported she has had a stroke and has had multiple health issues. ALJ Hall recommended that she complete a review course and provide documentation of 95% or higher probability of passing the NCLEX, and then she may test again.

6. Stephanie Gumerson

Ms. Gumerson appeared regarding her application for licensure by examination. She graduated in 2004 and has failed the NCLEX 8 times. She completed a review course in Jan. 2012 and reported she is working as a medical assistant and struggles with test taking. ALJ Hall recommended that she look into an evaluation of her test anxiety and she may test one more time.

7. Michael Rogers

Mr. Rogers appeared regarding his application for licensure by examination. He graduated in 2010 and has failed the NCLEX 4 times. He stated he has completed a review course twice but failed the NCLEX on his next try. ALJ Hall recommended that he get an evaluation for possible test anxiety and present the results to the BON at a personal appearance hearing in the near future.

8. Maria Goetz

Ms. Goetz appeared regarding her application for licensure by examination. She reported DUIs at age 18 and age 21, both with a BAC of .18. She served 2 years on probation and has had no further arrests. ALJ Hall recommended she have an ISNAP evaluation and may test. If eligible for an RMA, her license will be issued on probation. If not eligible, her license will be issued free and clear.

9. Nicolle Dauphinee

Ms. Dauphinee did not appear regarding her application for licensure by endorsement. Her license has been disciplined in other states. She was rescheduled from Feb. 16 and sent correspondence that she would not attend since she lives in Maine. ALJ Hall recommended that her application be denied.

10. Jami Fell

Ms. Fell appeared regarding her application for RN licensure by examination. She graduated in 1998 and has failed the NCLEX 2 times in MI. She is licensed as LPN in MI. She cannot test again in MI due to the time that has passed and would have to repeat RN school there. ALJ Hall recommended that she appear before the full board and ALJ Burghduff then heard the matter. ALJ Burghduff recommended that her application be denied; she may apply again after completing a review course and provide 95% or higher proof of probability of passing the NCLEX.

11. Freda McKinney

Ms. McKinney appeared regarding her application for licensure by examination. She had a positive response to disciplinary questions along with a hit on her criminal background check. She explained this was due to a misdemeanor domestic battery issue in 2008 and in 2007 for interfering with police. She was also terminated from a job as a medical assistant. ALJ Hall recommended that she be allowed to test and her license will be issued free and clear.

12. Sylvie Bogne

Ms. Bogne's personal appearance will be rescheduled for May 17.

13. Kayla Persinger

Ms. Persinger appeared regarding her application for licensure by endorsement. She had a positive response to disciplinary questions and reported a domestic battery arrest in Feb. 2011 which was pled down to disorderly conduct. She completed 6 months probation complying with all terms and reports no further issues. The incident occurred during nursing school. ALJ Hall recommended that her license be issued free and clear.

14. Sophia Trauner

Ms. Trauner appeared regarding her application for licensure by examination. She had a positive response to disciplinary questions and had a hit on her criminal background check. She reported a 2005 arrest for possession of marijuana and paraphernalia for which she completed a diversion program. In 2007 she was arrested for illegal possession of alcohol as a minor. She admits she still drinks. ALJ Hall recommended she have an ISNAP evaluation and enter into an RMA if eligible. Her license will be issued on probation for the length of the RMA. If not eligible, then license will be issued free and clear.

15. Heather Tharbs

Ms. Tharbs appeared regarding her application for licensure by examination. She had a positive response to disciplinary questions and had a hit on her criminal background check. She reported a 2006 charge for domestic violence and in 2007 for possession of marijuana. She also had an arrest for attempted fraud and receipt of stolen property for the use of stolen credit cards for which she completed probation on 3/21/12. ALJ Hall recommended she be allowed to test and her license will be issued on probation for 6 months with quarterly reports from her nursing employer.

16. Stephanie McMillan

Ms. McMillan appeared regarding her application for licensure by examination. She had a positive response to disciplinary questions and reported an arrest in Nov. 2011 for possession of marijuana for which a court case is pending. She also reported being cited in 2008 for underage drinking during a traffic stop. She reported the recent arrest occurred one month before graduation from nursing school. She is on probation for 6 months. She stated she did not inform her employer or nursing school of the recent arrest. ALJ Hall recommended she have an ISNAP evaluation and enter into an RMA if eligible. Her license will be issued on probation for the length of her criminal probation.

17. Bernard Cunahan

Mr. Cunahan appeared regarding his application for licensure by examination. He graduated in 1991 and has failed the NCLEX 16 times. He has not worked in a health-related field. ALJ Hall recommended that he return to school to complete a nursing degree and he may reapply. His application is denied.

18. Carla Taylor

Ms. Taylor appeared regarding her application for licensure by examination. She answered disciplinary questions and had a background check hit. She reported a conviction in 1988 for forgery of submitted timecards and served time in a correctional facility. In 1990 she shoplifted a pair of shoes. She has been working in health care as a QMA for 8 years. ALJ Hall recommended she be allowed to test and her license be issued free and clear.

19. Letitia Boyett

Ms. Boyett appeared regarding her application for licensure by examination. She reported a DUI in May 2010 while in nursing school and also reports being cited for using a false ID in June 2010. She currently works as an aide in a nursing home and reports she still drinks occasionally. ALJ Hall recommended she be allowed to test and her license will be issued free and clear.

20. Tammy Douglas

Ms. Douglas appeared regarding her application for licensure by examination. She graduated in 2005 and has failed the NCLEX 8 times. She has been an LPN since 1996 and a CNA since 1989. She has completed a review course. ALJ Hall recommended she provide proof of 95% or higher probability of passing the NCLEX and she may test one more time.

21. Tracy Alderton

Ms. Alderton was scheduled to appear regarding renewal of her RN license in November, February and March 22. She sent additional documentation but did not appear. ALJ Hall recommended her renewal be denied.

22. Elizabeth Sciscoe

Ms. Sciscoe was scheduled to appear regarding renewal of her RN license in January, February and March 22. She did not appear as requested. ALJ Hall recommended her renewal be denied.

23. Vickie Yaggi

Ms. Yaggi appeared regarding renewal of her RN license. She stated she pled guilty to forging a prescription in Sept. 2010 due to her son's addiction to pain medication. She states she takes opiates daily for pain herself and many members of her family have chronic pain issues. She has not worked as a nurse since 1980 and states she must have the medication to function. She would not be eligible for ISNAP due to her insistence that she cannot come off her present medications. She states she wants to renew her license to be able to get better jobs. ALJ Hall recommended her renewal be denied.

24. Shari Brindley

Ms. Brindley's personal appearance was rescheduled from Feb. 16 because she did not appear; her renewal was denied in 2010. She did not appear two times and ALJ Hall recommended her renewal be denied.

25. Sandra Dilk

Ms. Dilk appeared regarding the positive response on her LPN renewal. She did not answer any questions yes on her renewal yet has litigation pending. She has a prehearing settlement conference scheduled for later in the BON agenda this date. She reported a DUI in 2010 for driving while using pain medication after a dental procedure. Her LPN license expired in 2010. She has completed probation. ALJ Hall recommended her license be renewed in view of the pending litigation.

26. Lynn Kolberg

Ms. Kolberg appeared regarding the positive response on her RN renewal. She reported terminations on her 2011 and 2009 renewals. She stated the 2011 termination was due to "politics" and in 2009 was due to "physical and mental inability to do the job." She explained the terminations were due to personality issues and unfair practices in the workplace. She described physical ailments she currently has and has not been cleared by her doctor to return to work. ALJ Hall recommended that her license be renewed.

27. Mary Taylor

Ms. Taylor appeared regarding renewal on her LPN license that expired in 2004. She presented proof of CEs but stated she has not practiced as a nurse since 2002. She reported an arrest in 2004 and conviction in 2006 for her use of/addiction to meth resulting in a felony conviction. ALJ Hall recommended the full BON continue review of the renewal. ALJ Burghduff continued the personal appearance and recommended renewing the license on probation and that she complete an LPN refresher course with a clinical component along with having an ISNAP evaluation. She may petition to lift the probation upon completion of the course in preparation for the clinical coursework.

28. Angel Perry

Ms. Perry did not appear as requested and her personal appearance will be rescheduled one time.

Ms. Nunez appeared regarding her positive response on application for examination. She reported a 2009 charge for possession of marijuana and OWI. Her BAC was .11. She was in nursing school at the time of this occurrence. Ms. Slagle recommended that she be allowed to test and be issued free and clear upon successful completion of the examination.

8. Laura Carter RN examination positive response

Ms. Carter appeared regarding her positive response on application for examination. She reported an arrest for OWI in July 2011. Her BAC was .08. She is still on criminal probation and is scheduled to complete in July 2012. She reported last drinking in February 2012. Ms. Slagle recommended that she be allowed to test and obtain an ISNAP assessment and sign an RMA if eligible. She will be issued on indefinite probation for 6 months total ISNAP RMA compliance or until the criminal probation is successfully completed, whichever is longer.

9. Brian Radican RN examination positive response; information on CBC report

Mr. Radican appeared regarding a positive response on his application for examination. He reported two public intoxication arrests in 1992. He has had 3 DUI's in 1995, 1996 and 2003. He has been sober since February 2006. Ms. Slagle recommended that he be allowed to test and that his license be issued free and clear upon successful passage of the examination.

10. Jason Gilliland RN examination positive response; information on CBC report
