# IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT

Charles Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of April 2007, 460 active clients, 21 new intakes, 45 intakes in process and 16 RMA's returned.

Mr. Lindquist stated that the quarterly reports for January – March 2007 are nearly completed. ISNAP met on the 15<sup>th</sup> of April to review those who have applied for the needs assistance fund. They reviewed seven applications, seven qualified for assistance and vouchers were mailed.

Mr. Lindquist discussed the quarterly provider meeting that was held on April 24, 2007 at St. Vincent's Hospital. Dr. Karimi, addictionist, spoke on the use of seboxone for detoxification and pain management. Harry Anderson, MSW, also spoke in regards to sensitivity to cultural differences.

Mr. Klein addressed the board to explain the outcome regarding the proposed nurse compact legislation. He informed the board that the legislation, which included increased funding for the Indiana State Nurses Assistance Program, did not pass. He requested that the board issue some type of opinion on the matter. Additionally, he reminded the board that the contract with the Indiana State Nurses Association for the Indiana State Nurses Assistance Program will expire on July 31, 2007.

Mr. Lindquist addressed the audience as requested by the Board.

#### V. EDUCATION

#### 1. Goshen College - FYI for the Board

Goshen College submitted information regarding an institutional change with their annual report. Goshen College is opening a practitioner and nurse leader program at a Master level.

# A. Appearance by Applicants for Licensure

#### 1. Robert Walston

Mr. Walston appeared before the Board regarding the positive response on his application for licensure by endorsement. Mr. Walston was terminated from Good Samaritan Hospital in Cincinnati, Ohio possibly due to some sexual harassment he experienced from an employee or because he complained to the corporate office in regards to the hospital. Mr. Walston explained that he is unsure of why he was terminated exactly. Ms. Slagle recommended Mr. Harrison's submit a report from his current employer and previous employer in Kentucky regarding is competency, attendance and team work. Once the reports are received, Carolyn Slagle will review the letters for approval.

#### 2. Edward Roederer

Mr. Roederer appeared before the Board regarding the positive response on his application for licensure by examination. Mr. Roederer was arrested for trafficking marijuana in 2000-2001. In 1995 he was charged with assault on a minor. Ms. Slagle recommended Mr. Roederer's license be issued.

# 3. John Robert Majewski

Mr. Majewski appeared before the Board regarding the positive response on his application for licensure by endorsement. Mr. Majewski self reported to the Arizona State Board of Nursing that he needed help due to alcohol abuse. Mr. Majewski has been in recovery for three years and five months, attended intensive outpatient and continues to attend AA two to three times a week. His license is currently on Indefinite Probation in Arizona. Mr. Majewski stated that he has been in contact with ISNAP. Robin Reibsomer, ISNAP Coordinator, explained that Mr. Majewski's monitoring agreement is ready for his signature. Ms. Slagle recommended Mr. Majewski's license be issued on Indefinite Probation for the length of his ISNAP contract.

## 4. Sandra Miller

Ms. Miller appeared before the Board regarding the positive response on her application for licensure by examination. In March, 2004 Ms. Miller received an OWI. She was court ordered to an alcohol abuse deterrent program and three years of criminal probation, which will be completed on July 12, 2007. Ms. Slagle recommended to allow Ms. Miller to sit for the examination and be evaluated by ISNAP. Once we receive approval from ISNAP and Ms. Miller passes the examination, her licensed may be issued.

#### 5. Robin McClure

Ms. McClure appeared before the Board regarding the positive response on her application for licensure by endorsement. Ms. McClure was injured on the job and was asked to take a drug and alcohol screen. Ms. McClure did not take the screen until one week later. The screen tested positive for marijuana. Ms. McClure was terminated for not completing the drug screen in a timely manner. In October and November of 2005 she voluntarily admitted herself to Genesis Inpatient Facility for a twenty-two day rehabilitation. She completed the inpatient program and was rehired at the same facility on December 2, 2005. Ms. Slagle recommended Ms. McClure be evaluated by ISNAP. Once we receive approval from ISNAP, her license can be issued.

# 6. Aaron Lipp

Mr. Lipp appeared before the Board regarding the positive response on his application for licensure by endorsement. Mr. Lipp informed the Board that he wanted to withdraw his application at this time. Ms. Slagle recommended Mr. Lipp's application be withdrawn.

## 7. Racquel Hudson

Ms. Hudson appeared before the Board regarding the positive response on her application for licensure by examination. Ms. Hudson was arrested in Lawrence County on June 19, 2006 and charged with public intoxication, a class B misdemeanor. On October 25, 2006 she completed level II of the ADAPT substance abuse program. Ms. Slagle recommended Ms. Hudson's license be issued on Indefinite Probation for a period of six (6) months of continuous compliance with ISNAP.

# 8. Teresa Najera

Ms. Najera did not appear before the Board regarding the positive response on her application for licensure by endorsement. Ms. Slagle recommended Ms. Najera's license be denied.
