III. ADOPTION OF THE MINUTES FROM THE APRIL 2013 MEETING OF THE BOARD

A motion was made and seconded to adopt the April, 2013 minutes. McIntosh/Burghduff, 8-0-0, motion carries

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Mr. Lindquist presented on behalf of the Indiana State Nurses Assistance Program. He introduced Darryl Davis as the case manager replacement for Samantha Meadows. The April 2013 monthly report was received as a handout along with quarterly newsletter and flyer for presentations at Ivy Tech. Ms. Ogle asked again about the potential for video outreach for wide accessibility to the public. Mr. Lindquist indicated that a recent presentation he gave at St. Mary's was videotaped and will be available to the public. He indicated that the staff is also working on additional video presentations.

V. EDUCATION

**A. Ball State University- Request for Partnership with Community Health Network (Linda Siktberg)  
And Request for revised Baccalaureate Admission Requirements**

- Staff appeared from Ball State University and Community Health Network re: the request for partnership with Community. They would like to utilize the established Ball State "degree in three" track to further this partnership. They would like to increase the number of students admitted by 24 students two times a year (48 new admissions total per year). The students must meet the general admission requirements of both BSU and the school of Nursing. Students can then apply to the Nursing Academy and must meet the qualifications set up by Community for the scholarships. Ms. Hall asked if students from Ball State will have first priority at Community for clinical site training and the response is "yes" because all of these individuals will be placed at Community. Students must commit to working at Community after graduation for a one to four year term of ~~commitment. Their intent is to improve~~ retention of first year nurses and to create a more stable work environment. Ms. Hall asked if staff monitoring students at clinical are Community employees. They indicated that BSU staff will also be staff at Community Health Network but will be a BSU faculty member on the date of supervision and meets the Board's rules for faculty requirement. Ms. Dolk asked about guidance for training faculty. Staff indicated they are oriented as new faculty hires

in the School of Nursing and have a mentor assigned for these individuals. They are part-time contract semester faculty. Ms. Ogle asked how their performance will be reviewed. Staff indicated qualifications are reviewed and faculty members who work with these individuals will work as a team in the course, review of student evaluations and the faculty member will come to campus for simulations as well. Ms. Narwold asked if clinical is traditional or precepted and staff indicated they are traditional clinicals with a 1:8 ratio but no more than 1:10 total. Ms. Ogle asked if students are guaranteed employment at Community. Staff indicated high performing students will have the highest priority for placement and the Community system has many more nurse openings currently than this class can accommodate. Staff indicates students will be told it is not a guaranteed position and it is contained within the materials. Ms. Narwold asked about ample space for other SON in the area at Community and Dr. Adams indicated they are adding 48 new opportunities to expand rather than take away opportunities. Ms. Cooper asked about the fate of a student who is not hired in the system re: financial obligation. Dr. Adams indicated that if the person chooses to leave they owe the money back; if they choose not to take the student in Community will eat the scholarship money. Students who leave for poor academic performance would owe the money back. Student health issues would be reviewed on a case by case basis.

**Board Action: A motion was made and seconded to grant the new admissions. Narwold/Ogle, 8-0-1 (McIntosh abstains)**

- BSU requests to revise admission standards to delete the interview, paper and resume portion. Over the last three years they have found it does not differentiate the population and would like to increase the % of the pre-assessment test from 20% to 35%. Overall GPA 35%, preadmission score 35%, pre-nursing GPA 30%. Ms. Narwold asked about what preadmission test she NLN pass.

**H. Ivy Tech Richmond- Request for Removal of Conditional Status from Associate of Science in Nursing program**

**Staff appeared from Ivy Tech Richmond.** 2012 pass rate was 97.2%, utilizing ATI, faculty training, developing more consistency in their program, etc. They reported 48 students in their most recent graduating class. Faculty changes- none over the last year. **Board Action- A motion was made and seconded to remove the conditional accreditation status. McIntosh/Ogle, 7-0-2 (Cooper/Dolk abstain)**

## VI. DISCUSSION

**A. "Update: Division of Disability and Rehabilitative Services' Medication Administration in the Community Curriculum". (Kim Opsahl, President/CEO INARF)**

Developmental Disability Nurses Association members Debbie Hatfield and Nancy Ward and Kim Opsahl from IN Arf appeared before the Board and presented information regarding medication administration to supervised group living clients and home and community based services waiver clients. They service approximately 3,500 individuals in supervised group living and 13,000 in community based services. IC 25-23 is guiding them in their medication administration model and they are seeking guidance for this issue of instruction for unlicensed personnel to pass medications in their settings. They are currently in the process of rewriting their curriculum to a more manageable level of instruction that allows facilities to add in their own forms. They are also working to add in more clinical experiences.

**Board Action: A motion was made and seconded to establish a committee to assist with this effort and to invite the school nurses into the committee as well. Ms. Laux and Mr. Burghdoff are going to represent the Board in this effort.**

**B. Education Subcommittee Meets at 1:30 p.m. (Lynda Narwold)**

Ms. Narwold provided a brief report and indicated that the meeting scheduled for this afternoon will be the last as the subcommittee is ready to bring forward their program, forms and processes next month. Ms. Dolk will bring the information forward next month for a full Board review and vote.

**VII. BOARD DIRECTOR REPORT**

Ms. Kiefner Crawford reported the following:

- A handout was provided from the U.S. Department of Health and Human Services regarding trends in supply and education in the U.S. workforce. The handout demonstrates that the number of RN's grew by more than 24% and the number of LPN's grew by more than 16% in the last decade. The number of NCLEX candidates for the RN and PN exam has grown by 107% for RN's in the last decade and 80% for LPN's in the last decade.
- The Impaired Nursing audit will take place the first week of June, 2013.
- Feedback was obtained at the Deans and Directors retreat on May 17, 2013 which indicates that the new processes for May graduates has been very successful.
- The Board was counseled regarding the passage of House Enrolled Act 1376.
- Ms. Kiefner Crawford will not be here for the June full Board meeting as she will be attending the NCSBN Executive Officer Summit in Lake Geneva, Wisconsin.
- The 2013 NCSBN Annual meeting will be held in August in Providence, Rhode Island. Funding may be obtained for two additional board members to attend. Anyone interested should contact Ms. Kiefner Crawford.

**A. Appearances by Applicants for Licensure**

**1. Ted Howard Basket Jr.**

**RN Exam**

**CBC Hit/Positive Response**

Mr. Basket appeared for his personal appearance regarding his application for licensure. In August 2011, he went out to dinner with a friend. They ordered a pitcher of beer. On his way home he had to go through a sobriety check point. He blew a BAC of .10. He was arrested. This was his first and only drug alcohol offense. He was referred to a deferral program. He entered into the program for a year then it was removed from his record. He has no history of abuse and no other arrests. No one was in the car with him. He is allowed to test and license to be issued free and clear.

**2. Lindsey Renee Belland**

**RN Exam**

**CBC Hit/Positive Response**

Ms. Belland appeared for her personal appearance regarding her application for licensure. In April 2012, she turned 21 and went out with some friends. This was her first time at a bar. She had several different drinks and left the bar. She was picked up by a police officer right outside the door. She blew a BAC of .28. She is not on probation. She had to pay a fine and complete a mental health assessment. She did have a driver for the night. She has learned that she is accountable to every action she makes inside and outside of work. Part of the school's recommendation was to attend AA meetings for the summer and she did those. She completed all court requirements. She has not had a drink since this. She is allowed to test, license to be issued free and clear.

**3. Megan Dae Brown**

**RN Exam**

**CBC Hit/Positive Response**

Ms. Brown appeared for her personal appearance regarding her application for licensure. In October 2011, there was a community event that she went to with friends. She was drinking. She had a designated driver for the night. She was very drunk and went to go pass out in the car. The next thing she knew she blacked out and when she awoke was at a stop sign and there was a police officer. She had a previous black out in high school from drinking. She was charged with public intoxication. Her BAC was .14. She is allowed to test. She needs to have an ISNAP evaluation. If she meets criteria for an RMA she will be issued on probation, if does not meet criteria her license will be issued free and clear.

**4. Jennifer Mansfield**

**LPN Exam**

**Graduated 2007\***

Ms. Mansfield appeared for her personal appearance regarding her application for licensure. She graduated in 2007. She has never taken the NCLEX. She has been a student going through the RN. She would like to test so she can work this last year. She is allowed to test and license to be issued free and clear.

**5. Yaka Starks**

**LPN Exam**

**Previously Denied Application**

Ms. Starks appeared for her personal appearance regarding her application for licensure. She was arrested in 2010. This was before she decided to go through a nursing program. At that time she had a driver's license but had to complete defensive driving. She was later pulled over and didn't have a license. She went to court and was instructed to take the defensive driving and had to pay a seat belt ticket. She now has a current license. She had another incident where she was driving a U-Haul and hit a carport that tore off the mirror. She had her baby with her so instead of getting out of the car and telling someone she drove to the office. She got in trouble for leaving the scene of an accident. She was terminated from a PRN position because she was not picking up a certain amount of hours. She is allowed to test and license to be issued free and clear.

**6. Alyssa Secrest**

**RN Exam**

**CBC Hit/Positive Response**

Ms. Secrest appeared for her personal appearance regarding her application for licensure. In August 2011, she went to a concert with boyfriend and his friends. Before the concert she had some drinks. On the way home, she pulled over to get GPS signal. Her boyfriend had gotten out of the car. A police officer pulled up to make sure things was ok. He smelled alcohol and asked if they had been drinking. She said no. She was 20 at the time and blew a BAC of .03, and she was arrested. She completed all that the court issued. The officer told her that if she had been truthful she probably wouldn't have been arrested. She is allowed to test and license to be issued free and clear.

**7. Susan Ann DeVos**

**RN Endorsement**

**CBC Hit/Positive Response**

Ms. DeVos appeared for her personal appearance regarding her application for licensure. She currently has an active license in Michigan. She needs an Indiana license for a traveling position with the company she currently works for. In the 90's she was addicted to pain medication. She diverted drugs from a hospital. Her license was placed on probation and she could not pass narcotics and had to be evaluated by HPRP. She was terminated from the job. She had been diverting for about 6 months prior to getting caught. The probation has been lifted from that license. In 2011, she was pulled over after she hit a construction cone. She was on medication at the time. She was placed on 6 months probation, community service, and could only drive to and from work. She was charged with an OWI. She was reevaluated by HPRP and she did not have to go back into an agreement. She is not currently on any controlled substances. She will be allowed to endorse. She needs to have an evaluation with ISNAP. If she meets criteria for an RMA, her license will be placed on probation for the length of the RMA. If she does not meet criteria then her license will be issued free and clear.

**8. Amber Nicole Van Vleet**

**RN Exam**

**Positive Response**

Ms. Van Vleet appeared for her personal appearance regarding her application for licensure. She graduated on May 10, 2013. In 2002, she was working at a shoe store and was charged with conversion after she was caught doing wrongful returns. She was placed on probation. In 2007, she was arrested for purchasing more Sudafed that was allowed from the pharmacy. She was buying the Sudafed to give to someone who was making meth. She was addicted to meth. In June 2008, she realized that she needed to get help. Her parents took her kids and she entered into rehab. She was there for 6 months. Afterwards she started working at a hospital as a CNA. She is still working at the same hospital. She is allowed to test. Her license is to be issued on probation. She needs to have an evaluation with ISNAP. If she meets criteria, her probation will be the length of her RMA. If she does not meet criteria, then her probation will be for a year. She will need to submit quarterly reports from her employer during this time. If she is not employed she will need to send in self reports.

**9. Christina Lynn Brancato**

**RN Endorsement**

**CBC Hit/Positive Response**

Ms. Brancato appeared for her personal appearance regarding her application for licensure. She is currently licensed in Virginia. In March 2012, she was arrested for driving under the influence of ambien. She left a friend's house and consumed the medication in the car but didn't go straight home. She took the ambien because she was planning to go home but made a bad judgment and went elsewhere. She no longer takes ambien because she thought she remembered the night clearly but after reading the police report she didn't recall a lot that happened. Her Virginia license is active and two others are expired. Allow endorsement free and clear.

**10. Monika Sade Walker**

**RN Exam**

**CBC Hit/Positive Response**

Ms. Walker appeared for her personal appearance regarding her application for licensure. In 2003, she was arrested for criminal trespass. She was a sophomore in high school. She cut class and was hanging out with some friends in an abandoned building. Everyone was arrested. She doesn't remember the date but she also was charged with battery. She got into a fight with a girl and the girl had a knife. During the fight she got the knife away from the girl and cut her. She was 14 or 15 at the time. She was found not guilty. She received a second battery charge when she was 15 or 16. A group of girls came to fight her and everyone was arrested. These groups of girls were friends with the girl in the previous situation. In 2006, she was arrested for resisting law enforcement. She was in the car and the driver wouldn't pull over so everyone was arrested. Another time she was arrested for residential injury. She went to stay with a friend and was not on the lease. She was told by the friend that she couldn't stay there anymore. The friend wouldn't let her go into the apartment to get her stuff so she went into the apartment anyways. The cops were called and she spent 2 days in jail. Her mother passed away at an early age and she lashed out because of this. She has not been arrested since 2008. She has been a CNA since 2006. She feels like her life and mentality has changed. She feels like living on campus her first year of school helped changed her. It gave her a chance to see how life can be different from the environment she grew up in. She needs to have an MMPI-2 with a focus on coping and anger management. She is allowed to test prior to MMPI-2, but based upon the results of the MMPI-2 she may or may not be issued on probation. She needs to send letters from current employers to the board. Once those and the MMPI-2 results are in the board will review them and decided on the status of a license at that time.

**11. Hannah Allman**

**RN Exam**

**Failed 4 Times/Graduated 2011**

Ms. Allman appeared for her personal appearance regarding her application for licensure. She graduated in graduated 2011 and has taken the NCLEX 4 times. The last time she took the exam was March 27, 2013. Since this time she has been working with a tutor. She is answering 100 questions per day. Previously she completed a live Hearst review that had no kind of graded exam at the end of the review. The 2<sup>nd</sup> time she focused more on first review and took small quizzes every day. The 3<sup>rd</sup> time she didn't look at Hearst. Instead she collaborated with other students at a study group. She completed Kaplan and failed after that review. She needs to take the level 3 ATI virtual review and provide the board with 95% predictability of passing. Once that documentation is received, she will be allowed to test and license to be issued free and clear.

**12. Betty Jean Beemon**

**LPN Exam Failed 4 Times/Graduated 1992**

**13. Shari Ann Lind**

**RN Endorsement**

**Positive Response**

Ms. Lind appeared for her personal appearance regarding her application for licensure. She is currently is licensed in Arizona and Florida. In 1995, she applied for a job in Arizona. She had to take a drug test and received a false positive. The Arizona board investigated her even though no charge came from the false positive. She has a history of PTSD and was prescribed some narcotics that she began to abuse. She surrendered her license. She returned to Minnesota for monitoring and recovery. She has had her Arizona license reinstated and went through a probation period with them. Her license was cleared in 2008. She is currently teaching and needs to have an Indiana license for that. She is allowed to endorse free and clear.

**14. Jamie Ooley**

**RN Exam**

**CBC Hit/Positive Response (FULL BOARD)**

Ms. Ooley appeared before the full Board regarding her application for licensure. Ms. Ooley indicates she was dating a heroin addict who had relapsed and was arrested. She had to sit out of school for two quarters. She obtained the drug through another inmate and supplied it by sending it through the mail under a stamp. She indicated the boyfriend told her how to do it step by step. Ms. Laux asked

if she had second thoughts and she indicated she did not. Mr. White asked why she did it and she indicated she had a lapse in judgment and was naïve. She had one quarter of nursing school left when this occurred. Ms. Ogle asked how she could justify this as a nursing student and she indicated she could not. She is currently in therapy regarding this issue. Ms. Cooper asked for concerns about innocent people who were working in the prison system and the dangers these people were put in. She indicated she was not thinking. Ms. Ogle asked how they could be assured she would not deliver drugs to individuals again. She indicated she is in therapy and a 12 step program currently. Ms Cooper indicates that tapes were made where he indicated he was going to sell the drug for commissary money vs. addiction discrepancy. She indicates he had said both but the main one were withdrawal. She was sending him money too. She had been dating this person 8 months. Ms. Dolk indicated she is on three years of criminal probation currently. Ms. Narwold asked about school and she indicated that she brought two letters of recommendation. They asked if she was upfront with school and she indicated that she wanted to continue and the school allowed her to continue. She provided two letters of recommendation. Ms. McIntosh asked why the second letter of recommendation was not signed and it was indicated that it was sent via email. Board Action: A motion was made and seconded to deny licensure. **15. Jamie Lynn Wagner** **RN Endorsement** **CBC Hit/Positive Response**  
Ms. Wagner did not appear for her personal appearance regarding her application for licensure. This matter will be rescheduled.

**16. Mallorie Christine Phegley** **RN Exam** **CBC Hit/Positive Response**  
Ms. Phegley appeared for her personal appearance regarding her application for licensure. In September 2009, she was a freshman in college and was at a party where she had a couple beers. She and her friends left the party. The designated driver said she hadn't been drinking but they were pulled over. The driver was given a breathalyzer. The driver had been drinking and she was arrested. Another passenger in the car was allowed to drive home. Ms. Phegley was asked if she had been drinking and she said no. She was given a breathalyzer and blew a BAC of .02. She was given a ticket to appear in court. She entered into a pretrial diversion program. In January 2010, she was at a house party that was busted for being too loud. Ms. Phegley blew a BAC of .15. She was underage at this time. She entered into another agreement and the charges were dismissed after she complied with her agreement. She does not drink now. She is allowed to test. She needs to have an ISNAP evaluation. If she meets criteria for RMA she will be issued on probation and if she doesn't meet criteria then she will be issued free and clear.

**17. Michelle Nicole Harrison** **RN Exam** **CBC Hit/Positive Response**  
Ms. Harrison appeared for her personal appearance regarding her application for licensure. In November 2010, she was out with friends and had 3 shots. She drove back to her apartment. She was driving and texting and had an accident. She was arrested and placed on a year of probation. In January 2011, she completed her probation. She has had no other incidents. She blew a BAC of .12. She is allowed to test and license to be issued free and clear.

**18. Nakia Williams** **LPN Exam** **CBC Hit/Positive Response**  
Ms. Williams appeared for her personal appearance regarding her application for licensure. In 2002, she was charged with possession of cocaine. She was pulled over. She had 3.5 grams of cocaine on her. She was not using the cocaine, she was selling it. She had been selling it for about 6 months but never did it again after she got arrested. She was pulled over for speeding and her license was suspended and she has a warrant for driving while suspended. Her license was initially suspended because she was driving without a license. She spent 3 days in jail and completed year probation. In 2008, she received a battery charge after she had gotten into a fight with a girl. In 2010, she was charged with criminal mischief. She was on probation for 6 months and had to do community service. The charge was a result of her spray painting her brother's girlfriend's car. Another incident she was charged with theft. Her brother let her borrow his car and then her brother's wife reported the car stolen. Those charges were dismissed. The school was aware of her history when she applied. She is currently working in healthcare and they are aware of her background. She is a QMA at Bethel healthcare in Muncie. She is being referred over to the full board. Board Action: A motion was made and seconded to allow her to test and for the license to be issued on probation for six months of quarterly reports and an MMPI-2. **19. Tameka Jovet Ellis** **LPN Exam** **CBC Hit/Positive Response**  
Ms. Ellis appeared for her personal appearance regarding her application for licensure. She failed the test after her last personal appearance. She is going to be allowed to retest and if she passes her license will be issued on probation for 6 months active practice with quarterly reports as was requested at previous personal appearance.

**1. Amber L. Boesel** **LPN Renewal** **Failed to Complete Renewal Form**  
Ms. Boesel did not appear for her personal appearance regarding her application for renewal. This matter will be reset.

**2. Lisa Scarth** **LPN Renewal** **Positive Response**  
Ms. Scarth appeared for her personal appearance regarding her application for renewal. She is currently licensed in North Carolina and its free and clear. In 2008, she was reported to the board for a job termination where she fell asleep at work. This happened due to being exhausted from working two jobs. She got her nursing license reinstated then placed on probation and it is now free and clear. She has a history of alcoholism. In 2010, she had a relapse; she had been drinking at a bar. She completed a treatment program. She wants to move back to Indiana to be close to family. She has a support system in place in Indiana. Her Indiana license is to be renewed free and clear.

**3. Leonora Francis** **RN Renewal** **Failed to Submit Positive Response Statement**  
Ms. Francis did not appear for her personal appearance regarding her application for renewal. This matter will be rescheduled.

**4. Nina Blessing- Full Board** **LPN Renewal** **Positive Response**  
Ms. Blessing appeared for her personal appearance regarding her application for renewal. In 2010, she had a skiing accident and broke her arm; she was placed on pain medication. She stopped taking the pain medication. A friend offered her heroin and she started taking that. August 2011 she was with a friend who was driving and he was high. He pulled over and they switched places. She was going to

drive even with no license. She was arrested for driving with no license and had controlled substances on her. One of the prescriptions she had was for her and the others were a friends. She was sentenced in January 2012. She was supposed to stay out of trouble for a year. In March she was arrested for theft from Wal-Mart. She bonded out and found out she had a warrant for her arrest. She turned herself in. She spent 2 months in jail. May 9 2012, she was sentenced for both cases- possession of legend drug and theft. Her sobriety date is July 20, 2012. She stopped practicing before all the arrest began. Her blood alcohol level was .09. In 2012, she was pulled over for improper lane change. She had been drinking and refused to take the breathalyzer. She refused because her previous attorney told her to never take one. She was arrested for refusal. She no longer drinks. She needs to have an ISNAP evaluation. She is allowed to test. Ms. Perez appeared for her personal appearance regarding her application for licensure. She graduated in 2000 and has taken the test 6 times. She is currently working as an allergist. She last tested in 2006. She has not taken a review course. She needs to take a review course with predictability. Once she submits documentation showing 95% or greater predictability she will be allowed to test and license to be issued free and clear.

10. Holly Denise Miller RN Exam CBC Hit/Positive Response

Ms. Miller appeared for her personal appearance regarding her application for licensure. She was pulled over on March 14, 2012. She pled guilty for an OWI. She was on probation for a year, which she successfully completed. She blew .14. She has never had any other issues. She is allowed to test and license to be issued free and clear.

11. Jessi Elizabeth Johns RN Exam Positive Response

Ms. Johns appeared for her personal appearance regarding her application for licensure. In 2010, she went to Ball state to visit friends and was drinking; she was underage at this time. She received an underage drinking ticket. She paid the necessary fees. In July 2011, she was working at concert. When she was done working she changed and was holding a drink. A cop asked to see her id. She had not started drinking it yet and was issued a ticket for underage possession. She entered into a deferral program which she completed. She has not had a drink since 2011. She doesn't want anything to do with alcohol. She has been focusing on working and going to school. She is allowed to test and license to be issued free and clear.

12. Katie Wood RN Exam CBC Hit/Positive Response

Ms. Wood appeared for her personal appearance regarding her application for licensure. In January 2012, she was on way home from a friend's house and had been drinking. She was arrested for OWI and minor possession. She served 3 days in jail and year of probation. She has successfully completed the probation. She has never had any other issues. She is allowed to test and license to be issued free and clear.

13. Evan Jeffrey Leyba RN Exam CBC Hit/Positive Response

Mr. Leyba appeared for his personal appearance regarding his application for licensure. He was 19 in 2010 when we went camping with friends. Everyone was drinking, expect him. It started raining so they through just threw everything in the truck and left. He was the sober one so he was driving. He was pulled over for speeding. He was charged with underage transportation because there was alcohol in the back of the truck. He went through a deferral program which was successfully completed. He is allowed to test and license to be issued free and clear.

14. Jessica Leigh Buxton RN Exam CBC Hit/Positive Response

Ms. Buxton appeared for her personal appearance regarding her application for licensure. In October 2011, she was out with friends and was pulled over. Her blood alcohol level was .20. No one else was in the car with her. She had a minor consumption in 2009. She has not been in any trouble since. She needs to have an ISNAP evaluation. She is allowed to test. If she meets criteria for an ISNAP RMA her license is to be placed on probation. If she does not meet criteria then her license is to be issued free and clear.

15. David Micheal McCue RN Exam CBC Hit/Positive Response

Mr. McCue appeared for his personal appearance regarding his application for licensure. In 2003, he was pulled over for headlight. The officer said his ID had been altered. He went to court and the judge said the ID had been damaged and he was issued a citation. Later that year he was out with some friends. He was sitting in the car when a cop searched the vehicle. There was some marijuana in the car and he was charged since he was in the car. In 2004, he was at an apartment complex; he was standing outside with a friend. He had been drinking. He received ticket for minor consumption. In 2005, he was at a house party, cops showed up. He ran out back and was stopped. He received a resisting arrest and minor consumption. Since 2005, he went to school, completed his criminal probation, he has been working. He went overseas for a while to teach English. His last drink was almost 2 years ago. He is allowed to test and free and clear.

16. Denise Nicole Young LPN Exam Graduated 2007

Ms. Young appeared for her personal appearance regarding her application for licensure. She graduated in 2007. She has tested 3 times and did not pass. She needs to take a refresher course and review course with 95% predictability. Once she has submitted the documentation she will be allowed to test and license to be issued free and clear.

17. Sheila Beth Diebold RN Exam Previously Denied Application

Ms. Diebold appeared for her personal appearance regarding her application for licensure. She has taken the test 4 times. She has taken the ATI review course. She graduated in 2011. She is currently working as a pharmacy technician. She needs to complete refresher course with a clinical component and follow with a review course and submit documentation showing 95% predictability. Once this has been done she will be allowed to test and license to be issued free and clear.

18. Lisa Brown LPN Endorsement CBC Hit/Positive Response

Ms. Brown appeared for her personal appearance regarding her application for licensure. She has an active Kentucky license. She is not currently working as a nurse. She is working in a factory. 1<sup>st</sup> offense DUI was in 2008. In 2009, she had been traveling for the facility she was working for. She had worked all weekend night shift and drove home that morning. She took her depression medication. Work called and asked her to come in because they were shorthanded. She was pulled over for speeding. When they ran her license it was suspended from a previous DUI. She didn't realize that it was suspended. Cop started asking her questions and she went to jail as an impaired driver because of the depression medication. She was charged with a second offense DUI because of this. She had an EPO violation. She was going through a divorce and was in another relationship. She was living with the boyfriend and was going to leave him. The boyfriend got an EPO against her to get her out of the apartment. She had to go to court. As she was getting into her car the boyfriend walked up to her and at the time a sheriff walked up and wanted to know what she was doing. She was arrested because she wasn't 500 feet away from him. A few days later, she had made arrangements with the sheriff's department to go get her stuff. She was arrested again because the boyfriend told the cops that she threatened to kill him and burn the place down. These charges were dropped because there was no evidence. In 2011, she received a public intoxication charge. She was out with some friends. Her friend was driving and was stopped. They didn't do a breathalyzer. She was terminated from a nursing job for attendance in 2011. She lost another job in 2010 for attendance. She lost a 3<sup>rd</sup> job at Parkview healthcare for attendance. The first place was fired other places she gave resignation but she didn't work in 2 weeks out so she was listed as terminated. The board members have numerous concerns. There are several inconsistencies to what she is saying and the positive response statement she sent in. There is also the legal troubles and work issues. She appears to be all over the place. Her application is denied.

19. Jennifer Mansfield LPN Exam Graduated in 2007 CONTINUED

20. Reah Dawn Gohen RN Exam Failed 4 times/Graduated 2011

Ms. Gohen appeared for her personal appearance regarding her application for licensure. She has taken the test several times. The first time took test she believes she was very cocky since she was an LPN. She has been working as an LPN the entire time. She believes she has test anxiety. Prior to last test she took a Kaplan review. She last tested in July of last year. She is doing around 150 questions daily and working information she pulled off NSBN. She has been working for a tutor. She has seen her twice. She needs to do review course with 95% predictability. Once she submits this documentation she will be allowed to test and license to be issued free and clear.

21. Jason Joshua Heck RN Exam CBC Hit/Positive Response

Mr. Heck appeared for his personal appearance regarding his application for licensure. He was arrested in 1999, for a DUI in Missouri. He was 19 at the time. He went to rehab a couple times as a teenager. He had a lot happen to him between 1999 and 2003. He has been sober since 2004. He attends AA meetings and works as youth pastor with his church. He did work with a company that was funded by the state but fund were cut and job was gone. After that he went to nursing school. He started his nursing program with a GED. He is allowed to test and license to be issued free and clear.

22. Joshua J Lemon RN Exam CBC Hit/Positive Response

Mr. Lemon appeared for his personal appearance regarding his application for licensure. He caused a lot of trouble for himself from 18 and 19. He made some very poor choices. He grew up in Bloomington where there was a lot of partying and drinking. He was caught several times. The 1st time he was drinking but not driving. The 2nd time he was outside at a party police were called for a different party, asked him if he had been drinking he had and wasn't 21 yet so received a ticket. The 3<sup>rd</sup> time he was with friends but not drinking, was not given a breathalyzer but was arrested for PI but the charge was later dropped. 2008 was the last time he gotten into trouble. After 2008, he went through a program at Centerstone. He completed the program. In 2006, he received his EMT certification. In 2008, he was assaulted by ex-girlfriend's boyfriend. The neighbor called the cops. The charges were dismissed because they attacked him, he didn't fight back. He went to AA. He stills goes occasional. He is very involved in a youth mentoring program. Allow to test and license to be issued free and clear.

23. Kieonna Stewart RN Exam Positive Response

Ms. Stewart appeared for her personal appearance regarding her application for licensure. In February 2011, she was in a car with two friends; one of the friends had been drinking. They driver was pulled over for speeding. The girl in the back seat poured out her drink. She received a minor consumption because she blew .01. She is allowed to test and issued free and clear.

#### B. Appearances for Renewal


1. Patricia J. Shaw RN Renewal Failed to Provide CEU's or Proof of Active License

2. Amanda Paige Cross RN Renewal Positive Response



She is currently working at a drug and alcohol center. She is still taking outpatient therapy. She does not see her family anymore due to codependency issues. She has not seen them since 2010. Her license is to be renewed free and clear.
