#### February 21, 2008

## I. CALL TO ORDER & ESTABLISHMENT OF QUORUM

Ms. Slagle called the meeting to order at 8:29 a.m. in the Auditorium of the Indiana Government Center South Building, 302 West Washington Street, Indianapolis, Indiana 46204 and declared a quorum, in accordance with IC § 25-23-1-5(b).

#### II. ADOPTION OF THE AGENDA

#### IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT

Charles Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of January 2008, 467 active clients, 23 new intakes, 60 intakes in process, 15 closures in intake and 18 RMA's returned.

Mr. Lindquist stated that ISNAP's theme for their fall conference on 10/3/2008 is "Relapse/Relapse Prevention." The keynote speakers for the conference will be Dr. Michael Wilkerson and Jackie Fazeli, RN from Bradford Health Services in Alabama.

Mr. Lindquist stated that ISNAP staff met on January 15, 2008 to review applicants that have applied for the Needs Assistance Fund. They reviewed ten applications and seven of them qualified for assistance and vouchers were mailed to them.

Mr. Lindquist spoke to the audience at the request of the Board.

## V. DISCUSSION

# 1. Pamela Jeffries – Proposed Dedicated Education Unit at Indiana University – Request for a Board Member to Sit on the Executive Committee

Ms. Jeffries appeared before the Board and explained the purpose of the Proposed Dedication Unit to the Board. Ms. Jeffries expressed the interest for a Board Member to join the Committee. The Board reviewed the information submitted and informed Ms. Jeffries that they would take it under advisement and meet with the Director of the Board, Sean Gorman for additional information.

**2. Pass Rates** - Michelle Hines, Assistant Board Director, explained the pass rates to the Board. The following PN Programs were below the national average: Brown Mackie College – Merrillville and Brown Mackie College – Fort Wayne.

Ms. Hines informed the Board that Everest College, (formerly Olympia College), has increased their pass rates from 69.05% to 96.55%, which means Everest College will probably be requesting a hearing in the near future to come off of conditional accreditation.

The following ASN Programs were below the national average: Ancilla College, St. Elizabeth School of Nursing, Ivy Tech – Gary, Ivy Tech – Valparaiso, Ivy Tech – Columbus, Purdue University – North Central, Indiana University – East, Indiana University – Northwest, and Marian College.

Ms. Hines explained to the Board that Marian College's pass rate has been below the national average for three consecutive years and according to 848 IAC 1-2-5, Marian College will need to submit a plan of correction to the Board for approval.

The following BSN Programs were below the national average: Marian College, Anderson University, University of Evansville, and Goshen College.

Board Action: A motion was made and seconded to approve the pass rates submitted by NCCBN.

Sean Gorman, Board Director, presented his Board Director Report to the Board. Mr. Gorman talked about the creation of the three sub-committees with the Board, which are, the education sub-committee, rules sub-committee, and APN sub-committee.

Mr. Gorman also thanked the Board Members for their participation with the selections for the Salute to Nurses luncheon. Mr. Gorman reminded the Board Members that the luncheon is on April 29, 2008.

## VIII. PERSONAL APPEARANCES

## A. Appearances for Applicants by Licensure

## 1. Jennifer Smith – Examination

Ms. Smith appeared before the Board regarding the positive response on her examination application. Ms. Smith explained to the Board that she pled guilty to fourth degree domestic violence, a misdemeanor. Ms. Smith explained to the Board that she has completed a court appointed victim impact panel and court

appointed anger management courses. Ms. Smith explained that she was also charged with a OWI in June of 2006. She pled guilty to this charge, a class a misdemeanor, in November, 2006.

**Board Action:** A motion was made and seconded to approve Jennifer Smith to be made eligible to sit for the examination and once she passes be licensed with no restrictions.

#### 2. Lindsey Goodrich - Endorsement

Ms. Goodrich appeared before the Board regarding the positive response on her endorsement application. Ms. Goodrich explained that she was in the Texas Board of Nursing Rehab Program. She had a positive drug screen for cocaine. Ms. Goodrich informed the Board that she didn't complete the Texas Rehab program. Ms. Goodrich also informed the Board that she has a current Texas license with no discipline.

**Board Action:** A motion was made and seconded to issue Lindsey Goodrich's license on Indefinite Probation. Further, Ms. Goodrich must contact ISNAP and be evaluated by them within thirty (30) days. If Ms. Goodrich is eligible for the ISNAP program, her license will be on probation for the duration of her RMA. If Ms. Goodrich is not eligible for the ISNAP program, she can immediately petition the Board to have the probation withdrawn from her license.

#### 3. Deborah Sarazen - Examination

Ms. Sarazen appeared before the Board regarding the positive response on her examination application. Ms. Sarazen appeared before the Board at their August 16, 2007 meeting. The Board requested that Ms. Sarazen be evaluated by ISNAP and once she was evaluated, she would need to make another appearance before the Board. ISNAP informed IPLA on January 11, 2008 that Ms. Sarazen does not meet criteria for monitoring in ISNAP.

Board Action: A motion was made and seconded to issue Deborah Sarazen's license by examination.

#### 4. Erica Silva - Endorsement

Ms. Silva appeared before the Board regarding the positive response on her endorsement application. Ms. Silva stated that she did not complete the twenty hours of continuing education for her Texas nursing license. Therefore, she had to complete the twenty hours of continuing education and she had to pay a fine in the amount of \$100.00 dollars.

Board Action: A motion was made and seconded to issue Erica Silva's license by endorsement.

## 5. Heather Cunningham - Examination

Ms. Cunningham appeared before the Board regarding the positive response on her examination application. Ms. Cunningham stated in July of 2001 she was charged for possession of marijuana. Ms. Cunningham stated she was convicted of all three charges and they were ultimately dismissed.

## 6. Amy Martin - Endorsement

Ms. Martin appeared before the Board regarding the positive response on her endorsement application.

Ms. Martin was terminated after she had major health issues on August 15, 2005 from Hospice of Lancaster County. She was terminated from Lancashire Hall Nursing and Rehabilitation Center on June 6, 2006 after she had been sick and in the hospital for dehydration. On March 6, 2007 Ms. Martin was terminated from Masonic Village because they felt it was going work out with her working there. The recommendation made by Jerry Burghduff at the September 20, 2007 meeting was denied by the Board. The Board requested that Ms. Martin submit an evaluation from a pain medical specialist prior to approval for licensure at their September 20, 2007 meeting. Ms. Martin was rescheduled before the Board because IPLA had not received the evaluation as requested at the September 20, 2007 meeting.

Board Action: A motion was made and seconded to issue Amy Martin's license by endorsement.

#### 7. Rodney Sosbe - Examination
