IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT

Charles Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of September 2007, 468 active clients, 31 new intakes, 66 intakes in process and 18 RMA's returned. ISNAP staff reviewed 12 applications for the Needs Assistance Fund ("NAF"), approving 8 for assistance.

Mr. Lindquist reported having attended the national conference for the National Organization for Alternative Programs ("NOAP") in Washington D.C. on October 9-11, 2007. Mr. Lindquist provided the Board with a report summarizing the issues addressed at the conference.

Mr. Lindquist addressed the audience at the request of the Board.
