IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Chuck Lindquist, Program Director, appeared on behalf of the ISNAP program. ISNAP has placed an article in the ISNA bulletin for APN's working in the field of addiction to assist in ISNAP's work with nurses. There is a new resource available as well. ISNAP had 41 new intakes last month and anticipates another 70-80 in the next month due to the RN renewal window and personal appearances. Mr. Lindquist then addressed the audience regarding the ISNAP program.

V. EDUCATION

A. Ivy Tech Community College of Indiana- Request for change in program codes (Laurie Peters)

Ivy Tech has 14 regions in the Ivy Tech system and has several multi-campus regions that share resources, faculty and clinical space. They are working to streamline the system. They would like to consolidate to one ASN and one LPN program per region. This would cause one result for NCLEX per program, per region. Dr. Peters indicated they can still track each campus separately independent of the NCLEX scores coming as one packet. Dr. Peters indicated understanding that the region will go on conditional accreditation if NCLEX scores are low. A motion was made and seconded to grant the request. B. FYI Only- Medtech College, Greenwood Campus- Debra Zanders, MSN named as interim Director of Nursing replacing Lee Williams effective 10/3/13.

C. FYI Only- Indiana University Purdue University Fort Wayne- Dr. Lee-Ellen Kirkhorn named Nursing Department Chair effective July 1, 2013.

D. FYI Only- Ivy Tech Community College and University of Indianapolis announce post-licensure program for ASN to BSN licensure effective Fall 2014.

E. Medtech College, Fort Wayne Campus, - Quarterly Progress Report

Staff from Medtech, Fort Wayne Campus appeared for their quarterly progress report. A quarterly progress report was shared with the board. Their attrition levels have improved slightly over last year's numbers. For 2013, staff reported NCLEX scores at 88% for the LPN program and 72% for the ASN program. The Board asked about the number of students who have not yet tested for the year. Staff

indicated they have approximately 10 ASN students who have not tested for 2013. Board members asked if attrition calculations of students no longer in the program are being counted and staff indicated they are. Board members asked about the change in TEAS scores. They are requesting a change, as it is 52% right now and they are requesting to move to 58.7% for the change. Currently, students can retest within 24 hours, staff indicated they are working on a change to 30 days. Board Action: A motion was made and seconded to accept the quarterly report. Ms. Kiefner Crawford reported the following:

- A huge thank you to all Board staff and Board members who have worked diligently to complete the RN renewal cycle. In 75 days, over 104,000 renewals were processed and approximately 350 people have already been seen in personal appearances related to positive responses on renewals. The Board staff took over 2,400 phone calls the last 5 days of renewal and handled nearly 11,000 emails in the month of October alone.

A. Appearances by Applicants for Licensure Room 4

1. Yhaneka L. Kilpatrick RN Exam CBC Hit/Positive Response

Ms. Kilpatrick appeared for her personal appearance regarding her application for licensure. She has a plea agreement with the Attorney General's office regarding her LPN license. She graduated from her RN nursing program for June 2013. She has been arrested but did not disclose. She is allowed to test. Her license is to be issued on probation for six months active practice with quarterly reports.

2. Felix Azubuike RN Exam 5 Fails in 18 months

Mr. Azubuike appeared for his personal appearance regarding his application for licensure. He has taken the test 4 times. He has taken a review course with Kaplin. He has taken Kaplin before testing and after. He needs to take another review course and provide documentation showing he has a 95% chance or greater of passing the test. Once this is received he will be allowed to test and license to be issued free and clear.

3. Hannah Allman RN Exam 5 Fails

Ms. Allman appeared for her personal appearance regarding her application for licensure. She graduated in 2011 and has tested 5 times. Her last test was August 2013. She has tested twice in 2013. She has taken previous review courses. She is currently working with one on one tutor. She feels that she can pass the test on her next attempt. She had issues with her last test attempt there were issues with her IDs due to marriage name and this caused her issues with her concentration. She needs to take the review course and provide documentation showing she has 95% change or greater of passing the test. Once this documentation is received she will be allowed to test. She was arrested once for theft. She took items from Wal-Mart. This is her only arrest. Her license is to be issued on probation for six months active practice with quarterly reports.

4. Bianca Brown RN Exam CBC Hit/ 5 Fails

Ms. Brown appeared for her personal appearance regarding her application for licensure. She has taken the test 5 times. Her last time was in June 2013. She graduated in 2010. Since June she has been doing one on one tutoring. She needs to take a review course and provide documentation showing that she has 95% or greater chance of passing. Once this documentation is received she is allowed to test. She has a pending public intoxication charge, battery, and resisting arrest. Status of license will depend on outcome of her criminal issues. Another personal appearance will need to be scheduled after the criminal matters are resolved.

5. Rebecca Jordan RN Exam Grad Date of 2006

Ms. Jordan appeared for her personal appearance regarding her application for licensure. She graduated in 2006 and attempted to take the test 3 times. Her last attempt was two years ago. She has taken review courses since then. She took that in May of 2013. She has the predictably document. She is allowed to test and license to be issued free and clear.

6. Jessica Salzwedel RN Exam CBC Hit

Ms. Salzwedel appeared for her personal appearance regarding her application for licensure. In 2005, she received criminal conversion. She attempted to return stolen items to a store for the money. In 2011, she was charged with theft. There was a dispute at a store with the cashier. They were arguing and she just left the store with the money. She has had no other

arrest. Her nursing school was aware of her all of this when she was there. She is allowed to test. Her license is to be issued on probation for one year active practice with quarterly reports

7. Eva Cameron RN Endo Positive Response

8. Erika Jeffery RN Endo CBC Hit/ Positive Response

Ms. Jeffery appeared for her personal appearance regarding her application for licensure. She is currently licensed in IL. In May 2013, she was arrested for domestic battery. She got into a fight with a friend and police was called. The case is still pending. Her license in IL is active. They are not aware of this issue. She is allowed to endorse. Her license will be issued on probation until her criminal matter is resolved. She must submit quarterly reports.

9. Michelle Crawford RN Exam 13 Fails

Ms. Crawford appeared for her personal appearance regarding her application for licensure. She graduated in 2001. She has taken the test 13 times. Her last attempt was January 2011. She has taken Kaplan review, took review classes with Ivy Tech, and worked with a tutor. She is still in Kaplan. She needs to send in documentation showing she has a 95% chance or greater of passing. She is allowed to test after that documentation is received. This is her last change. Her license is to be issued free and clear.

10. Maryanna Sinenko RN Exam Grad Date of 2009*

Ms. Sinenko did not appear for her personal appearance. Her application is denied.

11. Rachele Herrera LPN Exam CBC Hit

Ms. Herrera appeared for her personal appearance regarding her application for licensure. She graduated in 2013. She did not disclose on her application past arrest on her application. She didn't answer yes for the first one because she thought it wasn't on her record and the second one she didn't realize was a criminal offence. In 2012, she agreed to give a guy a ride home. She did not know this guy. She was pulled over. They guy was acting nervous so they both were asked to step out of the car. He put marijuana under her seat. They both were arrested. The charges against her were dismissed.

Other case involves her special needs child and attendance at school. Her child is 9 years old. She was arrested because her child was not attending school on a regular basis due to his health issues. This matter is set for trial on December 18, 2013. She is allowed to test. Her license is to be issued on probation for six months active practice with quarterly reports. She needs to send in documentation showing the criminal outcome.

12. Britney Gibson LPN Exam CBC Hit/ Positive Response

Ms. Gibson appeared for her personal appearance regarding her application for licensure. She was arrested April 2011 for failure to appear to court. She wasn't aware of the ticket. She was arrested in 2012 for domestic batterh. She got into a fight with her ex-boyfriend. The matter was dismissed. She is allowed to test. Her license is to be issued on probation for six months active practice with quarterly reports.

1. Carolyn Munger RN Renewal Positive Response*

Ms. Munger appeared for her personal appearance regarding. She was arrested this year for domestic battery and this was dismissed. She was previously arrested in 2002 and 2006. The 2006 was also for domestic battery. She has been licensed as a nurse in 2008. 2002 and 2006 previously disclosed. Renew free and clear.

2. Lynette Stevens RN Renewal Positive Response

Ms. Stevens did not appear for her personal appearance. Matter to be reset one additional time.

3. Kimberly Rebich RN Renewal Positive Response

4. Jennifer Brown CSR Renewal Positive Response

Ms. Brown did not appear for her personal appearance. Reschedule one time.

5. Laura Kinnaird RN Renewal Positive Response

Ms. Kinnaird appeared for her personal appearance regarding her application for renewal. In July 2013, she was arrested for an OWI. She had some drinks with friends then drove home. She parked in a housing addition parking lot. When she woke up she ran over the sidewalk. Her blood alcohol level was .16. She is currently on criminal probation. She has not had any other issues. Her license is to be renewed on probation the length of her criminal probation or six months active practice, whichever is longer. She will also need to submit quarterly reports.

6. Jennifer LewisRenfrow RN Renewal Positive Response

She was suppose to throw away some insulin. She has a friend with no insurance and she took them for a friend. She was terminated for this. She told her facility she took them. This took place in October 2013. She is currently working. She has never done this before. Her license is to be renewed on probation for 18 months active practice, quarterly reports and 12 CEUS in medication and 12 CEUS in professionalism/ethics.

7. Mary Yaggy RN Renewal Positive Response

Ms Yaggy appeared for her personal appearance regarding her application for renewal. She had a malpractice settlement. The event happened in 2007 but the matter was just recently settled. It was a nuisance case. She has not had any other issues. No action was taken against her at work as a result of this issue. Her license is to be renewed free and clear.

8. Tammy Powers RN Renewal Positive Response

Ms. Powers appeared for her personal appearance regarding her application for renewal. She had applied for endorsement in California. She had previous had discipline in AZ in 2005. That license is currently suspended. Her application for California was denied. She has applied for OK and Alaska but it's still on hold.

She was terminated last year. She was placed on a unit and was the only nurse for the unit. According to guidelines was not enough RN. She told them she needed another nurse on the unit and she was told she would not get additional staff. They claimed she did not give a patient medication which she states she did. She is not currently working. Renew free and clear.

9. Pam Kruder RN Renewal Positive Response

Ms. Kruder appeared for her personal appearance regarding her application for renewal. In December 2011, she missed a court date due to a medical bill, she was arrested, she paid the money and the matter is resolved. Renew free and clear.

10. Tammy Paesch RN Renewal Positive Response

Ms. Paesch appeared for her personal appearance regarding her application for renewal. In January 2012, she was terminated from the hospital where she had worked for 20 years. She looked some information online about an arrest of a supervisor. She sent the link to a former co-worker from home but the coworker looked it up on line at work. She sent it to the former co-worker to ask for direction on what to do with it and she sent her this information in a private message via facebook. She reported the arrest to her trust line at work. She found out about this arrest from another current co-worker. Her employer did an internal investigation. She was called in and was questioned about posting information about this matter on facebook which she denies she did. She did send the message to the former coworker the link through private message on facebook but did not put it on her public page. She informed her HR this is how it was sent. She was terminated for sharing information to others and gross misconduct with corrective action policy and harassment policy. She is currently working and they are aware of her termination. Her license is to be renewed after she sends in 12 CUEs in professionalism/ethics.

11. Dana Jones RN Renewal Positive Response

Ms. Jones appeared for her personal appearance regarding her application for renewal. She was terminated from a facility that she had just been hired in but once disclosed she was in ISNAP she was terminated. In September 2012 she worked for hospital that she had been at for 13 years. She was suspected for diversion, and it was reported to the Attorney General's office. They told the AG she was terminated but she was under the impression that she resigned. She was asked to do a urine drug screen, she agreed to do it but it was not done due to resignation. She is currently in an 18 month RMA and is in full compliance. She was not in monitoring when this took place last September. Renew free and clear.

12. Lea Kraus RN Renewal Positive Response

Ms. Kraus appeared for her personal appearance regarding her application for renewal. She was terminated from St. Andrews in January 2013. This was her first nursing job. She was written up not following an order to start medication right away. She didn't have the correct dose so she didn't give any medication and passed it off to second shift. She received a write up and educational coaching for the incident. A couple weeks after this incident she did a significant medication error. The patient was on hospice and was actively dying. The orders were mistaken. The next day she saw a different order but though it was a mistake so she gave what she thought was the right dose. As soon as she realized the mistake she let her DON know and corrected it with the patient. She was terminated for his. She is currently in ISNAP. She has an 18 RMA. She has had on missed drug screen that may have been excused. She has been in compliance. She is currently working. Her current employer is aware of past history. Her license is to be renewed on one year active nursing practice, quarterly reports, CEUs: 24- hours medication, 12- professional/ethics, 4 hours critical thinking.

13. Beth Taylor RN Renewal Positive Response

Ms. Taylor appeared for her personal appearance regarding her application for renewal. In April 2012, she relinquished her CSR. The facility she was working out was audited by the DEA. Everyone there with a CSR was asked to do so. She had written prescriptions for Subxone for pain management. The board of nursing was not notified of this. She is currently working at Purdue University. She also works part time. Neither position requires a CSR. License to remain as Valid to Practice and send up to the Attorney General's office.

14. Debbie Cragen RN Renewal Positive Response

15. Meghan Peffers RN Renewal Positive Response

This matter needs to be rescheduled for December 12, 2013.

16. Brandi Kaiser RN Renewal Positive Response

Ms. Kaiser appeared for her personal appearance regarding her renewal. She applied for a California license while her license on IN was on probation. Her application in CA was denied due to IN probation. She thought she already reported in on her 2011 renewal. Renew free and clear.

17. Stella Rood RN Renewal Positive Response

Ms. Rood appeared for her personal appearance regarding her application for renewal. She was arrested for an OWI. She was at a friend's house and had been drinking. Her blood alcohol level was .08. The OWI was later dropped to a public intoxication charge. She was on six months probation and paid a fine. She has had no other arrest. Her license is to be renewed on probation for six months active practice with quarterly reports.

18. Patricia Biddle RN Renewal Positive Response

Ms. Biddle appeared for her personal appearance regarding her application for renewal. She was arrested in February 2013. There was money in the slot machine at a casino. She cashed the money out but was then told it was someone else's and she paid it back. This happened twice. She was pulled over a few months later for speeding and discovered there was a warrant out for arrest. She wasn't aware of the warrant. She is currently on home detention. Her license is to be renewed on probation for six months active probation quarterly reports.

19. Mark Tucker RN Renewal Did Not Disclose

Mr. Tucker appeared for his personal appearance regarding his application for renewal. He did not report that his nursing license is on probation. He is currently in a 3 year RMA and is fully compliance. He didn't answer yes because he didn't realize he was suppose too. He just misunderstood the question. He is currently employed. His license is to be renewed on probation under his current order.

20. Gwendolyn Sunkel RN Renewal Did Not Disclose

Ms. Sunkel appeared for her personal appearance regarding her application for renewal. She did not disclose a malpractice settlement on her renewal. She was told that she wouldn't need to report it since the malpractice didn't involve her. Events took place in 2005. Her licensee is to be renewed free and clear.

21. Mary Schuster RN/Midwife Renewal Positive Response

Ms. Schuster appeared for her personal appearance regarding her application for renewal. She started with Health net in March 2013 and she was terminated during her probation period. They stated she was too slow. She was told she needed to speed up and go faster. She is licensed in Ohio which is inactive and she has an expired WI, neither is disciplined. She has never been terminated before. Her license is to be renewed free and clear.

22. Stacey Ayers RN Renewal Positive Response

Ms. Ayers appeared for her personal appearance regarding her application for renewal. She was written up in December 2012, due to care of a patient that was not hers. She was written up for not calling a rapid response on the patient. She told his nurse but that nurse didn't follow through. Her license was on probation at this time, she was suspended for not telling the facility that her license was on probation. Her license is to be renewed on probation with an additional 24 CEUs in professionalism/ethics and an additional six months active practice with quarterly reports.

23. Casey Springer RN Renewal Positive Response

Ms. Springer appeared for her personal appearance regarding her application for renewal. She is currently in ISNAP and in compliance. In July 2013, she was caught diverting at work and self reported to ISNAP. She was suspend then terminated from employment. Her RMA is 18 months. She is not currently working as a nurse at the moment. Her license is to be renewed on probation for the length of her RMA. She is to also submit quarterly reports and 8 CEUs in impaired nursing and 12 CEUs in professionalism and ethics.

24. Cheryl Riester RN Renewal Positive Response

M s. Riester appeared for her personal appearance regarding her application for renewal. She was terminated in August 2013. She called in a medication and gave a different name when calling it in. She is currently in ISNAP and her RMA was extended. The doctor told her that she could call the prescription in for her husband. Her license is to be renewed on probation length of RMA, submit quarterly reports and complete 4 CEUs in critical thinking, 12 CEUs in professionalism/ethics and 4 CEUS in medication administration.

25. Jacqueline White RN Renewal Positive Response

Ms. White appeared for her personal appearance regarding application for renewal. She is in ISNAP and has 3 year RMA. She is in compliance. She received a DUI in February of 2012. She also had a previous DUI in 2009. She self reported to ISNAP after the 2012 DUI. She self reported herself to her job also. Her blood alcohol level for the 2012 incident was .2. Her license is to be renewed on probation for the length of her ISNAP RMA, with quarterly reports and 8 CEUS in impaired nursing.

26. Kendra Clay RN Renewal Positive Response

Ms. Cooper indicated that the licensee reported that she was terminated for working at one nursing program and consulting at another. Ms. Cooper indicated that she asked the licensee whether she had ever been terminated previously and the licensee said she had not. Ms. Hall had information that the licensee was also terminated from Harrison College in 2011 in a matter not disclosed to the Board member. The licensee is currently serving as a Dean at an ITT location. A motion was made and seconded to place her on the December 12th agenda to be seen by the full Board. Cooper/McIntosh, 7-0-1, motion carries (Hall abstains)

27. Christopher McCan RN Renewal Positive Response

Mr. McCan appeared for his personal appearance regarding his application for renewal. He was arrested for a OWI when he was coming home from a concert. His blood alcohol level was .14. He felt ok to drive when he left. He was in an accident where he bumped into another car. There were no injuries or damage to either car. He has no other issues and is currently employed at same place. He is on criminal probation for a year. His license is to be renewed on probation for a year, with 8 CEUs in impaired nursing and 8 CEUs in professionalism/ethics.

28. Kevin Chase RN Renewal Positive Response

Mr. Chase appeared for his personal appearance regarding his app for renewal. He received an OWI in June 2012. He pled guilty and had a year probation which he successfully completed. He has had no other issues. His licensee is to be renewed on probation for 6 months with 8 CEUs in impaired nursing and 8 CEUS in professionalism/ethics.

29. Wygonda Rogers RN/APN/CSR Renewal Did Not Disclose

Ms. Rogers appeared for her personal appearance regarding her application for renewal. She did not disclose a malpractice settlement. She just didn't think about it when she renewed. She did retire in November of 2012. She just wants to keep her license. Her license is to be renewed free and clear.

30. Ronda Alexander RN Renewal Positive Response

Ms. Alexander appeared for her personal appearance regarding her application for renewal. She is ISNAP and is compliant. She received an OWI in March 2012. She also had a previous OWI in 2005. She self reported to ISNAP. She is in a 3 year

RMA. Her license is to be renewed on probation for the length of her RMA, with quarterly reports and 8 CEUs in impaired nursing and 8 CEUs in professionalism/ethics.

31. Angela White RN Renewal Positive Response

Ms. White appeared for her personal appearance regarding her application for renewal. She answered yes to #1 by mistake.. She was terminated for refusing drug screen and has since returned to the same facility. She is RMA for a year. Her license are to be renewed on probation for the length of her RMA and 8 CEUs in impaired nursing and 8 CEUs in professionalism/ethics, also needs to submit quarterly reports.

32. Janet Huseman RN Expired Renewal Working on Expired License

This matter was seen by the full Board. The licensee was working on an expired license for two years since 10/31/2011. She worked part-time in a cardiologist's office taking vitals, updating medications and reordering medications through the computer system. She admits signing her name as an RN while her license was expired. Board Action: A motion was made and seconded to place the license on valid to practice while under review and refer the matter to the Office of the Attorney General for investigation.

33. Mark Addington RN Renewal Positive Response

Mr. Addington appeared for his personal appearance regarding his license renewal. Mr. Addington was terminated from his employment for patient abandonment. He license will be placed on six (6) month probation with submission of two (2) good employer reports.

34. Mary Dillon RN Renewal Positive Response

Ms. Dillon appeared for her personal appearance regarding her license renewal. Ms. Dillon was terminated from her employer after being employed six (6) days. Her license will be renewed free and clear.

35. Linda Lindsey RN Renewal Positive Response

Ms. Lindsey appeared for her personal appearance regarding her license renewal. Ms. Lindsey was terminated from her employment for absences. Her license will be issued free and clear.

36. Lori Tolbert RN Renewal Positive Response

Ms. Tolbert did not appear for her personal appearance regarding her license renewal. Her license is denied.

37. Mary Ryll RN Renewal Positive Response

Ms. Ryll did not appear for her personal appearance regarding her license renewal. Her license is denied.

38. Chrystal Pruett RN Renewal Positive Response

Ms. Pruett appeared for her personal appearance regarding her license renewal. Ms. Pruett was arrested for OUI. She had taken something for a migraine and fell asleep behind the wheel. Her license will be renewed free and clear.

39. Melinda Rudolph RN Renewal Positive Response

Ms. Rudolph appeared for her personal appearance regarding her license renewal. Ms. Rudolph was terminated from her employment. Her license will be placed on probation for six (6) months with submission of two (2) good employer reports.

40. Michelle Richardson RN Renewal Positive Response

Ms. Richardson appeared for her personal appearance regarding her license renewal. Ms. Richardson was arrested June 2012 for OWI. Her blood alcohol level was .24. Ms. Richardson is currently in an out-patient intensive care program and has nine (9) weeks before completion. Her license will be placed on probation for the length of her intensive program or RMA, whichever is longer. In the case of Ms. Richardson not meeting qualifications for ISNAP, she will remain on probation for the duration of the intensive program and submit employer reports or self reports.

41. Natasha Cassidy RN Renewal Positive Response

She received a letter from the board for documentation errors. She didn't disclose the issue on her application because Kentucky had not done anything yet and the matter is still being investigated. Her license in Kentucky was renewed. She was investigated for diversion in Kentucky and it was decided that she was diverting or have an addiction. Documentation shows wrong medication was removed for patient but she went to the supervisor as soon as she discovered it. Allow endorsement. She is to be issued on probation until the matter Kentucky has been cleared up completely. She will need to send quarterly reports to the board.

Ms. Johnson appeared for her personal appearance regarding her application for renewal. In June 2012, she received a DUI. She was with her boyfriend and the both had been drinking. They go into a fight so she went to sit in the car to get away from him. He came down to the car and threatened her so she left. He called the cops on her. She believes her blood alcohol level was .14. She entered into a plea agreement and was placed in house arrest then two years probation. This took place in Oregon. She has several different license and they all are free and clear. She had a previous DUI when she was 21. Her license is to be renewed on six months active practice, quarterly reports, and ISNAP evaluations.

73. Maria Lilly RN Renewal Positive Response

Ms. Lilly appeared for her personal appearance regarding her application for renewal. She received a DUI in May 2013. She has completed her criminal probation. Her APN is currently on probation due to the DUI. Her RN license is to be renewed free and clear.

74. Teresa Haas RN Renewal Positive Response

Ms. Haas appeared for her personal appearance regarding her application for renewal. She received an OWI and endangerment. She drove home after dinner. She believes her blood alcohol level was .13 but she is not sure. She is on criminal probation until March 2014. Twenty years ago she was arrested for public intoxication. Her license is to be renewed on six months active practice with quarterly reports, and ISNAP evaluation.

75. Megan Wilson RN Renewal Positive Response

Ms. Wilson appeared for her personal appearance regarding her personal appearance. She used her user name and password to access her son's lab reports. She offered this information up in a meeting and was fired for violating HIPPA. She has had no other issues. She needs to complete 12 CEUs in HIPPA. Once these are received her license can be renewed free and clear.

76. Tiffany Olmstead RN Renewal Positive Response

Ms. Olmstead appeared for her personal appearance regarding her application for renewal. She received a DUI in 2011. She did report this on her 2011 renewal and her status remained at Valid to Practice. She was not placed in criminal probation. She self reported the matter to her employer. She has not had any other issues. Her license is to be renewed free and clear.

77. Melissa Shaffer RN Renewal Positive Response

Ms. Shaffer appeared for her personal appearance regarding her application for renewal. She was out with friends and received a DUI. Her blood alcohol level was .08. She was placed on a year of probation. She works at St. Vincent's hospital. She had an underage drinking charge when she was 18. Her license is to be renewed on probation for six months active practice, quarterly reports, and ISNAP evaluation.

78. Robin Huffman RN Renewal Positive Response

Ms. Huffman appeared for her personal appearance regarding her application for renewal. She was working at a middle school. She received a call that there was a sick girl in the bathroom. This girl had a history of claiming to be sick. She was delayed in giving care. She also had a conflict with the principal at the school. She was terminated. She was terminated from another facility for violating a policy during orientation. She is currently not working. Her license is to be renewed free and clear.

79. Vanessa Scott RN Renewal Positive Response

Ms. Scott appeared for her personal appearance regarding her application for renewal. She was out celebrating a new job and got into a fight with her boyfriend. She got mad and drove home after having some drinks. She does not remember her blood alcohol level. She entered into a plea agreement which she successfully completed. She has not had any other issues. Her license is to be renewed on probation for six months active practice, quarterly reports, and ISNAP evaluation.

80. Sarah Hisch RN Renewal Positive Response

Ms. Hisch appeared for her personal appearance regarding her application for renewal. She was terminated after watching three CNAs play a joke on another nurse and she did not intervene to stop them. Her license is to be renewed free and clear.

81. Mary Bramwell RN Expired Renewal Working on Expired License

Ms. Bramwell appeared for her personal appearance regarding her application for renewal. She did not renew her license in 2011. She has worked the last two years as a school nurse. Her license is to be renewed on probation for six months active practice with quarterly reports. This matter is to be sent to the Attorney General's office for investigation.

82. Samantha Rainbolt RN Expired Renewal Positive Response

Ms. Rainbolt appeared for her personal appearance regarding her application for renewal. She was caught shoplifting at Wal-Mart in 2011. The case was dismissed after she did community service. She has no other issues. Her license is to be renewed free and clear.

83. Amanda Casey RN Renewal Positive Response

Ms. Casey did not appear for her personal appearance regarding her application for renewal. Her renewal has been denied.

84. Maureen Socha RN Renewal Office Manager Did Renewal CONTINUED

85. Arcadia Franklin RN Renewal Positive Response

Ms. Franklin appeared for her personal appearance regarding her application for renewal. She was fired due to not being able to catch onto the computer system fast enough. She believes it was age discrimination. She was terminated from Maxim Healthcare because her supervisor didn't like her and there was a personality conflict. She was asked to resign from a previous position in the past. Her license is to be renewed on probation for six months active practice and quarterly reports.

86. Cammy Stinson RN Renewal Positive Response

Ms. Stinson appeared for her personal appearance regarding her application for renewal. She went to work in September 2012 and was told she had a patient in active labor. She did not feel that her staff was sufficient to cover the deliver. She voiced her concerns regarding the patient's safety. She was terminated. Her license is to be renewed free and clear.

87. Stephanie Thurman-Edwards RN Renewal Positive Response

Ms. Edwards appeared for her personal appearance regarding her application for renewal. A CNA came and told her that she while she was turning a patient she hit the patient's face against the wall. She assessed the patient and report the matter to the supervisor. She did not contact the patient's family or doctor. She kept an eye on the patient's neurology status and placed ice on her face due to swelling. In the morning the patient was taken to the ER where it was discovered she had a fractured nose. The DON called the police on the CNA. Both her and the CNA was terminated. As a new nurse she was asked to resign due to pressures of family members being sick. She is currently working in home health care. Her license is to be renewed on probation for six months active practice and quarterly reports.

88. Dustin Craig RN Renewal Positive Response

Mr. Craig appeared for his personal appearance regarding his application for renewal. He received an OWI in October 2012. He was out with a friend and was pulled over. His blood alcohol level was .11. His criminal probation ends January 2014 but will probably be completed November 23, 2013. He currently works at IU health. His license is to be renewed free and clear.

89. Emily Blair RN Renewal Positive Response

Ms. Blair appeared for her personal appearance regarding her application for renewal. She received a public intoxication charge in July 2013. She had gone out with some friend and had some shots. She started feeling ill so she went outside and laid down on the grass near the street. A cop was driving by and stopped to check on her. She entered into a six month pretrial diversion agreement. It will be over in March 2014. She has had no other issues. Her license is to be renewed on probation for six months active practice, quarterly reports, and ISNAP evaluation.

90. Athena Turner RN Renewal Positive Response

Ms. Turner appeared for her personal appearance regarding her application for renewal. She has been closed out of ISNAP due to non-compliance. She was non-compliant due to medication she had to take and being too sick to go take the drug test. Her license is to be renewed on probation for six months active practice, quarterly reports, and return to ISNAP.

91. Marilyn Hackett RN Renewal Positive Response

Ms. Hackett appeared for her personal appearance regarding her application for renewal. She was taking medication for depression and went off of it. She got depressed again and was caught shoplifting. She entered into a pretrial diversion program until July 2014 and went back on her depression medication. She was arrested years ago for shoplifting. She is currently working at the VA hospital. Her license is to be renewed on probation for six months active practice and quarterly reports.

92. Bradley Marks RN Renewal Positive Response

Mr. Marks appeared for his personal appearance regarding his application for renewal. He was out with friends and received a public intoxication charge. He had called a cab to take them home but received the charge before the cab got there. He entered into a pretrial diversion program. His license is to be renewed on probation for six months active practice, quarterly reports, and ISNAP evaluation.

93. Jessica Mulhaupt RN Renewal Positive Response

Ms. Mulhaupt appeared for her personal appearance regarding her application for renewal. She was terminated from IU health for violating HIPPA. She viewed her and a co-workers health records while at work. She has since taken CEUs in HIPPA. She has not had any other issues. Her license is to be renewed free and clear.

94. Edward Edmiston RN Renewal Positive Response

Mr. Edmiston appeared for his personal appearance regarding his application for renewal. In May 2013, he was out with friends. He thought he had quit drinking in enough time to drive home. He was convicted on public intoxication. He is on unsupervised probation. He has not had any other issues. His license is to be renewed on probation for six months active practice, quarterly reports, and ISNAP evaluation.

95. Arlene Locke RN Renewal Positive Response

Ms. Locke did not appear for her personal appearance regarding her application for renewal. Her application for renewal has been denied.

96. Sindi Lowe RN Renewal Positive Response

Ms. Lowe appeared for her personal appearance regarding her application for renewal. She has an OK license that is active but with conditions. She needs to see a psychologist from their board list. There is only two people on that list. She has not done that yet. A few years ago she was very sick and attempted suicide; this is the reason for the need to see the psychologist. She did undergo inpatient treatment. Her license is to be issued on probation until her OK license is completely free and clear.

97. Camille Elick RN Renewal Positive Response

Ms. Elick appeared for her personal appearance regarding her application for renewal. She received an OWI. She pulled over to get sick and a police officer pulled up behind her. Her blood alcohol level was .09. She is in ISNAP and has a one year RMA that she has been fully compliant with. Her license is to be renewed free and clear.

98. Ida Hole RN Renewal Positive Response

Ms. Hole appeared for her personal appearance regarding her application for renewal. She has a pending malpractice case where the patient died after surgery. Everyone involved was named in the matter. The matter is to be referred to the Attorney General's office and her license status is to be Valid to Practice While Being Reviewed until the AG's investigation is completed.

99. Molly Neeley RN Renewal Positive Response

Ms. Neeley appeared for her personal appearance regarding her application for renewal. She was on medical leave for a year and her place of employment could no longer hold her position. Her license is to be renewed free and clear.

101. Nicole Lyons RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reported a public intoxication charge in 2011. She was a passenger in a car that was pulled over. She was arguing with a police officer and would not listen. She was not tested for BAC at the scene. She had a minor consumption charge approximately eight years ago. She is currently working as a nurse and has no problems. ALJ Narwold recommended that the license be renewed free and clear.

102. Carrie Hines RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reported an addiction to pain medications and forging a prescription to obtain pain medications. She is on criminal probation at this time. She self reported to ISNAP and is in full compliance. She is not working at this time. ALJ Narwold recommended renewing the license on probation until successful completion of the criminal probation.

103. Larry Swaby RN Renewal Positive Response CONTINUED

104. Amber Johnson RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reported a disorderly conduct charge related to a domestic event and is in a diversion agreement through November 16, 2013. She remains in the relationship and reconciled. Alcohol was not involved in any way. She brought letters of support from her supervisor. She is currently in a diversion agreement at this time. ALJ Narwold recommends renewing the license free and clear with proof of the successful completion of the diversion agreement.

105. Anthony Moore RN Renewal Positive Response

The licensee appeared regarding his application for renewal. He reported an OWI in April 2013. He was at a friend's house and chose to drink and drive. He was involved in a single car accident. His BAC was 0.16 or 0.18. He reports no previous problems with alcohol. ALJ Narwold recommended that the license be renewed on indefinite probation and that he obtain an ISNAP evaluation and enters into an RMA if eligible. If he is not eligible for an RMA, he can apply for withdrawal once his criminal case is completed. If eligible for an RMA, he can apply for withdrawal after successful completion of the RMA.

106. Angela Langston RN Renewal Positive Response

The licensee appeared in person and by counsel Mark Lienhoop. She answered a question regarding malpractice action and has pending action at this time. A patient's blood glucose was low; she had seizures as a result, was sent to ICU and passed. The decision is at the medical malpractice panel and submissions are being made. She was not disciplined at work as a result of this incident. ALJ Narwold recommends renewal of the license free and clear. The licensee understands that if additional action occurs that she will disclose on her next renewal.

107. JoAnne Pates RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reported pending criminal charges for trespassing and resisting arrest. The criminal trial is postponed until December 2013. She refused to leave the emergency room after seeking treatment for asthma and flu-like symptoms and was arrested while on work shift. She was tasered as part of this process and this resulted in the resisting arrest charges. She did not answer "YES" on the question regarding termination on her renewal and admits she was terminated from the hospital for these actions. She worked after this for a month at a nursing home but left due to depression and a "nervous breakdown". ALJ Narwold recommends that the license be renewed as valid to practice while being reviewed and that the matter be referred to the Attorney General's Office for investigation.

108. Brent Boston RN Renewal Positive Response

The licensee appeared regarding her application for renewal. He reported being pulled over and arrested for DUI. His BAC was 0.15. He reports another alcohol related incident approximately 20 years ago. He has completed criminal probation and is attending AA meetings. ALJ Narwold recommended that the license be renewed free and clear.

109. Willard Cupp RN Renewal Positive Response

The licensee appeared regarding his application for renewal. He reports a reckless driving and a BAC of .09 at the time. He completed a diversion program and has been diagnosed and is being treated for bipolar disorder. He reports no problems at work. Prior to this time he had no issues with alcohol. ALJ Narwold recommends that the license be renewed free and clear.

110. Jessica Houser RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports an arrest for possession of bath salts and unlawful possession of a syringe. She was injecting IV drugs. She is in a 12 step program at this time and self reported to ISNAP after being in jail for 32 days. She completed criminal probation in June 2013. She is not working in nursing at this time. Her ISNAP compliance is full. ALJ Narwold recommended that the license be renewed free and clear.

111. Joanna Fray RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports an OWI in August 2012. She was out with friends and felt she was okay to drive. She reports having 6-7 beers in a 6 hour time span. Her BAC was 0.16. She pled guilty and was not on criminal probation. She reports no prior issues with alcohol. ALJ Narwold recommends that the license be renewed free and clear.

112. Sarah Williams RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a charge for reckless driving in June 2012. Alcohol was involved at the time. She had a friend in the car and caused an accident. She hit a semi, her friend was injured and taken to the hospital. Her BAC was 0.12. She completed criminal probation for this matter in June 2013. She then went to a concert in April 2013, did not feel well and went to sleep in the car. She was then taken home to sleep and got into an altercation with a significant other. She hit the significant other multiple times resulting in a bloody nose and cracked tooth and police were called. Her criminal charges are pending at this time for this incident. She is under court supervision at this time. She is enrolled in a domestic violence

class at this time. ALJ Narwold recommended that the license be renewed on probation, that the licensee obtain an ISNAP evaluation and sign an RMA if eligible. The license is to be on probation until the successful completion of the criminal matters or the ISNAP RMA, whichever is longer.

113. Megan Parsanko RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a termination in September 2013. She had a positive drug screen for cocaine. She is enrolled in ISNAP and is living in a halfway house. ALJ Narwold renewed the license on indefinite probation for the length of the ISNAP RMA.

114. Sarah Stump RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports criminal charges for possession of marijuana. She left her boyfriend at the house and went to a friend's house. Her home alarm went off and she did not answer the call. The police had been there prior to her arrival at home. She reported a strange light on in the home and the police came back to the home. During their search of the home, police discovered marijuana and arrested her. The marijuana belonged to the boyfriend. She hired a lawyer and completed a criminal diversion agreement. She is no longer in a relationship with the boyfriend. ALJ Narwold recommended that the license be renewed free and clear.

115. Dorothy Pyritz RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a DUI after being at a friend's house. She ran a stop sign and was arrested with a BAC of .17. She is a participant in ISNAP and completed an outpatient treatment program. She is in individual counseling at this time. Her criminal charges are pending. ALJ Narwold recommends making the license valid to practice while under review and referring the matter to the Office of the Attorney General while under investigation.

116. Lauren Maier RN Renewal Positive Response

The licensee appeared regarding her application for renewal with counsel Julie Smith. She reports an OWI in September 2013 and the criminal charges are still pending. She could not do a BAC but a blood draw was conducted. She currently works at Methodist Hospital and reports no issues. ALJ Narwold recommends making the license valid to practice while under review and referring the matter to the Office of the Attorney General while under investigation.

117. June Panchot RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a termination in this renewal cycle. She had a difficult patient who had coughed out his trach on the previous shift. The patient was out to the emergency room to reinsert the trach. She had difficulty finding supplies and completed a treatment without a physician's order. She reports prior interpersonal communication issues at this facility and a "no call, no show" incident. ALJ Narwold recommended that the license be renewed upon receipt of continuing education in the areas of documentation (12 hours) and interpersonal communication (12 hours).

118. Georgia Beam RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She was terminated from a position for failing to follow the directive of a superior. She reports the directive was to dispose of blank signed prescriptions from a physician and that she did not do so due to a messy desk. She reports there are charges pending against this physician. ALJ Narwold recommends making the license valid to practice while under review and referring the matter to the Office of the Attorney General while under investigation.

119. Phillip Beachey RN Renewal Positive Response

The licensee appeared regarding his application for renewal. He reports still being on criminal probation at this time. The incident is related to a DUI in July 2013. His BAC was .16 because he was injured in the accident and sent to the emergency room. He is not sure if anyone else was injured in the accident. He is working now at SJRMC in Mishawaka. This is his second DUI in two years. ALJ Narwold recommends that the license is renewed on probation for the length of the RMA. He may not work until he enters into the RMA.

120. Virginia Timbrook RN Renewal Positive Response CONTINUED

121. Carrie Yagle RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a DWI in October 2011. She went out for Halloween and does not recall her BAC. Her criminal charges are still pending for February 2014. ALJ Narwold recommend that her license be valid to practice pending review and be referred to the Office of the Attorney General for investigation.

122. Olivia Cronnon RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a termination due to a home care incident where a diabetic patient needed insulin but she did not go. She falsified the documentation and indicated that she had attended the patient. She

works at Maxim at this time. She has been a nurse for 25 years. ALJ Narwold recommends that the license be renewed free and clear.

123. Samantha Meeks RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She has a malpractice action pending against her license. The malpractice involves a post-menopausal patient that was non-compliant with care. The case is still in discovery at this time. ALJ Narwold recommended that the license be renewed free and clear. The licensee understands if additional action takes place she needs to report this on her next renewal.

124. Colleen Sahy RN Renewal Positive Response

The licensee appeared regarding her application for renewal. Angela Southern appeared on behalf of the licensee and was told to enter an appearance in the matter. The licensee has a pending malpractice action that is in discovery. The complaint was filed in June 2013. The licensee understands if additional action takes place she needs to report this on her next renewal.

125. Serena Fowler RN Renewal Positive Response

The licensee failed to appear. The matter will be rescheduled one time.

126. Jennifer Maze RN Renewal Did Not Disclose

The licensee appeared regarding her application for renewal. She reports failing to disclose a pending administrative complaint against her license during the renewal. ALJ Narwold recommends renewing the license as valid to practice while being reviewed and refer the renewal fraud issue for investigation to the Office of the Attorney General.

127. Kimberly Clark RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a termination in October 2012 for absence without leave and performance concerns. She did not have enough leave for medical issues. She reports inappropriately discussing a wrong site surgery with a patient. She also reports a patient who was on a narcotics contract and was prescribed a combination of medications. She called the pharmacy about acetaminophen levels and questioned the orders. ALJ Narwold recommends that the license be renewed free and clear.

128. Allen Howard RN Renewal Positive Response

The licensee failed to appear. The matter will be rescheduled one time.

129. Dariusz Gromko RN Renewal Positive Response

The licensee appeared regarding his application for renewal. He reports a DWI in July 2013. He was stopped after a dinner and blew a .11 BAC and a .14 at the police station. He has criminal charges pending at this time. ALJ Narwold recommends that the license be renewed as valid to practice while being reviewed and refer to the Office of the Attorney General for investigation.

130. Krystle Jackson RN Renewal Positive Response

The licensee was sent to ALJ Natalie Hall.

131. Jennifer Stacy RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a termination during this renewal cycle. She contacted a physician re: a resident issue overnight as an abdomen fold was bleeding. When she dated and initialed the dressing she wrote on the dressing of the patient. She failed to document the telephone order from the physician re: the taping. ALJ Narwold recommended that the license be renewed free and clear.

132. Christina Malone RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a charge for battery and disorderly conduct. She worked ten days in a row and was sitting on her porch with her daughter when the neighbor came down and was yelling and cursing. She told the neighbor to leave and the neighbor verbally attacked her. The neighbor then physically attacked when she approached. All three were arrested due to conflicting stories. She had a couple of beers that night. She has pending criminal charges at this time. She is currently working at a plasma center. ALJ Narwold recommended valid to practice while under review and refer to the Office of the Attorney General for investigation.

133. Deonna Shanks RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports an OWI while in a pontoon boat. She had a few beers, the weather was rough and she attempted to get a boat into a slip. A DNR officer asked if they needed help and she was arrested for OWI motorcraft. Her BAC was 0.14. She reports no other alcohol related issues. She completed six months of non-reporting criminal probation. She works at Anthem and reports no issues at work. ALJ Narwold recommends that the license be renewed free and clear.

134. Kimberly Everly RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a termination from a nursing home. She went into a room where two aides were dressing a resident who was not calm. The resident bit the licensee's finger while administering medications and the licensee tapped her in the mouth. She did not call the patient's family. The patient did not receive the medication. The aides reported the licensee for abuse. She is working currently as a private duty nurse. In 2009, she was terminated after staff reported she had a bad attitude and had yelled at a staff person. ALJ Narwold recommended that the license be valid to practice while being reviewed and refer the matter to the Office of the Attorney General for investigation.

135. Janet Clemens RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a DUI in February 2013. She went to dinner with a friend and consumed drinks. She was texting as she was driving and was pulled over. She had a BAC of .13. She reports no previous issues. She is on non-reporting criminal probation through March 2014. ALJ Narwold recommended that the license be renewed as valid to practice while being reviewed and refer the matter to the Office of the Attorney General for investigation.

136. Corinne Janavich RN Renewal Positive Response CONTINUED

137. Jamie White RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a DUI in Kentucky since her last renewal. Her Kentucky license is active and she has not appeared in front of the Kentucky board. She drank after an incident involving her husband who passed away. She got into the car and was involved in an accident. She is a night supervisor at a nursing home in Kentucky and reports no issues at work. She reports a DUI when she was 21 years old. She no longer drinks alcohol. ALJ Narwold recommended that the license be renewed free and clear.

138. Kimberly Caudill RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports three terminations in the last two years. She was working at a hospital in Warsaw, Indiana in August 2012 after working there about two years. She reports being bullied at work and that she was terminated due to disorganization. She was written up at the hospital for documentation errors, failure to do dressing changes correctly, communication issues re: outpatients. She has had a difficult transition back into long term care. She was terminated at Autumn Ridge after two weeks due to attendance and failure to call in a timely manner due to family issues. She was terminated at Sunshine Home Health in July 2013 after working six weeks due to patients calling and saying she was not conducting visits and the potential for false documentation. ALJ Narwold recommends that the license be valid to practice while being reviewed and refer to the Office of the Attorney General for investigation.

139. Michelle White RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports an OWI in 2011. She was out at a bachelorette party in Indianapolis and drove home approximately an hour north. She does not recall her BAC but it was at least .1. She had underage alcohol issues around the year 2001. She completed criminal probation in July 2012. She is working at IU North at this time. ALJ Narwold recommends renewing the license free and clear.

141. Rebecca Hall RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a termination in this renewal cycle. She had four critical patients that day. She had a patient that was on oxygen that was initially assessed and had to go down for a test. The patient came back and needed portable oxygen. She did not reattach the wall oxygen and the patient passed. The incident happened in August 2012. She is not working as a nurse currently. She worked at Putnamville Correction Center for a year after this and was terminated for write-ups. She was written up for leaving needles on a desk. She was not forthcoming about having a narcotic key when a narcotic went missing. She missed a narcotic count. She was drug tested and did not test positive. ALJ Narwold recommended that the license be renewed as valid to practice while being reviewed and refer to the Office of the Attorney General for investigation.

142. Shelly Schafer RN Renewal Positive Response

The licensee appeared in person and by counsel John Ittenbach regarding her renewal application. She reports discipline against her license in Michigan with a reprimand and a fine. She brought her daughter to work, allowed her to go into a c-section room and witness a procedure, and did not realize this was a HIPPA violation. ALJ Narwold recommended that the license be renewed free and clear.

143. Elizabeth Brown RN Renewal Positive Response

The licensee failed to appear. The matter will be rescheduled one time.

144. Colleen Rood RN Renewal Positive Response

The licensee appeared in person regarding her renewal application. She reports a shoplifting incident in a Walmart store in July 2011. She had recently transitioned jobs from a floor nurse to a desk nurse which resulted in a reduction in salary. She was criminally charged and completed pre-trial diversion. She is not working currently due to ongoing medical issues. She last worked as a nurse in July 2012. ALJ Narwold recommended that the renewal be denied.

145. LaSheryl Williams RN Renewal Positive Response

The licensee appeared in person regarding her renewal application. She reports a criminal charge in May 2013 for neglect of a dependent. She went to stay at a casino with her six month old daughter. She reports leaving her wallet in her desk at work. She left the baby in a hotel room drove her vehicle to retrieve her wallet at a casino entry point. When she returned to her room, there were two employees holding her baby and two police officers came. The baby was left alone for approximately an hour. They questioned her and arrested her. The baby was placed in foster care while the criminal process was completed. The charge was turned into domestic violence for probation. She also holds a license in Illinois. She is on criminal probation at this time. ALJ Narwold recommended renewing the license on indefinite probation for the length of the criminal probation.

146. Julie McFarland RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a malpractice action in this renewal cycle. A malpractice panel found against her specifically regarding overprescribing of opiates for a patient that expired. She prescribed to the patient as his APN. She is currently teaching at Med Tech in the nursing program. ALJ Narwold recommended renewal of the license free and clear.

147. Tanesha Anderson RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a DUI in September 2013. She was at a friend's house, drank alcohol, and drove home. She was pulled over and had a BAC of .13. She has criminal charges pending. ALJ Narwold recommended valid to practice while under review and refer to the Office of the Attorney General for investigation. She is currently working at Avon Health and Rehab.

148. Marta Wroblewski RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a DUI in May 2011 after attending a luncheon where she drank alcohol. She does not recall her BAC but says it was "pretty high". She relapsed and received a second DUI in December 2011. She went out to dinner and drank at that time. She does not recall her BAC with second incident. Prior to that, she reports no issues with alcohol. Her spouse passed away during this time period. She is participating in ISNAP and is in partial compliance with a missed drug screen and three missed reports. She is on criminal probation at this time. ALJ Narwold recommended that the license be renewed on indefinite probation for the length of the ISNAP RMA or the successful completion of all criminal matters, whichever is longer.


149. Judith Adams RN Renewal Positive Response

The licensee appeared regarding her application for renewal. She reports a DUI on October 26, 2013. This was after her renewal was processed. She was at a Halloween party and drank both beer and hard alcohol. She was pulled over after crossing the center line. She does not recall her BAC. Her criminal charges remain pending at this time. She understands she needs to report this on her next renewal. Her employer is conducting random drug screens at this time. She reports prior issues with alcohol approximately twenty years ago. ALJ Narwold recommended valid to practice while being reviewed and refer to the Office of the Attorney General for investigation.

150. Laura McGhee RN Renewal Positive Response


The licensee appeared regarding her application for renewal. She reports an OWI and a termination in this renewal cycle. She received an OWI in December 2012 after a company Christmas party. She ran into a fence and had a BAC of .16. When new management came into her facility she had write-ups for an incident involving a mix-up between a spoon and a syringe. The termination followed the OWI. She is currently on criminal probation. She is currently participating in ISNAP was just extended three months for a positive UDS. ALJ Narwold recommended that the licensee be placed on indefinite probation for the length of the ISNAP RMA.

There being no further business, and having completed its duties, the meeting of the Indiana State Board of Nursing adjourned at 3:50 p.m.
