He delayed in testing because he working for the Veterans Affairs. He was content with what he does there. At the time there was no room for the advancement. Now he realizes he wants to advance but needs to have his license to do that. He also answered yes to number 3. He had a failure to appear. He was charged with residential entry. He went into his wife's house at the time. They were going through a divorce. He went to pick up his dog that he received in the settlement. His wife had put the dog down. The charges against him were dismissed. There were no alcohol or violence involved.

Ms. Cooper recommends that he complete a review course. He must provide predictability documentation showing 95% or greater chance of passing. Once this is received he can test and his license is to be issued free and clear.

- 4. Jennifer Poe RN Exam Positive Response
 - Ms. Poe appeared for her personal appearance regarding her application for licensure. She answered yes to number 3 on the application. On June 8, 2010, she received a DUI. She does not remember what the blood alcohol level was. She was pulled over for speeding. She no longer drinks and does not believe she has a drinking problem. On a separate incident she was at Wal-Mart. She was looking at baby monitors. She sat the monitor on her stroller while tending to her kids. She forgot the monitor was there and the alarm went on when she tried to leave the store. This matter goes to court on June 18th. She graduated in May.
 - Ms. Cooper recommends the following: She is allowed to test. Her license is to be issued on probation. She must have ISNAP evaluation. Her license is to remain on probation for one year of active practice or the length of an RMA (if she meets criteria). She must submit quarterly employer/self reports.
- 5. Steven Mattingly RN Exam Five Failed Attempts
 - Mr. Mattingly appeared for his personal appearance regarding his application for licensure. He has taken the NCLEX 5 times. The last time he took the test was in March 2015. He was taken Kaplan every time before taking the exam. Since March he finished the NCSBN program and done some tutoring with instructors at Ball State. His scores continue to go down with each test.

She became involved with ATI since her last failure. She provided the documents to Ms. Cooper.

Ms. Cooper recommends the following: She is allowed to test and license issued free and clear. This is her last chance to test.

 - Sherry Milner is allowed to take the NCLEX when she is ready to do so. However, before she can become a licensed RN in Indiana she must pay 3 \$250 fines for a total of \$750. She must provide predictability documentation showing 95% or greater chance of passing. Once this is receivedshe can test and his license is to be issued free and clear.

Ms. Paytes appeared for her personal appearance regarding her application for licensure. She graduated in 2011 and has tested 6 times. Since this time she took some remedial classes. 18. Kristen Johnson RN Exam Positive Response

Ms. Johnson appeared for a personal appearance regarding her application for licensure. She had an arrest in 2013. She was charged with an OWI. She had been out with friends. She was pulled over for not using her turn signal. Her blood alcohol level was .11. All her charges got dismissed. She pled guilty to reckless driving. Ms. Cooper and Ms. Smith recommend the following: She is allowed to test. Her license is to be issued on probation for 6 months of active practice with quarterly employer/self reports.

19. Rachael Schrader RN Exam Positive Response

Ms. Schrader appeared for her personal appearance regarding her application for licensure. She had an arrest for trespassing. Her sister in law was hosting a party. They needed some cups so a group of them went to Wal-Mart to get them. They were asked to leave for being too loud. She had not been drinking but others in the group had. Her sister in law got into a situation with the police office at Wal-mart. She was asked to leave and didn't want to leave her sister in law. The matter got out of hand. This happened in September. She is on a deferral agreement.

Ms. Cooper and Ms. Smith recommend the following: She is allowed to test. Her license is to be issued on probation until her criminal matter is completed. She must submit quarterly employer/self reports.

20. Elloweese Freer RN Endo Positive Response

Ms. Freer appeared for her personal appearance regarding her application for licensure. She is licensed in Michigan. 2001 she was cited for trespassing. She went to rescue a dog from a house. That matter was dismissed. Another time she was shopping at Meijer's she was approached by an older couple. The lady started yelling that she hit her with a cart. She did not do this. The police were called. She was falsely charged but pled no contest and was on probation for 90 days.

In 2001, she began to use alcohol to medicate herself. Her employer recognized she had a problem. She went through a treatment program. She was accepted back to work after her treatment program. She had a relapse in 2010. Her current date of sobriety is April 13, 2010. Her Michigan license is not on any type of probation. She has not worked in the US since 2010. She has been going on surgical mission trips.

Ms. Smith and Ms. Cooper recommend the following: Her endorsement is granted and license is to be issued free and clear.

21. Olaniyi Afolayan LPN Exam Five Failed Attempts/ Grad Date of August 2011 Mr. Afolayan appeared for his personal appearance regarding his application for licensure. He graduated in 2011 from a program in California. He has taken the NCLEX 5 times. He has done Kaplan review course. He has been reviewing a Kaplan cd and book

Ms. Cooper and Ms. Smith recommend the following: He complete a review course. He must provide predictability documentation showing 95% or greater chance of passing. Once this is received he can test and his license is to be issued free and clear. He was one chance to test. This must be done in 2015.

22. Byron Arrivilloga RN Exam Positive Response

Mr. Arrivilloga appeared for his personal appearance regarding his application for licensure. He answered yes to number 3 on his application. In 2012, he pled guilty to an OWI. He does not remember his blood alcohol level but he knows it was high. His was his only arrest as an adult. In 2007, he had an alcohol consumption of a minor charge. In 2009, he was cited for consuming alcohol. He does not believe he has a problem with alcohol. He had an assessment after his arrest.

Ms. Cooper and Ms. Smith recommend the following: He is allowed to test. He license is to be issued on probation. He must have an ISNAP evaluation. He must complete 12 CEUs in impaired nursing and 3 in professionalism and ethics. His probation will be for one year of active practice with quarterly employer/self reports or the length of an RMA (if meets criteria) whichever is longer.

23. Sara Messmer RN Exam Positive Response

Ms. Messmer appeared for his personal appearance regarding her application for licensure. In 2012, she had a minor consumption. She was at a party and had a drink. She was 19 at the time. She did a pretrial diversion program. This is the only issue she has had.

Ms. Cooper and Ms. Smith recommend the following: She be allowed to test and her license be issued free and clear.

24. Catherine Vallandingham RN Endo Positive Response

Ms. Vallandingham appeared for her personal appearance regarding her application for licensure. She is licensed in Ohio. She has been convicted of shoplifting and credit card fraud. She was giving a credit card from her brother in law then he reported it stolen. She completed probation. This happened over 30 years ago. The shoplifting charges were a result of her steeling some clothes.

She was terminated for not doing the recommended number of intubations. She states she did do them. This was her only termination.

Ms. Cooper and Ms. Smith recommend the following: Her endorsement is approved and license to be issued free and clear.

26. Cristy Tidwell LPN Exam Positive Response

Ms. Tidwell appeared for her personal appearance regarding her application for licensure. She answered yes to number 3 on her application. She was convicted of welfare fraud. She purchased some food stamps off of a friend. This occurred in 2014. She completed her criminal probation in March of this year.

Ms. Cooper and Ms. Smith recommend the following: She is allowed to test and her license is to be issued free and clear. She must complete 12 CEUs in professionalism/ethics. These must be completed in 2015.

27. Debra Schoenfelder RN Exam Positive Response

Ms. Schoenfelder appeared for her personal appearance. She was arrested in November 2014. She was involved in a domestic dispute with her husband. She was in her bedroom drinking. They had been arguing due to an indiscretion. She was charged with domestic violence and strangulation. She remembers one time grabbing for him. She does not remember grabbing him at all. The memory of the event is hazy due to the amount of alcohol she had consumed. Her blood alcohol was 2.211. She does not believe she has a problem with alcohol. She enrolled herself in a 7 week program and completed it. She has no other issues. The prosecutor declined to file charges.

Ms. Cooper and Ms. Smith recommend the following: She is allowed to test. Her license is to be issued on probation. She must have an ISNAP evaluation. Her license will be on probation for 6 months active practice with quarterly employer/self reports or the length of an RMA(if meets criteria) whichever is longer.

28. Sharon Hancock RN Endo Positive Response CONTINUED

29. Monique Morris RN Exam Seven Failed Attempts/ Grad Date of December 2007 Mrs. Morris appeared for the personal appearance regarding her application for licensure. Her graduation date states 2007 but technically she was finished with school in 2008. She was taken the NCLEX for RN 4 times. This is the first time being in for a personal appearance. She took a review course after she failed before and still did not pass.

Ms. Cooper and Ms. Smith recommend the following: Her application is denied.

30. Victoria Freed RN Exam Positive Response

Ms. Freed appeared for her personal appearance regarding her application for licensure. She graduated in May. She had an arrest for DUI in 2014. She was pulled over for speeding. Her blood alcohol was .12. She took alcohol classes and did an alcohol evaluation. She was not placed on probation. Only time this has happened. Ms. Cooper and Ms. Smith recommend the following: She is allowed to test and her license is to be issued free and clear.

31. Dawn Mead LPN Endo Positive Response

Ms. Mead appeared for personal appearance regarding her application for licensure. She is currently an LPN in Kentucky. In 2013, she had a DUI. She was arrested from her home. This is the only time she has been in trouble. She didn't think about notifying the Kentucky board when this happened. She had to pay some fines to the board. Her license in Kentucky is active with no restrictions.

Ms. Cooper and Ms. Smith recommend the following: The endorsement is granted and license to be issued free and clear.

32. Brady Smith RN Exam Positive Response

Mr. Smith appeared for his personal appearance regarding his application for licensure. He was staying with some friends parents. He went to the grocery store to pick up some groceries. He got distracted and walked out with the cart. He went back in to pay but couldn't because he had left the store. This happened in January 2015. He is finishing a PTI program and has completed community service hours.

Ms. Cooper and Ms. Smith recommend the following: He is allowed to test. He must provide court documents showing the matter is dismissed before he can be issued a license. His license is to be issued free and clear.

33. Michelle Calhoun RN Exam Positive Response

Ms. Calhoun appeared for her personal appearance regarding her application for licensure. She was at Wal-Mart with her son. The son's father showed up. He took the son but gave her money to pay for some shorts. She bought some groceries with the money and shoplifted some other items. She has completed the pretrial diversion program in February 2015.

Ms. Cooper and Ms. Smith recommend the following: She is allowed to test. Her license is to be issued on probation for 6 months active practice with quarterly employer/self reports and 12 CEU hours in professionalism and ethics.

34. Chandra Baker RN Exam Positive Response

Ms. Baker appeared for her personal appearance regarding her application for licensure. She is currently an LPN. She had a 3 strikes you're out situation at work and was terminated. She doesn't remember all the details for the write ups. She tried to get write ups but was unable to get those. She remembers it was 3 separate issues of medication errors. This is her only termination.

Ms. Cooper and Ms. Smith recommend the following: She is allowed to test. Her license is to be issued free and clear. She must complete 6 hours of CEUs in medication administration and 6 hours in documentation. These must be completed in 2015.

35. Taylor Balog RN Exam Positive Response

Mr. Balog appeared for his personal appearance regarding his application for licensure. In July 2014, he had an OWI. His blood alcohol level was .11. He had to serve one year of unsupervised probation. It will be completed in October 2015. This is the only time he has been in trouble.

Ms. Cooper and Ms. Smith recommend the following: He is allow to test. His license is to be issued on probation until his criminal matter is completed. He must submit quarterly employer/self reports.

36. Gretchen Fyock RN Exam Positive Response*

Ms. Fyock appeared for her personal appearance regarding her application for licensure. She answered yes to number 3 on her application. In 2013, she was charged with possession of stolen property. There was material at her home in her basement that she didn't know it was there. It was children's furniture, it was unopened. She doesn't know who ordered it. When this was delivered she didn't accept it. She believes the workers that were at her house did. It was in the basement for about a week. No one had signed for it. Police showed up to look for the stolen property. A credit card was used to pay for the furniture that came to the home and the card had been stolen. The cops took the furniture. She later went to the court house and turned herself in for receiving stolen property with fraud. She was placed on probation. This has been successfully completed. The charges were only filed against her and not her husband. This did not happen while she was in nursing school. She had a background check when going into nursing school but no one from her school talked to her about the matter. Ms. Cooper and Ms. Smith recommend the following: She is allowed to test. Her license is be issued on probation for 6 months of active practice with quarterly employer/self reports and complete 24 hours of CEU in leadership management professionalism. The CEUs must be completed in 2015.

37. Melinda Hart RN Exam Positive Response

Ms. Hart appeared for her personal appearance regarding her application for licensure. She had two previous charges of public intoxication, possession of marijuana, and possession of paraphernalia. She then had an OWI while she was riding a bike, possession of marijuana and possession of paraphernalia. She doesn't believe she has an issue with substance abuse. She has been clean for 8 years with no other trouble. She had grown up around that lifestyle. In 2008, her father died and she decided to turn her life around. She went back to school in

2010 and became a medical assistant. She completed that in 2012. In 2013 she went back to nursing school. She has been working as an ER tech for the past 2 years with no issues. She had a breach of peace in South Carolina. She was arguing with her brother, no alcohol was involved.

Ms. Cooper and Ms. Smith recommend the following: She is allowed to test. Her license is to be issued on probation. She needs to have an ISNAP evaluation. Her license will be on probation for 9 months active practice or the length of the ISNAP RMA (if she meets criteria) whichever is longer. She must provide quarterly employer/self reports and complete 6 hours of CEUs in chemical abuse and 6 hours in ethics.

. Jo DeArmond Exp RN Renewal Did Not Disclose Ms. DeArmond appeared for her personal appearance regarding her application for renewal. She has an expired IL and Indiana license. She was disciplined in IL for defaulting on her student loans. She did not report this matter on her renewal application. She has not practiced nursing since 2013.

Ms. Cooper and Ms. Smith recommend the following: Her application is denied. Once the matter is IL is cleared up she may reapply for renewal.
