**II. ADOPTION OF THE AGENDA**

**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM**

Chuck Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of November 1, 2010, 583 active clients, 29 new intakes, 60 intakes in process, 33 closures in monitoring and 23 new Recovery Monitoring Agreements returned.

Mr. Lindquist addressed the attendees at the Board Meeting at the request of the Board President and described the nature of the ISNAP program, which provides monitoring and assessment / treatment referral services to nurses licensed in Indiana who meet the program's monitoring criteria.

**V. EDUCATION**

**A. University of Indianapolis – Proposal to begin a spring admission for 32 additional students.**

Cheryl Martin appeared on behalf of U of I to speak to the program's proposal to add an additional admission period in the spring for 32 students. A motion was made and seconded to approve the proposal.

**C. Ivy Tech Community College report; vote on Columbus ASN Accreditation**

Representatives from Ivy Tech College reported on measures they have taken system wide to improve the quality of their nursing program. They also reported on the results of their October accreditation visit from NLNAC, which resulted in an extension of the program's national accreditation status. The Board also considered the previously tabled state Board accreditation survey and recommendations. A motion was made and seconded to place the Ivy Tech Columbus' ASN program on a conditional accreditation status with the requirement that the program provide quarterly reports to the Board and that they be revisited to reconsider the accreditation status after one year.

**F. FYI: MedTech College – Fort Wayne: ASN and LPN Program offering evening enrollment options.**

The Board took the matter under consideration.

**G. MedTech College – Indianapolis: Site Visit Report and Recommendations from October 25, 2010 accreditation visit.**

Representatives from MedTech College appeared before the Board regarding the site visit conducted by the Board regarding the Board's survey visit and recommendations on the program's accreditation status. The Board expressed concerns about the program's NCLEX pass rates but acknowledged the difficulty the program would have achieving national accreditation status without full State Board accreditation, and the potential catch-22 the situation presents as the program seeks to improve the quality of its clinical offerings, which are limited due to many organizations' policy of not signing clinical agreements with schools that are not nationally accredited. Following Board discussion, a motion was made and seconded to adopt the recommendation to place the program on a full Board accreditation status.

**VI. DISCUSSION**

**A. Cristina Williams, R.N. License No. 28183505A (expired) – Request to voluntarily surrender**

Ms. Williams submitted a request to the Board to voluntarily surrender her nursing license. The Board precedent in situations where a licensee seeks to surrender licensure to avoid potential disciplinary action against the license is to deny the request to surrender and allow the Attorney General's consumer complaint process to work its way through the process. A motion was made and seconded to deny the request and refer the matter to the AG as a consumer complaint.

**B. Juliann Lowe, LPN Exam Applicant, Personal Appearance**

Ms. Lowe appeared before the Board regarding her application for licensure as an LPN by examination. Ms. Lowe had previously applied and was inadvertently issued a license prior to testing. The Board became aware of the error and discovered that Ms. Lowe had been practicing on the license obtained in error. A motion was made and seconded to permit her to test and to bring her in upon passing the NCLEX to consider how to issue the license.

**VII. BOARD DIRECTOR REPORT**

Mr. Gorman reported to the Board on the final numbers from the LPN renewal cycle that ended October 31, 2010. 25,168 LPNs renewed their licenses during this cycle. Currently, there are approximately 94,000 actively licensed RNs in the state of Indiana. Mr. Gorman expects that there will be 100,000 RNs by the next RN renewal cycle.

Mr. Gorman also reported the status of the recent changes in the Attorney General's office with respect to the Consumer Protection Division. The Board discussed concerns about the consumer complaint process in terms of the amount of information presented to Board designees regarding the results of their investigation. Mr. Burghduff expressed concern that the information was not sufficient to make an informed decision on whether or not to request formal charges be issued against licensees. Mr. Burghduff also expressed concern that many of the matters presented to the Board as part of formal actions or in the informal Board summaries. The Board requested that Mr. Gorman contact Gabrielle Owens to request her appearance on behalf of the Attorney General's office to discuss the Board's concerns.

**VIII. PERSONAL APPEARANCES**

**In the Matter of the License of: John Murray, R. N., License No. 28150136A**



Re: Request to Withdraw Probation


