**V. INDIANA STATE NURSES ASSISTANCE PROGRAM**

Chuck Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of October 1, 2010, 593 active clients, 15 new intakes, 70 intakes in process, 12 closures in monitoring and 27 new Recovery Monitoring Agreements returned. Mr. Lindquist summarized the substance of the September 17, 2010 Fall Workshop.

Mr. Lindquist addressed the attendees at the Board Meeting at the request of the Board President and described the nature of the ISNAP program, which provides monitoring and assessment / treatment referral services to nurses licensed in Indiana who meet the program's monitoring criteria.

## **VII. BOARD DIRECTOR REPORT**

Mr. Gorman addressed the Board and informed them of a recent reorganization of the Consumer Protection Division in the Attorney General's Office. Deputy Attorney General Gabrielle Owens is now over the entire CPD in charge of investigating and bringing new complaints and generally representing the State in matters before the Board. Deputy Attorney General Patricia Gibson will conduct all ALJ hearings, and Deputy Attorney Generals Laura Wilford, Elizabeth Kiefner Crawford, and David Fleishhacker will be assigned to handle nursing board cases full-time.

Mr. Gorman also updated the Board as to the status of criminal background check legislation that is being discussed for proposal in the upcoming legislative assembly. The current proposal being discussed would require comprehensive background checks for all new applicants at the time of initial licensure, and at the applicant's expense. There would be potentially be a random audit mechanism for renewal applicants at the Board's discretion, and there would be a reporting mechanism installed that would require Indiana prosecutors to notify appropriate Boards of any new criminal charges issued against individuals with existing licenses. The background check requirement would apply to all health-related occupations requiring license or registration and administered by the Indiana Professional Licensing Agency.




2. Michael Long
