**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM**

Chuck Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of September 1, 2010, 578 active clients, 17 new intakes, 66 intakes in process, 39 closures in monitoring and 27 new Recovery Monitoring Agreements returned. Mr. Lindquist highlighted the schedule for ISNAP's fall workshop "Unbecoming a Nurse – Bypassing the Hidden Chemical Dependency Trap" set to take place on September 17, 2010.

Mr. Lindquist addressed the attendees at the Board Meeting at the request of the Board President and described the nature of the ISNAP program, which provides monitoring and assessment / treatment referral services to nurses licensed in Indiana who meet the program's monitoring criteria.

**V. PHARMACY BOARD DIRECTOR PHIL WICKIZER: INSPECT PROGRAM: Person of Interest Reports**

Phil Wickizer, Director of the Indiana Board of Pharmacy, presented to the Board the plans to generate Person of Interest Alerts from information gleaned from the INSPECT database. The INSPECT program is working with representatives from professions with prescriptive authorization and experience on developing prescriptive thresholds that would trigger instant notifications to prescribers regarding patients that are filling controlled substance prescriptions beyond yet to be established thresholds. Preliminary reports of individuals filling prescriptions from multiple sources in amounts considered to be well above any therapeutic threshold have already been run and have highlighted the need for this service.

**VII. BOARD DIRECTOR REPORT**

Mr. Gorman reported that legislation is being drafted that will be proposed in the coming general assembly and which will require criminal background checks for new licensees. While renewal applicants will not likely be required to submit to criminal background checks as a routine condition of renewal, other options to check existing licensees are still being considered. Mr. Gorman reminded the Board that it has the authority to issue fines of up to \$1000 for a finding of renewal fraud, and that the suggestion was made that the Board consider increasing its historical \$250 sanction for renewal fraud to further encourage individuals renewing to honestly disclose situations regarding criminal background.

Mr. Gorman informed the Board that Mr. Johns plans to resume regular Board Meeting attendance and participation in Board activities following an absence due to personal issues.


