II. ADOPTION OF THE AGENDA

III. ADOPTION OF THE MINUTES FROM THE SEPTEMBER 19 2013 MEETING OF THE BOARD

A motion was made and seconded to adopt the minutes from the August 2013 board meeting. Burghduff/Presley, 5-3-0, motion carries. A motion was made and seconded to adopt the minutes from the September 2013 board meeting.

IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Mr. Lindquist reported the following:

- The third quarterly report for 2013 indicates that 76% of participants were fully compliant and 16% were only missing 1 report or UDS. Only 8% of participants are in significant non-compliance with contract extension, OTSC or file closure.
- ISNAP has revised their policy so that when they close files with nurses with active licenses they will allow nurses to be monitored before they come before the BON.
- ISNAP was recently awarded the Impaired Nursing contract for the next two years.

V. EDUCATION

A. FYI Only- Ivy Tech, Bloomington ASN and PN Programs will be moving from 200 Daniels Way, Bloomington, Indiana 47404 to 101 Daniels Way, Bloomington, Indiana 47404 effective Fall 2014.

This matter will require a site visit in the future.

B. J. Everett Light Career Center- Notice of closure of PN Program effective December 31, 2014 (Karen Strandjord/Shawn Wright-Browner)

Staff appeared from J. Everett Light Career Center. They have made a decision to close their program in relation to federal dollars. They are in compliance with all federal mandates and all ACEN requirements. They currently have 52 students enrolled. They are not planning to admit any additional students as of Fall 2013. The plan if they are unsuccessful with Boards is that students will go to Medtech for career pathways. **Board Action: A motion was made and seconded to accept their plan. McIntosh/Laux, 7-0-0, motion carries**

F. Ancilla College- Request for reinstatement to full accreditation and request for change in PN to RN Bridge Program curriculum (Ann Fitzgerald)

Staff appeared from Ancilla College regarding reinstatement to full accreditation. Their pass rate for 2012 was 93%. They were placed on conditional accreditation in April 2012. **Board Action: A motion was made and seconded to remove the conditional accreditation. Narwold/Laux, 7-0-0, motion carries**

Staff also indicated that their LPN to RN bridge program requires a change in curriculum to match the LPN to RN bridge program with their ASN curriculum. **Board Action: A motion was made and seconded to accept the curriculum change. McIntosh/Laux, 7-0-0, motion carries**

G. FYI Only- Ivy Tech Lafayette All Programs- Notification of retirement of Karen Dolk, Dean effective 5/31/14.

H. Purdue Calumet- BSN and ASN to BSN Programs- Request for exemption of concurrent clinical and didactic courses (Kathy Nix)

Kathy Nix appeared on behalf of Purdue University Calumet. The school is requesting an exemption for one course in their community health nursing class. The faculty attempted to rearrange the plan of study so that students were not overloaded. Faculty determined the best option would be to move the community health lecture to summer and proceed into clinical three weeks later. This change involves senior nursing students only with the same faculty through both the clinical and didactic courses. Ms. Laux asked whether students usually go to summer classes and Ms. Nix indicated that accelerated students attend school in the summer. This would not require an additional tuition payment. Presently, the course is in the same semester for both components. Ms. Hall asked how the grading is done if the course is bifurcated. Ms. Nix indicated there are two separate three hour courses with two separate grades. **Board Action: A motion was made and seconded to deny the request for exemption. McIntosh/Hall, 7-0-0, motion carries**

I. Kaplan College- Request for consolidation of campuses/site visit (Natalie Hall)

Staff appeared from Kaplan College. Ms. Hall presented the information for the site visit. The site visit was based on a request to consolidate from the northeast Indianapolis campus to southeast Indianapolis. Concerns were noted for the faculty turnover and the turnover in the faculty chair position. Students voiced concerns about confidentiality with faculty serving in dual roles as both instructor and clinical advisor. There is no student services department in existence. Faculty presented a response. **Board Action: A motion was made and seconded to allow for consolidation to the southeast Indianapolis campus. Laux/Narwold, 7-0-0, motion carries**

VI. DISCUSSION

A. LSA Document #13-284, Readoption of Rules

Readopts rules in anticipation of IC 4-22-2.5-2, providing that an administrative rule adopted under IC 4-22-2 expires January 1 of the seventh year after the year in which the rule takes effect unless the rule contains an earlier expiration date. Effective 30 days after filing with the Publisher.

A. Appearances by Applicants for Licensure

1. Becky Astalas LPN Endorsement CBC Hit/Positive Response

Ms. Astalas appeared for her personal appearance regarding her application for licensure. She received a DWI in January 2013. She had taken some prescription medication before leaving work and fell asleep while driving. She was arrested. She has not been convicted yet and nothing has been filed. She failed to disclose her Texas discipline on her application. She is allowed to endorse on probation until resolution of her criminal matter in Texas.

2. Saliu Oladokun RN Exam Failed 3 Times/Graduated 2010

Ms. Okadokun appeared for her personal appearance regarding her application for licensure. She graduated nursing school in 2010. She has taken the NCLEX 5 times. The last time she took the test was in April. She has taken a review course and did receive the 95% predictability for passing. She is allowed to test and her license is to be issued free and clear.

3. Michelle Murray RN Exam CBC Hit/Positive Response

Ms. Murray appeared for her personal appearance regarding her application for licensure. In 2011, she received a DWI. She was out with friends and was pulled over because a head light was out. She believes her blood alcohol level was .13 but she was not sure. She had a minor consumption charge when she was 16. She is allowed to test. Her license is to be issued on probation for 6 months of active nursing practice with quarterly reports.

4. Louisa Brown RN Endorsement Positive Response

Ms. Brown appeared for her personal appearance regarding her application for licensure. She has a Kentucky license that is active. She has been in the KARE program since 2011 and is in full compliance. She went to the KARE program for diverting from her place of employment. She is allowed to endorse free and clear.

5. Raquel Fletcher LPN Endorsement CBC Hit /Positive Response

Ms. Fletcher appeared for her personal appearance regarding her application for licensure. In 2004, she received a DUI. She had been out with her husband and drove home. In 2006, she was charged with resisting law enforcement. No alcohol was involved with this arrest. There was also a charge of criminal mischief but that was not her and was thrown out due to mistaken identity. She also had a charge of possession of a handgun. This charge was dismissed. The handgun belonged to her friend. She is allowed to endorse. Her license is to be issued on probation for 6 months active practice with quarterly reports. She needs to submit self reports if she is not employed.

6. Mark Stok LPN Exam CBC Hit/Positive Response

Mr. Stok appeared for his personal appearance regarding his application for licensure. He had 2 public intoxication charges as a minor. Three years ago he had 2 OWIs within 9 months of each other. He currently works at Community Hospital. He is allowed to test. His license is to be issued on probation for either the length of an RMA, if he meets criteria, or one year

of active practice within the healthcare profession, whichever is longer. He needs to submit quarterly reports while employed and self reports if not employed.

7. Maryanna Sinenko RN Exam Graduated 2009

Ms. Sinenko did not appear for her personal appearance regarding her application for licensure. This matter is to be rescheduled one time.

8. Destiney Nehring RN Exam Failed 4 times

Ms. Nehring appeared for her personal appearance regarding her application for licensure. She completed an ATI review after she tested in August. She completed Kaplan after graduation. She is now seeing a therapist. She needs to keep working with her therapist on the anxiety then come back. Her request is denied at this time.

9. Ryan Hollis APN/CSR Did Not Disclose

Mr. Hollis appeared for his personal appearance regarding his application for licensure. In 2009, he received an OWI after leaving a party. His blood alcohol level was .11. He did not disclose this on his initial application or his 2011 RN renewal. He stated he didn't think it was on his record and thought it was taken care of through the court. His application for APN/CSR is granted. He will have to have another PA for his RN renewal.

10. Ashante Hernandez RN Exam CBC Hit/ Positive Response

Ms. Hernandez did not appear for her personal appearance. This matter is to be rescheduled one time.

11. Lindsay Wefel RN Exam CBC Hit/ Positive Response

In 2012, she was pulled over for speeding. Her license was suspended due to no insurance. In November 2012, she was arrested for check fraud on a check she had written in 2011. She has completed her probation and her driver's license is current. She is allowed to test and license to be issued free and clear.

B. Appearances by Applicants for Renewal

1. Heather Hazen RN Renewal Positive Response CONTINUED

2. Jeremy Hagen RN Renewal Positive Response

Mr. Hagen appeared for his personal appearance regarding his application for renewal. In June 2013, he received an OWI. His blood alcohol level was .15. He pled guilty and is currently on criminal probation. He is working with ISNAP and has entered into an 18 month RMA. His license is to be renewed on probation for the length of his criminal probation.

3. Melissa Chamberlin RN Renewal Positive Response

Ms. Chamberlin appeared for her personal appearance regarding her application for renewal. She had 3 separate discipline issues at work within a year. The 1st discipline was due to too much overtime. The 2nd one was due to not carrying out orders with the required amount of time per hospital policy. She also had started a medication and asked someone else to finish it. The third was due to shutting off the wrong medication pump while dealing with a hostile family member. She needs to do 18 hours of Continuing Education, 6 each in the following areas: medication administration; professionalism; and patient safety. Once these are received, her license can be renewed free and clear.

4. Norma Winger RN Renewal Positive Response

Ms. Winger appeared for her personal appearance regarding her application for renewal. She received discipline at work twice last year for not completing duties. Once she passed on information for night shift to complete report. The second time a patient had a sore. She placed this on skin condition report and was told she should have called for treatment. This year she was disciplined for forgetting to administer medication with applesauce and not completing duties. She has been employed in the same setting for 13 years. She was terminated in 2009 but returned to the same employer. She needs to complete 18 hours of continuing education, 6 hours in each of the following areas: assessment; professionalism; and documentation. Once these are completed, the license can be renewed free and clear.

5. Stephanie Collins RN Renewal Positive Response

Ms. Collins appeared for her personal appearance regarding her application for licensure. On October 31, 2012, she was arrested for family violence. There had been some family transition issues and discipline issues with her 11 year old son. She arrived home from work five to ten minutes before police showed up. She drew her hands to hit her son and the police officer grabbed her and she was arrested. She had to complete parenting classes. She started the steps of having her son go to juvenile but stopped. The case is in Georgia. She answered question number 6 in error. She needs to send in a statement regarding that. Once the statement is received, her license can be renewed free and clear.

6. Luke McKinney RN Renewal Positive Response

Mr. McKinney appeared for his personal appearance regarding his application for renewal. He was placed on 90 days probation by employer. He had been sick but not bad enough to call in. He felt dehydrated and gave himself a bag of saline through an IV. He did go to the doctor and was placed on probation. A few days later he did inform his manger what he did. He has fulfilled that probation and was not terminated. He indicates that someone else started the IV for him. A motion was made and seconded to renew the license free and clear after he has completed CEUs in the following areas: 12in medication administration and 12 hours in ethics. Burghduff/Narwold, 5-0-1, motion carries

7. Beverly Mauger RN/APN Renewal Failure to Renew Herself

Ms. Mauger appeared for her personal appearance regarding her application for renewal. Her renewal was completed by someone else. That person transmitted information backwards from what the licensee had given her. The matter is to be referred to the Attorney General's office. Her license status is to be Valid to Practice While Being Reviewed pending the outcome of the OAG investigation for renewal fraud.

8. Tina Galley RN Renewal Positive Response

Ms. Galley appeared for her personal appearance regarding her application for renewal. She was terminated from employment. She was doing rounds every two hours. She had checked on patient and everything was ok. At 9:30 when she checked on the patient, the patient was deceased. She had worked at the facility since July 2008. She has not had any prior issues. She is allowed to renew free and clear.

9. Sara Ramsey-Gunter RN Renewal Positive Response

Ms. Ramsey-Gunter appeared for her personal appearance regarding her application for renewal. In July 2012, she was attending a reception of a co-worker. She had been drinking and was pulled over. Her blood alcohol level was .18. This was her first arrest. She completed criminal probation. She is already in ISNAP and in full compliance. She is allowed to renew on probation for the duration of her RMA.

10. Brittany Haynes RN Renewal Positive Response

Ms. Haynes appeared for her personal appearance regarding her application for renewal. She was terminated from Riley after six and a half years. She received a heart transplant patient. This type of patient care was not common for her department. She tried to give care as instructed but couldn't follow through. She was trying to draw methadone from syringe but it dripped everywhere. She needs to complete 6 hours of continuing education in medication administration and 3 hours in infection control. She can be renewed free and clear once these are received.

11. Rhonda King RN Renewal Positive Response

Ms. King appeared for her personal appearance regarding her application for renewal. She was terminated from her employment. A staff member said she wasn't happy that a patient was sleeping; made medication errors; and didn't give treatment when she was told to. She needs to complete 18 hours of continuing education, 6 hours each in the following areas: assessment; professionalism; and medication administration. Once these are received, the license can be renewed free and clear.

12. Maria Held RN Renewal Positive Response

Ms. Held appeared for her personal appearance regarding her application for renewal. She was arrested in August 2012 for an OWI and battery by bodily waste. She was out with friends drinking. She was driving and had an accident. Her blood alcohol level was .20. She only had a medium margarita and believes she blacked out. She is on 2 years criminal probation. She completed the KARE program, paid fines, and counseling. She is to be renewed on probation. She needs to contact ISNAP, complete the terms of her criminal probation, send quarterly reports, and complete 12 hours of continuing education in professionalism/ethics and 6 in impaired nursing.

13. Erin Walters RN Renewal Positive Response

Ms. Walters appeared for her personal appearance regarding her application for renewal. She received discipline at work. Hospital policy was to take a computer into rooms when giving medications. There were not any computers available so she went ahead and gave the medication. She ended up giving the wrong dose. She was disciplined for not taking the computer into the room. She has been with the employer for 13 years. She has had prior disciplines for tardiness. She needs to complete 12 hours of continuing education in professionalism/ethics and 6 in medication administration. Once these are received, her license can be renewed free and clear.

14. Danielle Jackson RN Renewal Positive Response

Ms. Jackson appeared for her personal appearance regarding her application for renewal. In December 2011 she was pulled over for speeding. She had been drinking. She has no priors. She is allowed to renew free and clear.

15. Erin Burkeybyle RN Renewal Positive Response

Ms. Burkeybyle appeared with her counsel regarding her positive response. She reports a disciplinary issue for tardies at work. She had seven incidents in 2012. The second incident she was summonsed to report to court for felony battery count against a minor resulting in bodily injury. There was an incident between herself and her minor son and she hit him with a belt. The minor son hit his head on a door casing during the incident. The next day the minor son had a stomachache and was vomiting and was kept home from school. The minor son indicated that the belt buckle hit him in the head. The minor son is in counseling. She has criminal charges pending at this time. There is another pre-trial conference scheduled in the near future. The licensee has also started personal counseling at this time for personal issues and anger management. **Board Action: A motion was made and seconded to refer the matter to the Office of the Attorney General and keep the license as valid to practice pending review. 11. Ryan Morris RN Renewal Positive Response

The licensee appeared regarding his RN renewal. He reports a public intoxication in January 2013. He is on criminal probation for one year. ALJ Hall recommended referral to ISNAP for evaluation, renewal of the license on probation for the length of criminal probation. The licensee must provide quarterly employer reports.

12. Michael Allen Burrows RN Renewal Positive Response* CONTINUED

13. Bryn Sue Hardy RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reports an OWI in this renewal cycle and a DUI in 2007. She is enrolled in a 18 month RMA with ISNAP and is on probation at work. ALJ Hall recommended that she be renewed free and clear.

14. Patricia Cranford RN Renewal Positive Response*

The licensee failed to appear. ALJ Hall recommended denial of the renewal.

15. Rebecca L Geib RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported a DUI in 2011 with a BAC of .19. She successfully completed criminal probation and has had no other arrests. ALJ Hall recommended that the license be placed on probation for six months of active nursing practice with quarterly employer reports.

16. Michael Schlebecker RN Renewal Positive Response

The licensee appeared regarding his RN renewal application. He reported a 2011 arrest for domestic battery but formal charges were not filed. ALJ Hall's recommendation is to renew the license free and clear.

17. John A. Keller RN Renewal Positive Response

The licensee appeared regarding his RN renewal application. He reported a 2011 DUI with a BAC of .126. He is on criminal probation for two years, ending in December 2013. He also reported the matter to the Kentucky Board of Nursing. ALJ Hall recommended an ISNAP evaluation with the license to be renewed free and clear.

18. Jinnyi Clements RN Renewal Positive Response

The licensee appeared regarding her RN renewal application. She reported a DUI in December 2011 with a BAC of .13. She is on criminal probation for two years, ending in December 2013. She reports no other offenses. ALJ Hall recommended an ISNAP evaluation with the license to be renewed free and clear.

19. Trudie Pyle RN Renewal Positive Response

The licensee failed to appear. The matter will be rescheduled one time.

20. Tammy McCarty RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported an OWI with a BAC of .138 which occurred in August 2013. Her criminal charges are pending. ALJ Hall recommended referral to ISNAP, renewal on probation with six months active nursing practice, and quarterly employer reports.

21. Rochelle Owens RN Renewal Positive Response

Ms. Owens appeared for her personal appearance regarding her application for renewal. She received a DUI in 2012. She was at a political party, had a few drinks, and drove home. Her blood alcohol was .14. Her court date is set for November 25, 2013. She has not had any other issues. She needs to have an ISNAP evaluation. Her license is to be renewed on probation for six months active practice, quarterly reports. If she meets criteria for an RMA she must have full, complete, and continuous compliance.

22. Jacquelyn Kimes RN Renewal Positive Response

Ms. Kimes appeared for her personal appearance regarding her application for renewal. On May 13, 2013, her employer did a random drug screen. She tested positive for marijuana. She self reported herself to ISNAP. She has entered into an 18 month RMA. She has not had any other issues. Her license is to be renewed free and clear.

23. Amanda L Hardin RN Renewal Positive Response

Ms. Hardin appeared for her personal appearance regarding her application for renewal. In February 2012, she had a DUI. She left a restaurant and hit another car. She is not on probation. She completed seven days home detention. She needs to have an ISNAP evaluation. If she meets criteria then her license will be renewed on 6 months probation. If she does not meet criteria her license will be issued free and clear.

24. Verda Keel RN Renewal Positive Response

Ms. Keel appeared for her personal appearance regarding her application for renewal. In November 2012, she got into a verbal argument with the housekeeper. This argument was not in front of patients. She was written up for harassment for this. In February 2013, she was taking care of a patient who just came out of surgery. They were in the recovery room area. The patient was coughing. She gave the patient a tissue and asked her to cover her mouth. A co-worker reported to management that was had been rude to the patient. She was told it was inappropriate to ask the patient to cover her mouth. In June 2013, she was taking care of a patient. She knew the family and had been joking around with them. The co-worker reported this to management. She was terminated. She had worked at the same place of employment for 22 years.

25. Amanda Turich RN Renewal Positive Response

Ms. Turich appeared for her personal appearance regarding her application for renewal. In March 2012, she had an OWI that was pled down to reckless driving. Her blood alcohol was .16. She is on criminal probation until June 2014. She needs to have an ISNAP evaluation. Her license is to be renewed on probation for the length of her criminal probation with quarterly reports.

26. Amy Becker RN Renewal Positive Response

Ms. Becker appeared for her personal appearance regarding her application for renewal. She was terminated for making 6 immunization errors within a year. She believes it happened because she was going through a divorce and was living in the same house as her husband; she had to place her mother in a nursing home; and she was battling depression. She does not have an alcohol related issues. No one was hurt as a result of the errors. She is not currently working. Her license is to be renewed free and clear.

27. Amy Nethery RN Renewal Positive Response

Ms. Nethery appeared for her personal appearance regarding her application for renewal. In January 2012, she was at a party. After she left, she pulled over to the side of the road and fell asleep. The police stopped. Her blood alcohol level was .22. She pled guilty to public intoxication. She completed a year of probation. She has not had any other issues. She needs to have an ISNAP evaluation. Her license is to be renewed free and clear.

28. Rebecca Herrmann RN Renewal Positive Response

Ms. Herrmann appeared for her personal appearance regarding her application for renewal. She self enrolled in ISNAP in March of 2012. She had two major surgeries. After these surgeries she became addicted to opiates. She was in significant non-compliance for the first quarter. She had one positive drug screen. Her RMA is for two years. Her license is to be renewed free and clear.

29. Thomas Skeen RN Renewal Positive Response

Mr. Skeen appeared for his personal appearance regarding his application for renewal. He had a malpractice settlement. The issue happened in 2006 and the settlement was reached in 2012. He was ordered to pay restitution. The patient involved passed away. His role in the matter was that he gave the patient anesthesia He has not had any other issues. His license is to be renewed free and clear.

30. Andrea Lowden RN Renewal Positive Response

Ms. Lowden appeared for her personal appearance regarding her application for renewal. In 2011, she received a DUI. When she was pulled over her blood alcohol level was .23. In February 2013, she received another DUI. She self reported to ISNAP in January 2013. She did three months of jail time and three months of work release. She was terminated from her job because of this. She is in a three year RMA and has had a full year of compliance. She had not had a drink since 2012. Her license is to be renewed free and clear.

31. Kelly Grimm RN Renewal Positive Response

Ms. Grimm appeared for her personal appearance regarding her renewal. In 2012, she renewed her license. She was audited and didn't have the correct amount of continuing education units. They told her that she could pay a fine. She did not have the money to pay a fine so she surrendered her license. Her license in Washington was reprimanded based on the Alaska issue. Her license is to be renewed free and clear.

32. Rita Kress RN Renewal Positive Response

Ms. Kress appeared for her personal appearance regarding her application for renewal. She received her license in 2012. The first place she was hired let her go after a week because she was not fast enough. In August 2012, she was hired on at an elementary school. After 3 months she was asked to resign. She believes she was on her own too much. In January 2013, she was working at a nursing home. She was terminated in August for having three medication errors. She currently works one day a week taking care of an elderly patient. She went to school at IUPUI. Her license is to be renewed on probation for six months active practice with quarterly reports.

33. Lori Levi RN Renewal Positive Response

Ms. Levi appeared for her personal appearance regarding her application for renewal. She had been having issues with a previous neighbor. After a night of drinking she went over to that neighbor's house and started pulling her flowers. The police were called. She was charged with public intoxication. She is currently on probation until February 2014. She needs

to have an ISNAP evaluation. Her license is to be renewed on probation until her criminal probation has ended. She must submit quarterly reports.

34. Stacy Lindsey RN Renewal Positive Response CONTINUED

35. Wayne Stoll RN Renewal Positive Response

Mr. Stoll appeared for his personal appearance regarding his application for renewal. He had a termination in June 2012. A patient fell down some stairs and had a head injury. He was taking care of him. He initiated a procedure and wrote the order for it. He tried to page the doctor. Later in the morning the doctor did sign the order. At shift change the patient had to be re-intubated (sp). Four of five days later the patient's family made him a patient of hope. He was terminated. The only other termination he had was at a job that he did not make it through the probationary period. His license is to be renewed free and clear.

36. Susan Overcash RN Renewal Positive Response

Ms. Overcash appeared for her personal appearance regarding her application for renewal. In February 2013, she had an OWI. She had been out, had too drink, got lost, and was driving the wrong way down the street. She spent three days in jail. He is currently on criminal probation until February 2014. She needs to have an ISNAP evaluation. Her license is to be renewed on probation until her criminal probation. She must submit quarterly reports.

37. Brandy Stinson RN/APN Renewal Positive Response

Ms. Stinson appeared for her personal appearance regarding her application for renewal. She received a DUI. She was going through a breakup. She was drinking and drove home. She hit an electric pole then drove home. Her blood alcohol level was .118. She was not placed on criminal probation. She lost her license for 30 days and took an alcohol class. In 1996 or 1997, she was driving on a suspended license. She needs to have an ISNAP evaluation. Both her RN and APN license are to be renewed free and clear.

38. Paula Wright RN Renewal Positive Response

Ms. Wright appeared for her personal appearance regarding her application for renewal. She had received a shoplifting charge. She was very sick and emotional at the time. She went to the store and had placed her items in a shopping bag and just threw it over her shoulder. She was in a daze that day. Her job is aware of the situation. There have been no other issues. Her license is to be renewed free and clear.

39. Marlene R Tolbert RN Renewal Positive Response

Ms. Tolbert appeared for her personal appearance regarding her application for renewal. In 2012, she received an OWI. She was out with friends and drove home. She pulled over to the side of the road because her friend was getting sick. A police officer pulled up to see if they were ok. Her blood alcohol level was .15. She had a year of criminal probation which she successfully completed. She has not had any other issues. She needs to have an ISNAP evaluation. Her license is to be renewed free and clear.

40. Heather Hanks RN Renewal Positive Response

Ms. Hanks appeared for her personal appearance regarding her application for renewal. In July 2012, she received a DUI. She was living in Texas and not working as a nurse. In April 2013 she pled no contest. She is on probation until August 2014. Her blood alcohol level was .186. Her current employer is aware of the issue. She needs to have an ISNAP evaluation. Her license is to be renewed on probation the length of her criminal probation. She must submit quarterly reports.

41. Cindy Lou Hancock RN Renewal Positive Response CONTINUED

42. Zofia Pachacz RN Renewal Positive Response

The licensee appeared regarding an application for RN renewal. She reported that she had three incidents within a 12 month period and was terminated. She was on-call on the first incident and failed to have a written agreement between the parties. In the second incident, she was on-call and failed to respond within 30 minutes. The third incident involved a

miscount of sponges in a laproscopic procedure, the sponge was left in the patient and the patient had to return for retrieval. She is not currently working. ALJ Narwold's recommendation is to renew the license free and clear.

43. Kristy Walsh RN Renewal Inconclusive MMPI-II Results

The licensee appeared regarding an application for RN renewal. She previously appeared in 2010 and was requested to obtain an MMPI. She is not currently working. She submitted an MMPI-II which contains inconclusive results. ALJ Narwold recommended that she obtain the additional evaluation suggested in the MMPI-II and denied the renewal. She may apply for renewal again once she has further evaluation that shows she is safe to practice as a nurse.

44. Stellamaris Obaseki RN Renewal Positive Response

An email was received from this individual today stating she would not appear. ALJ Narwold recommended denial of the renewal.

45. Margaret Dossett RN Renewal Positive Response

The licensee appeared regarding an application for RN renewal. She reported approximately three years ago she was a nursing home administrator in a hospital-based unit. During the ISDH survey, an I/J tag was given at that time. She did not review her HFA license, but she has been working under her RN license. She agreed to revocation of her HFA license in March 2013. She reports no discipline on her RN license. She currently works at St. Mary's Medical Center in Evansville as an RN case manager. She reports no problems in her current position. ALJ Narwold recommended renewal of the license free and clear.

46. Sheryl Miles RN Renewal Positive Response

The licensee appeared regarding an application for RN renewal. She reported that eight months ago she was written up because she failed to call a patient back. The patient suffered no ill results as a result of the failure. She reports no other issues in the workplace and still works there. ALJ Narwold recommended renewal of the license free and clear.

47. Coleen Brown RN Renewal Positive Response

The licensee appeared regarding an application for RN renewal with counsel Cynthia Marcus. She reported an OWI in October 2011 and successfully criminal probation in March 2013. She has contacted ISNAP and had an evaluation. She was not a candidate for ISNAP. ALJ Narwold recommended renewal of the license free and clear.

48. Donna Craig RN Renewal Positive Response

The licensee appeared regarding an application for RN renewal. She reported that she was setting up a pump for an overnight feeding which was an older style model. She had to turn it up to prime the pump and failed to turn it back down. The patient received 875 mL of feeding vs. 275 mL. The patient suffered no ill effects; however, the licensee was terminated. ALJ Narwold recommended renewal of the license free and clear.

49. Roberta Miller RN Renewal Failure to provide requested documentation

The licensee failed to appear in person or by counsel for her appearance. ALJ Narwold's recommendation is to deny.

50. Sherri Fugit RN Renewal Failure to submit self reports

The licensee appeared regarding her RN renewal with counsel Julie Miller. Self reports from her 2011 renewal cycle were not received in a timely basis. She has been working since February 2013 at Express Scripts pharmacy as a patient counselor. ALJ Narwold's recommendation is to renew the license free and clear.

51. Mary Rummel RN Renewal Positive Response

The licensee appeared regarding her RN renewal with counsel Elliott Pinkie. She reported pending malpractice litigation in a case involving fetal demise when she was working as a nurse practitioner. She has been named as a party but they are seating the panel at this point. ALJ Narwold's recommendation is to renew the license free and clear.

52. Star Michael Oliver RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported receiving an OWI in February 2013. She hit a parked car and left the scene of the accident. She was texting at the time. She does not recall her BAC. She provided documentation

of successful completion of criminal probation as of September 2013. She also had a minor consumption issue in the past. ALJ Narwold's recommendation is to renew the license free and clear.

53. Emily Jean Botich RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported receiving an OWI in March 2013. Her BAC was 0.11. She is currently on criminal probation through June 2014. She received an evaluation from ISNAP and is in an RMA until June 2014. ALJ Narwold's recommendation is to renew the license on probation for the length of the ISNAP RMA or successful completion of the criminal probation, whichever is longer. She agreed to the probationary status.

54. Krystal L. Embrey RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported being pulled over for speeding, while doing 55 in a 35 mph zone. She had been drinking and her BAC was .079. She has a misdemeanor on her record now for reckless driving. ALJ Narwold recommends renewing the license free and clear.

55. Kasey Bergman RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported receiving an OWI in April 2012. Her BAC was .16. She was on criminal probation for one year until July 2013. She provided documentation of successful completion of criminal probation. She reports a minor consumption in 2001. ALJ Narwold's recommendation is to renew free and clear.

56. Margaret Mews RN Renewal Positive Response*

The licensee appeared regarding her RN renewal. She reported a reprimand for a medication error. She was passing medications and she mixed up heparin with insulin and gave a patient the wrong medication. There were no ill effects on the patient. She does not work at the facility any longer as she is a stay at home mom at this time. ALJ Narwold recommends renewing the license free and clear.

57. Katie M. Fletcher RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported receiving an OWI in 2011. Her BAC was .09. She reports that she completed a year of criminal probation. She had a prior public intoxication conviction in 2008. Her BAC was .19. ALJ Narwold recommends a probationary license for the length of the ISNAP RMA, or if she does not meet ISNAP criteria, she may apply for withdrawal immediately. She agreed to the probationary status.

58. Candice Cutrer RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported an OWI in June 2013 which was pled down to reckless driving. She reported taking a shot of Jagermeister. Her BAC was .10. She is in a diversion program at this time until January 2014. ALJ Narwold recommended that the license be renewed on probation for the length of the successful completion of the diversion program. She agreed to the probationary status.

59. Cynthia Bush Davis RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported a job termination in April 2013. She has a drug dependence issue. She is currently in an ISNAP RMA and is fully compliant. ALJ Narwold recommends that the license be renewed on probation for the length of the RMA. She agreed to the probationary status.

60. Paula Van Cleave RN Renewal Positive Response

The licensee failed to appear. The recommendation is to deny renewal.

61. Tonya Haggard RN Renewal Positive Response

The licensee failed to appear and will be rescheduled one time.

62. Megan Sordelet RN Renewal Positive Response

Ms. Sordelet appeared for her personal appearance regarding her application for renewal. She received an OWI. She was driving home from a wedding and was pulled over. Her blood alcohol level was .2. She is already in ISNAP and RMA will be completed in April 2014. She has been in full compliance. She has not had any other issues. Her license is to be renewed free and clear.

63. Karey Hogue RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported a proposed malpractice complaint involving a baby who had a seizure 36 hours after birth and suffered a skull fracture. The baby is believed to be ok. ALJ Hall recommended renewing the license free and clear.

64. Ali Campbell RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported a pending OWI with a BAC over .10. She also had an OWI in 2006. ALJ Hall recommended referral to ISNAP with renewal of the license on probation for the length of the criminal probation or six months active nursing practice, whichever is longer, and quarterly employer reports.

65. Jonathan Trader RN Renewal Positive Response

The licensee appeared regarding his RN renewal. He reported a pending OWI with a BAC of .18. ALJ Hall recommended an ISNAP evaluation, renewal of the license on probation for six months of active nursing practice or the length of the criminal probation, whichever is longer, and quarterly employer reports.

66. Heather Hazen RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported falling asleep twice on shift in two weeks and was disciplined for that. She was terminated from Maxim Healthcare Services after six years but is not sure of the specific reason. She reports no other terminations. ALJ Hall recommended renewal of the license free and clear.

67. Bonnie Gerstung RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported a termination from Parkview related to a miscommunication in charge nurse roles. She has never been terminated prior to this. ALJ Hall recommended renewing the license free and clear.

68. Stephanie Evans RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported an OWI and completion of criminal probation in March 2013. ALJ Hall recommended referral to ISNAP and renewal of the license free and clear.

69. Tracey Dilk RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported a DUI and job termination related to the DUI. She self reported to ISNAP and is enrolled in a two year RMA with full compliance. ALJ Hall recommended renewing the license free and clear.

70. Jason Siebert RN Renewal Positive Response

The licensee appeared regarding his RN renewal. He reported a job termination relating to a substance abuse problem. He self reported to his employer and is in full compliance with ISNAP. ALJ Hall recommended renewing the license free and clear.

71. Margarita Ramirez RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported an OWI in September 2012 with a BAC of .12. She also has a conviction for reckless driving in 2010 that involved alcohol. ALJ Hall recommended referral for an ISNAP evaluation with the license to be renewed free and clear.

72. Mary John Cain RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported a complaint regarding her job duties which resulted in an employer investigation. She has since reevaluated her job duties. ALJ Hall's recommendation is to renew the license free and clear.

73. Nicole Furseth RN Renewal Expired License

The licensee appeared regarding her RN renewal. She reported practicing as an RN since 2011 without renewing her license. ALJ Hall recommended denying the renewal and referring the matter to the OAG for investigation.

74. Jennifer Wright RN Renewal Did Not Disclose

The licensee appeared regarding her RN renewal. She reported discipline in Illinois which was not disclosed on her renewal form. ALJ Hall recommended renewal of the license on probation until the Illinois license is free and clear.

75. Michelle Lynn Goble RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported a DUI in October 2011 with a BAC of .18. She has completed criminal probation. She reports a prior reckless driving incident 13 or 14 years ago that also involved alcohol. ALJ Hall's recommendation is to obtain an ISNAP evaluation and renew the license free and clear.

76. Morgan M. Newkirk RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported an OWI in August 2013. She is on criminal probation for a year. ALJ Hall's recommendation is to obtain an ISNAP evaluation, renew the license on probation until successful completion of criminal probation.

77. Melanie Sue Creel RN Renewal Positive Response*

The licensee appeared regarding her RN renewal. She reported a termination from work in June 2013 related to failure to document drug waste, practicing outside the scope of her license and falsifying documents involving giving additional medications that were not ordered. There was no harm to the patient. She reports completing continuing education on medication documentation and stress management. She is not an ISNAP candidate. ALJ Hall's recommendation is to renew the license free and clear.

78. Laura Thompson RN Renewal Positive Response

The licensee appeared regarding her RN renewal. She reported a written warning after a patient asked for her number while he was being discharged. She provided it to the patient; they exchanged text messages and had no further contact. ALJ Hall's recommendation is to renew free and clear.

79. Timothy Resac RN Renewal Positive Response

Mr. Resac did not appear regarding this matter. It will be rescheduled.

80. Lori Speicher RN Renewal Positive Response CONTINUED

There being no further business, and having completed its duties, the meeting of the Indiana State Board of Nursing adjourned at 2:10 p.m.
