IV. INDIANA STATE NURSES ASSISTANCE PROGRAM

Mr. Lindquist appeared on behalf of ISNAP and introduced Samantha Meadows as the new case manager replacing Roxanne Thomas. ISNAP's quarterly newsletter was distributed to providers and participants and a copy was provided to the Board. Mr. Lindquist then reported on the quarterly ISNAP compliance info. He also indicated that after a Board inquiry, the compliance decision tree will start going to all participants at the beginning of the RMA process. One figure is wrong on quarterly compliance information and will be corrected. Mr. Lindquist then addressed the audience.

V. EDUCATION

**A. Brown Mackie College Merrillville PN Program:** Allan Puplis, Program Administrator for PN Program resigned effective 9/7/12; Brenda McAllister, Regional Director for Brown Mackie to serve as Program Administrator until the teach-out is completed. Staff appeared from Brown Mackie College Merrillville. Ms. McAllister indicated that the teach-out will be completed in December 2012. Five students are in the program, 3 students are set to graduate next week, 1 student is set to graduate in November 2012 and 1 student is set to graduate in December 2012. **Board Action: A motion was made and seconded to accept Ms. McAllister as the program head until the teach-out is completed. #### B. Appearances by Applicants for Renewal

1. Amber Lichtle LPN Renewal Positive Response  
Ms. Lichtle appeared for her personal appearance regarding her application for renewal. In January 2012, she received an OWI. She has been in touch with ISNAP and is entering into an RMA. There have been no problems at work. She is allowed to renew on probation the length of her RMA, with quarterly reports.
2. Bamikole Oniyide LPN Renewal Positive Response  
Mr. Oniyide appeared for his personal appearance regarding his application for renewal. He was terminated from his employer in August 2011. There was a patient he was taking care of that did not like him. He had made several attempts to speak with management regarding the patient. He asked the patient if he didn't like black people because the patient always made racial comments to him. He spoke to the administrator about the patient's perception of him. He made several complaints regarding the patient. They took him off the assignment for a while but sometimes he had to take care of him. He was terminated because of this patient. He filed a wrongful termination complaint but reported that it has been dropped due to facility going under. He is currently working at Kindred healthcare. He has never had any other problems with any other patients. No trouble with current work place. He had a previous administrative complaint that came before the board and at that time he was renewed free and clear, paid a fine and took CEUs. He does not feel there are any anger issues. The recommendation is to renew free and clear.
3. Jessica Smith LPN Renewal Positive Response CONTINUED
4. Stephanie Wilson LPN Renewal Positive Response  
Ms. Wilson appeared for her personal appearance regarding her application for renewal. She received a DUI in July 2011 and a second one in March of 2012. She has yet to go to court over the second DUI. She has returned a 2 year RMA agreement with ISNAP. She has not had a drink since March. She is doing ok. The recommendation is to renew on probation for the length of RMA with quarterly reports from employer.
5. Sharen Barker LPN Renewal Positive Response  
Ms. Baker appeared for her personal appearance regarding her application for renewal. She will be in an out of state monitoring program. Last May she had a motorcycle accident and was released on a long list of pain medication. She went back to work too soon while still taking the medication. Her Kentucky license is active with the restriction of not being able to work with narcotics. She is working in Kentucky and is in the CARE program. She is going to be monitored by ISNAP. The recommendation is to renew free and clear.
6. Del Vallee Torsten RN Renewal Positive Response  
Ms. Torsten did not appear for her personal appearance regarding her application for renewal.
7. Vickie Morris LPN Renewal Positive Response  
Ms. Morris appeared for her personal appearance regarding her application for renewal. During her probation period she had a job at a specialty hospital. She told them she didn't have recent training and was told that was ok. At the end of her 90 probation period, she was given patients she didn't feel comfortable working with due to lack of training. She told them she wasn't comfortable and was discharged. She had been an office nurse and had not done some things since nursing school. She got another job at a doctor's office and was there for 90 days. She was slow learning on the computer. The manger was told she didn't take enough notes. She didn't have training on giving immunizations or listening to baby's heartbeats. At the end of the probation period, she was told she didn't fit in and was let go. She is currently working at a nursing home for the last 2 weeks. Everything is going well. She has no issues of feeling overwhelmed. She has never had an issue with license as far as complaints or discipline actions. The recommendation is to renew free and clear.
8. Lesa Vaughn LPN Renewal Positive Response  
Ms. Vaughn appeared for her personal appearance regarding her application for renewal. She was terminated from Northwest Manor in March 2011. Her dad was a resident of the facility and she was there to visit her father. While she was there, she was confronted by the dad's girlfriend and there was a verbal confrontation with the family. She was let go due to this confrontation. She is currently working at new facility since July 2011 with no issues. She has never had any other problems. The recommendation is to renew free and clear.
9. Billy Craig LPN Renewal Positive Response  
Mr. Craig appeared for his personal appearance regarding his application for renewal. He has entered in a pretrial diversion for public intoxication. On May 30 2012, he went golfing with friends and he had an accident and was taken to the hospital. They did no blood alcohol test. He was given a ticket at the time but was not told anything else. He was looking into the issue and discovered there was a warrant for his arrest. He turned himself in and was given the pretrial diversion. He is currently on criminal probation. He also has a nursing license in Ohio. He needs to have an ISNAP evaluation. His license will be renewed on probation for the length of RMA or criminal probation, whichever is longer.
10. DeLisa McCloud LPN Renewal Positive Response  
Ms. McCloud appeared for her personal appearance regarding her application for renewal. She received a DUI in April 2012. Her blood alcohol was .20. She was on criminal probation for 6 months. The criminal probation has been completed. She was celebrating a job promotion and was drinking mixed drinks. She needs to have an ISNAP evaluation. If meets criteria, she will be renewed on probation length of the RMA, if not renew free and clear.
11. Rasheedah Hunter LPN Renewal Positive Response  
Ms. Hunter appeared for her personal appearance regarding her application for renewal. She was arrested in January 2012. She had an altercation with youngest daughter. She found out her daughter was in another apartment and she refused to come home. She went to the residence to bring her daughter home. She held on to her daughter because she didn't want her

to run away. The daughter told police she didn't want to go home because she was beaten and choked by her mother. Those charges were dismissed. She placed her daughter in a therapy program. Her daughter is now home with her. During this renewal period, she was also terminated from a job because she received a call while at work and took a break to talk on the phone because her son had been shot. She had the keys and she left the floor unattended for an unauthorized break so she was let go. She did tell another nurse that she was taking a break so someone would know she wasn't on the floor. She is currently working at a new facility and has been there for almost a year. She has not had any problems or issues. She reports that her home life is much better now. The recommendation is to renew free and clear.

12. Stacy Henderson LPN Renewal Positive Response  
Ms. Henderson appeared for her personal appearance regarding her application for renewal. She has a 2010 conviction. She was called in to give a deposition in a criminal investigation and made an incorrect statement and then told the truth. The recommendation is to refer the matter to be expedited to the attorney general's office for investigation and allow the license to be valid to practice while being reviewed.
13. Carla Deal LPN Renewal Positive Response- SEEN BY FULL BOARD  
Ms. Deal appeared in person and by counsel David McNamar. She tested positive for marijuana in October 2009. She was working at Victory Knoll in Huntington, Indiana when this occurred and received a drug screen as a result of a workplace injury. She then was unemployed for 12-18 months. She had a hearing before the full Board in June 2012 which resulted in indefinite probation with a six month recovery monitoring agreement which is now under judicial review. Mr. White asked if she would agree to issue her renewed license on probation and Mr. McNamar indicated he would not. Mr. White then recommended that the matter be referred to the Attorney General's Office for investigation and make the status valid to practice in order to respect the wishes of the trial court and let the judicial proceedings continue. She is working at Peabody in Manchester, Indiana in a full time position. Ms. Deal indicates she has had no supervision issues or disciplinary problems at Peabody. She currently has a prescription for Vicodin but takes PRN as she needs it usually ½ tablet per week for back issues. She also currently has a prescription for Tussionex pearls. Board Action: A motion was made and seconded to make the license valid to practice while under review and refer the matter to the Office of the Attorney General for investigation. 14. Jade Dixon LPN Renewal Positive Response  
Ms. Dixon appeared for her personal appearance regarding her application for renewal. In May 2011, she worked for the Marion County Jail and for Wishard. She left the 1<sup>st</sup> job for an emergency dental appointment. The 2<sup>nd</sup> job called while she was at the dentist to have her work a shift that night. She called and left several messages to tell them that she could not work. The next day she was told she didn't work there anymore. This year she reported working a pediatric care assignment, for 2 days but was terminated because the patient's mom did not like her.. The mom was not happy because she was working another full time job and she really wanted a nurse to work full time. She is currently working at West Park health care for over a year. She has had no other issues. The recommendation is to renew free and clear.
15. Tina Heath LPN Renewal Positive Response  
Ms. Heath appeared for her personal appearance regarding her application for renewal. She was terminated; but reports that the facility was going through a lot of changes in management. The interim director was staying at the facility and asked a CNA to clean her room. The CNA didn't feel comfortable in cleaning the room alone with all her personal belongings. She was going to go with the CNA to help clean the room. The RN at the time was very upset about this; she was yelling and cussing at both her and the CNA. She told them she wasn't happy with her job due to everything that was happening. By the end of the meeting, she was told she was fired. She was not allowed to clock out. After talking to corporate, she found out she was fired for insubordination. She is currently working part time with no issues. The recommendation is to renew free and clear
16. Karen Klein LPN Renewal Positive Response  
Ms. Klein appeared for her personal appearance regarding her application for renewal. She had a DUI in April 2012 and completed a deferral program. Her blood alcohol level was .09. This is the only DUI she has had. She had a second issue in this renewal cycle regarding a protection order against her ex-boyfriend. She called the police because he violated the order. He was friends with the cop and the cop wrote her a ticket for false informing. She is working towards getting that dismissed. She is currently on criminal probation for one year (April 2013). She needs an ISNAP evaluation. She is allowed to renew on probation length of her RMA or criminal probation, whichever is longer.
17. Regina Doyle LPN Renewal Positive Response  
Ms. Doyle appeared for her personal appearance regarding her application for renewal. In March 2011, she received a charge for OVI, in Ohio. Her mother was with her and had alcohol in the car. She was going to pick up sister-in-law. By poor judgment she went to pick her up after drinking. She does not drink anymore. She had an assessment through Gateway and it said she needs no further assessment. She does not feel like she has a problem. She was in monitoring previously and completed it. She was in the program previously due to marijuana. She reports completed her criminal probation. She needs to have ISNAP evaluation. If she meets criteria she will be renewed on probation for the length of her RMA. If she does not meet criteria then she can be renewed free and clear.
18. Deborah Turpin LPN Renewal Positive Response  
Ms. Turpin appeared for her personal appearance regarding her application for renewal. She had a criminal conversion charge in September 2012. She was with 2 friends, one friend was having a rough time and they agreed to help her out. She took money from one friend's checking account to help pay the bills and then that friend decided not to help. The other friend said she didn't have permission to remove money from the checking account to pay the bills. She stated no charges were filed and then later stated she that she pled guilty but no criminal probation was involved. The recommendation is to renew free and clear.
19. Robert McKean LPN Renewal Positive Response

Mr. McKean appeared for his personal appearance regarding his application for renewal. He was terminated due to charting errors. He was told he wasn't charting correctly, and he indicated that the facility wanted him to chart that a patient was alert and coherent when the patient really wasn't. He has never had any issues with his charting in the past. He was told the last week that he was too much of a resident advocate. He is currently accepting unemployment. He has never had any past complaints or issues. He had a termination previously due to staffing and overtime issues. He has completed CEUs. The recommendation is to renew free and clear.

20. Tracy Vaughan LPN Renewal Positive Response  
Ms. Vaughan appeared for her personal appearance regarding her application for renewal. She was terminated in December 2011 for yelling at a resident. She was going to go help with a patient who was in the floor. She asked the patient if she was ok and the patient answered yes. Then asked why she didn't have her oxygen on. They got her up and taken care of. She left two CNAs in the room. When she came back to work she discovered the aid had been fired and she was suspended while it was being investigating. The daughter of the resident made a complaint. Daughter said the resident told her that the aid yelled and the nurse did too. Before this she had complained to management about working and not getting paid. She couldn't take lunches or breaks due to being the only nurse. She was required to be on the floor the whole time she was there. She stayed because she loved her job and they worked around her school schedule. She loved the residents. This matter is currently in federal court. She is currently working and reports no issues. She doesn't feel like she has any issues with dealing with people or any anger issues. The recommendation is to renew free and clear.
21. Quanadra Hatcher LPN Renewal Positive Response  
Ms. Hatcher appeared for her personal appearance regarding her application for renewal. In September 2011, she was pulled over for DUI. Her blood alcohol level was .09. That day she was celebrating getting a home loan to get a house with some friends. When they were leaving she felt ok to drive and was 2 blocks from home when she was pulled over for driving too close to the grass. She has never been in trouble before this. She pled guilty and was placed on a year of criminal probation. This has been completed. The recommendation is to allow to renew free and clear.
22. Lisa Miller LPN Renewal Positive Response  
Ms. Miller appeared in front of the full Board. She worked on an expired license in the State of Indiana for two years as a nurse. She worked at Waterford Place in Kokomo, Indiana and Advantage Home Health Care in Kokomo, Indiana. 

She is currently working in an assisted living facility. She loves her current job. She does not meet criteria for ISNAP. She is allowed to renew free and clear.
2. Harjit Sangha LPN Renewal Positive Response  
Mr. Sangha appeared for his personal appearance regarding his application for renewal. He was arrested in March 2012 for a DUI. He was in his apartment complex and there was a fight. He was standing outside his car and the cops thought he was involved. He blew .08. He had court date last Thursday. He was placed on 6 month probation. He needs to have an ISNAP evaluation. His license will be renewed on probation the length of his criminal probation.

3. Ms. Dunigan appeared for her personal appearance regarding her application for renewal. She was terminated from her job for giving medication without an order. The patient was sick and diabetic. He was having a very bad night. She gave him some medication so his stomach wouldn't be upset. Matter to be referred to the AG's office. License to be valid to practice while being reviewed. Current employer does not know what happened. She was been working at new facility since January. She answered all no's on her renewal application. She said she did not know how she missed the question.
4. Michael Icenberg LPN Renewal Positive Response  
Mr. Icenberg appeared for his personal appearance regarding his application for renewal. He was terminated from his job. He has no idea why. He was called by the administrator stating he was fired due to talking in a authoritative voice to the residents. He has never had any resident's complaints. He has been fired 3 times for being male. Currently working at Danville rehab and Masonic Home. He has not had any issues at either facility. Allow to renew free and clear.
5. Craig Gray LPN Renewal Positive Response  
Mr. Gray appeared for his personal appearance regarding his application for renewal. H was terminated from job. He was dating one of the nurse managers and then started dating another nurse. The nurse manager was real upset by this and started texting him and the other nurse. They tried to fire him several times and he would take the matter to the administrator and they would be told to leave him alone.

He was eventually terminated due to the relationships being violation of corporate policy. He has been at his current facility for a couple months and there have been no issues. There have been no issues with his job performance. Allow renewal free and clear.

6. Sandra Duncan LPN Renewal Positive Response  
Ms. Duncan appeared for her personal appearance regarding her application for renewal. She received a DUI last November. She is still waiting to for a court date. She has not worked for over 20 years but wants to keep her license. She was out with girlfriends and made a bad mistake. She blew .08. She does not meet criteria for ISNAP. She is allowed to renew. If she is placed on criminal probation her license will be renewed the length of criminal probation.
7. Sharen Baker RN Renewal Positive Response CONTINUED
8. Janet Murphy LPN Renewal Positive Response  
Ms. Murphy appeared for her personal appearance regarding her application for renewal. She was terminated from Sara Care. She didn't realize she was supposed to be the supervisor because no one told her this. She was told she was unable to be a supervisor. She was also let go from Indiana Eye Institute for not being fast enough. She was having panic attacks and has had them for years. She takes current medication but not in therapy. She has not worked as a nurse for a year. Her panic attacks are currently stable. Allow renewal free and clear.
9. Lisa Scott LPN Renewal Positive Response  
Ms. Scott appeared for her personal appearance regarding her application for renewal. She had a criminal conversion charge in March. This is the first time in trouble. She was in a bad relationship. He was abusive and stole a lot of her money. She didn't have money to get stuff for her kids. She stole food for them. She was going through a rough period in her life. She was also terminated in March for taking items from different residents' rooms. She took a clock, lamp, and owl figurine. She has never had problems with drugs or alcohol. She has not had any counseling. She needs to take a MMPII. License to be renewed on probation status for 6 months active license with quarterly reports. She currently works at Canterbury Rehab. They are not aware of what has occurred in the past.
10. Rebecca Shaw LPN Renewal Positive Response  
Ms. Shaw appeared for her personal appearance regarding her application for renewal. She is currently on probation in IL. She was working for a physician for about 13 years. She had a written job description which stated she was to write prescriptions in the morning and place in chart and was diluting cough syrup with cherry flavoring. Renewed on probation to mirror IL's probation.
11. Angela Townsell LPN Renewal Positive Response  
Ms. Townsell appeared for her personal appearance regarding her application for renewal. She had an intimidation and battery charge. The situation involved a blockbuster clerk. She received a letter stating she owed a late fee. She called the store to get the charge removed. The clerk was really rude and she couldn't get anything resolved. She just went up to the store to get it resolved in person. They had a verbal altercation. She left the store. There were charges filed. There was a bench trial. She has been on her current job for 5 years without any discipline actions. She did do 6 weeks of anger management classes. She is not on any kind of probation though the courts. Recommend renewal allowed free and clear.
12. Farai Moyo LPN Renewal Positive Response  
Mr. Moyo appeared for his personal appearance regarding his application for renewal. In 2010 he was arrested for public intoxication. He was out with friends they were being loud. These charges were dropped. In August 2010, he was arrested for DUI. Blew 0.15. He went through probation, classes, counseling, and paid the fines. His probation is completed. He has already contacted ISNAP and has an appointment set up. He is not currently drinking. Allow renew, if in ISNAP RMA renew on probation the length of RMA if not license free and clear.
13. Georgia Palmer LPN Renewal Positive Response  
Ms. Palmer appeared for her personal appearance regarding her application for renewal. She was arrested for DUI in June 2011. She has completed probation, counseling, and classes. She has had no issues in her work place. She does not drink. She blew .08 and hit her neighbor's car. She doesn't meet ISNAP criteria. Allow renew free and clear.
14. Amber Roark LPN Renewal Positive Response  
Ms. Roark appeared for her personal appearance regarding her application for renewal. In Feb 2011, she was out with friends with dinner and drinks. She was pulled over for speeding and blew .12. She has completed probation, classes, and community service. She job is aware of what occurred. She needs to send documentation showing proof that her probation is cleared up. Once we receive these documents she can be renewed free and clear.
15. Gaspar Dado LPN Renewal Positive Response  
Ms. Dado appeared for his personal appearance regarding his application for renewal. He pled guilty to Sexual battery. He was involved in an incident involving his girlfriend's niece. He pled guilty due to girlfriend being pregnant and his other children had been taken by CPS due to issues with mother. He couldn't take the children because of the charges. He is on criminal probation for 18 months. He was accused of molesting his girlfriend's niece. The mother and the niece accused him. The child was 14 at the time. He embraced her and made her feel uncomfortable. Renew on probation for the length of the criminal probation, need quarterly reports from employer, if not employed need self reports. Same restrictions for criminal probation will apply for the nursing probation.
