**I. CALL TO ORDER AND ESTABLISHMENT OF QUORUM**

**II. ADOPTION OF THE AGENDA**

**III. ADOPTION OF THE MINUTES FROM THE SEPTEMBER 15, 2011 MEETING OF THE BOARD**

A motion was made and seconded to adopt the September 15, 2011 nursing board minutes. Laux/Ogle 8-0-0, motion carries

**IV. INDIANA STATE NURSES ASSISTANCE PROGRAM**

Chuck Lindquist reported on behalf of ISNAP. The Board received ISNAP's September 2011 monthly report. The ISNAP benefit concert held in September raised over \$950.00 for the Needs Assistance Fund ("NAF") and there is currently about \$1200.00 total in the fund. ISNAP staff is training and the expected live date for their electronic case management system is 11/1/11 with vendor Affinity Online Solutions ("AOS"). The ISNAP quarterly provider meeting is 10/28/11 at Tara Treatment Center in Franklin, Indiana. The Board received a handout on the rise of ADHD drugs in college age students. Chuck related that INSPECT access is proving to be a valuable resource for ISNAP. Ms. Ogle asked a question about the NAF and Chuck indicated that AOS will provide \$3000 in funds for the NAF and that nurses are limited to use the NAF two quarters at a time. Currently, the requests into the NAF have not exceeded the available funding. Chuck then addressed the students in the audience regarding ISNAP and the monitoring process.

**V. EDUCATION**

- A. Indiana Dabney University- Plan of Correction**  
**Pass Rates: 2008-40%, 2009-43.48% 2010-42.9%**  
**Standard Deviation: 2008-86.1%, 2009-87.8%, 2010-86.8%**

Staff from Indiana Dabney University ("IDU") was present regarding their Plan of Correction. IDU has made changes to their admissions process and is now using the NLN PACS (as of eight months ago) to test for preadmission examinations. IDU combined their mental health and psychology courses together in the curriculum. IDU is utilizing the NLN for evaluation processes throughout the nursing program. IDU admits 3 cohorts each year with a cap of approximately 20 students per cohort. IDU has had 2 admission cycles since the implementation of PACS. Ms. McIntosh asked why IDU decided on 100 points for the PACS when 160 points are available. Ms. Laux asked whether the comprehensive is predictive. Staff indicated the Diagnostic Ready test is a good indicator. IDU's current cohorts are 6, 10 and 13 students, respectively. Ms. Dolk asked about admission criteria. Staff indicated that they look at past work experience and a GPA of 3.0 which requires some students to complete additional course work and reapply. Ms. McIntosh asked about retaking prerequisites. Staff indicated that all students come in with prior medical experience such as a CNA or MA. Their lowest passing grade is a "B" (calculated at 80%) in the class. Ms. Hall asked whether IDU has assessed their program to see why the NCLEX pass rates are so low. Staff indicated that this has not been completed. IDU has no articulation agreements in place at this time. Without these, their student credit hours would not transfer to any other school of Nursing. IDU is projecting an 85% pass rate for 2011 first time NCLEX test takers. Ms. Narwold indicated IDU's Plan of Correction focuses on the testing piece but that staff should look at other things as well such as clinical sites, gaps in curriculum, faculty delivery improvement methods, textbooks, courses students come into the program with, etc. Ms. Dolk indicated they should look at the rigor of exams as well and make sure they are increasing in rigor. Ms. Laux also recommended looking at faculty certifications.

**Board Action:** A motion was made and seconded to table the matter and for IDU to return in December with a revised Plan of Correction which includes action steps and pass rates for 2011 NCLEX first time test takers. Burghduff/Hall 8-0-0, motion carries

## VI. DISCUSSION

### A. Kelly Moore – Motion to Reconsider

The Board held a discussion regarding this motion. A motion was made and seconded to deny a request for a new hearing as the time for judicial review has passed and there is no proof of new evidence in the motion. Burghduff/Laux 8-0-0

### B. Discussion of Logistics for January 2012 Meeting

On January 19, 2012, the Board will meet for its full meeting at Ball State University in Muncie, Indiana. Ms. Crawford reported that she will be traveling to Ball State to work on logistics for the meeting on October 28, 2011 with Ms. McIntosh. Additional details for travel, etc. will follow at the November and December 2011 Board meetings.

### C. Report from Gabrielle Owens, Office of the Attorney General

Ms. Owens appeared before the Board of Nursing. A report was passed regarding the current complaint openings and closures from the Office of the Attorney General as of October 20, 2011. Ms. Owens reported that 435 consumer complaints have been opened in 2011, 480 consumer complaints have been closed in 2011 and 263 Nursing administrative complaints have been filed in 2011. Ms. Ogle asked for a cumulative figure for accurate reporting so that the 480 consumer complaints closed is more accurate, i.e. an explanation as to how OAG closed more complaints than they opened in 2011. Ms. Ogle requested a figure which indicates the total number of open cases that they have not just those opened in one year's time. Mr. Burghduff noted he asked for a report regarding the aging of complaints at the July full Board meeting and that information was not provided in today's report. Mr. Burghduff asked how many open complaints there are and Ms. Owens indicated that she could not provide that answer at this time. Ms. Owens did indicate that she believes there is no consumer complaint older than the first quarter of 2010. Ms. Owens was asked and could not provide a number for the amount of litigation cases open or regarding the oldest litigation case open. Mr. Burghduff again addressed concerns about ISNAP cases not being brought within two months time as these are emergent public safety issues. Ms. Owens indicated that Board staff should email the list to her and Ms. Crawford indicated that this had already occurred on September 13, 2011. Ms. Owens indicated that ISNAP closures were treated like emergency suspensions and are moved as quickly as possible. Mr. Burghduff reiterated that individuals that are closed out of ISNAP are of the utmost importance to public safety. Ms. Owens asked for notice for the next quarter and was told that her next quarterly appearance will be in January 2012.

**D. Discussion from President-** Mr. Burghduff indicated that the Board is looking at legislative issues and rules at this time. This is being done in subcommittees that are being done in less than a quorum. Any work that is being handled on those subcommittees is not official or final until the whole Board meets and votes. Speculation by anyone at this point is premature. Mr. Burghduff indicated that unless you are a party to these subcommittees this information should not be communicated to anyone.

## VII. BOARD DIRECTOR REPORT

Ms. Crawford reported that the Registered Nurse renewal cycle is going well. As of today's Board meeting, over 68,000 RN's had renewed which leaves about 30,000 outstanding for the October 31, 2011 expiration date. We will have a great deal of personal appearances over the next 90 days to deal with positive responses so all Board members should contemplate long Board meeting days. Ms. Crawford reported that the third quarter NCLEX scores are out and gave the average percentages to the Board. Ms. Crawford reported that Mary Jo Regan Kubinski, Dean of Nursing at IUSB, passed away this week. The Board sends its condolences to the IUSB family. Ms. Crawford reported that she presented before the Executive Board of the Indiana Organization of Nurse Executives on October 18, 2011 and that several of the regional bodies of IONE have requested speaking engagements for their next regional meetings.

#### 2. Lisa Reed

Applicant appeared in person regarding her application for licensure by examination. Applicant indicated that her Indiana pharmacy technician certificate was revoked for diversion of Tussionex. Applicant was supplying other pharmacy staff employees with Tussionex as well.

Applicant appeared in person regarding her application for licensure by examination. Applicant reported a trespassing charge and a marijuana possession charge in 2005. Applicant appeared in person regarding her application for licensure by examination. Applicant reported multiple criminal convictions including criminal mischief, possession of a handgun and false informing. **Board action:** A motion was made and seconded to allow her to sit for the NCLEX examination. Applicant must obtain an ISNAP evaluation and enter into an RMA if indicated. After successful completion of the NCLEX, Applicant's license shall be issued on indefinite probation. Applicant may not lift probation for a minimum of one year with quarterly employer reports. Burghduff/Ogle, 5-0-0, motion carries
10. **Clarice Williams**  
Applicant appeared in person regarding her application for licensure by examination. Applicant reported theft charges in 1990 and 2003 and prior work site disciplinary issues in her work as a Certified Nursing Assistant. Applicant provided letters of recommendation to the Board.

**Board Action:** A motion was made and seconded to allow her to sit for the NCLEX examination. Applicant's license shall be issued on probation. Applicant may apply for withdrawal after six months of active nursing practice with two employer reports.
11. **Patrick Delaney**  
Applicant appeared in person regarding his application for licensure by endorsement. Applicant had two alcohol related convictions from 2001 and 2003 and a disorderly conduct arrest in 2007 which were not disclosed on his application for licensure.

**Board action:** A motion was made and seconded to issue a license by endorsement. Applicant must obtain an ISNAP evaluation and sign a RMA if eligible. Applicant's license shall be issued on probation. If ISNAP eligible, Applicant may apply for withdrawal after 6 months of active nursing practice with employer reports. If he is not eligible for ISNAP, Applicant may petition to lift probation immediately. 5-1-1 Burghduff/McIntosh, motion carries (Ogle against, Laux abstains)
12. **Javier Salazar**  
Applicant appeared in person regarding his application for licensure by examination. Applicant reported a check deception charge in 1997 and an auto theft charge in 2006. The application was tabled so that the applicant could provide documentation of the military service. Applicant reappeared in the afternoon session. Mr. Salazar was in the military from 1993 to 1995. He was charged with an Article 15 in Georgia while in the military and received a medical discharge regarding an alcohol related issue. He had to repeat one clinical course during nursing school. Applicant indicated that he is currently taking Xanax.

Applicant must attend another personal appearance after all information is submitted and he has successfully passed the

NCLEX so that the Board may determine whether to issue a license. 5-1-2, Ogle/Laux motion carries (Dolk and Burghduff abstain, McIntosh against)

**13. Dara Bieber**

Applicant appeared in person regarding her application for licensure by endorsement. Applicant reported a DUI in 2008. This is the only conviction Applicant has had. Applicant's Michigan license is active and current but she has never worked in Michigan. Applicant provided a letter of recommendation to the Board.

Applicant appeared in person regarding her application for licensure by examination. Applicant reported a shoplifting charge in 1999 and a 2011 DUI.

**Board action:** A motion was made and seconded to allow her to sit for the NCLEX examination. Applicant must obtain an ISNAP evaluation and sign an RMA if eligible. Upon successful completion of the NCLEX, Applicant's license shall be issued on indefinite probation for duration of criminal probation or RMA whichever is longer with quarterly employer reports. She also has an active PN license which will be referred to the OAG for investigation. Burghduff/Narwold, 5-1-0, motion carries (McIntosh against)

Applicant appeared in person regarding her application for licensure by examination. Applicant's license was suspended for failure to pay a prior speeding ticket.

**Board action:** A motion was made and seconded to issue the license free and clear. Burghduff/McIntosh 6-0-0, motion carries

**B. Appearances by Applicants for Renewal**

The following personal appearances were conducted by Ms. Laux and Ms. Presley sitting as an Administrative Law Judge ("ALJ") in Conference Room 14 unless otherwise noted.

**Board Action:** A motion was made and seconded to accept the recommendations of Ms. Laux and Ms. Presley. Narwold/Ogle, 7-0-0 motion carries

**1. Cynthia Alkire**

Ms. Alkire did not appear before the ALJ as requested regarding a positive response on renewal of her RN license. She has been closed out of ISNAP and there is a pending complaint with the AG's office. The ALJ recommended denying her renewal.

**2. Natalie Smith**

Ms. Smith appeared regarding her RN license renewal. She reported a termination and conviction in 2010 for shoplifting. The ALJ recommended renewing her license on probation for 6 months with 2 quarterly reports from employer or self reports if not employed.

**3. Jeannie Dunlap**

Ms. Dunlap appeared before the ALJ regarding her application for renewal of her RN license. She reported a pending lawsuit due to death of a patient. She stated it occurred 5 years ago and she could not remember most of the details. The ALJ recommended renewing her license and referring the matter to the AG's office.

**4. Joshua Harper**

Mr. Harper appeared before the ALJ regarding renewal of his RN license. He reported an OWI in May 2011 with a BAC of .16. He is on probation until May 2012. The ALJ recommended an ISNAP evaluation and to renew the license on probation for the length of the RMA or criminal probation, whichever is longer.

**5. Kelly Ferreira**

Ms. Ferreira appeared before the ALJ regarding renewal of her RN license. She reported that she is on probation for domestic battery in the presence of her children. She previously reported this on her APN application but she did not report that she was on probation. The ALJ recommended renewing the license on probation for the length of her criminal probation.

**6. Holli Madewell**

Ms. Madewell appeared before the ALJ regarding renewal of RN license. She reported a DUI arrest in November 2010 and upon advice did not do a breathalyzer test. She is on probation until Jan. 2012. The ALJ recommended renewing her license on probation for the length of the criminal probation.

**7. John Sloan**

Mr. Sloan appeared before the ALJ regarding his RN renewal application. He reported his KY license was reprimanded for charting errors. He stated he has been required to complete 60 CEs by the KY ALJ. The ALJ recommended his license be renewed upon his showing proof of completing the CEs as required by KY board order.

**8. Patricia Scheyer**

Ms. Scheyer appeared before the ALJ regarding her RN renewal. She reported a termination in Dec. 2010 due to job performance issues pertaining to medication administration, charting and insubordination. She is seeking to renew her license so she can do volunteer work. The ALJ recommended that her license be renewed free and clear.

**9. Charles Hoover**

Mr. Hoover appeared before the ALJ regarding his RN renewal. He reported DUI 2 years ago following his 2009 renewal. He stated there have been no alcohol related incidents since and the matter has been resolved. The ALJ recommended his license be renewed.

**10. Joel Durnell**

Mr. Durnell appeared before the ALJ regarding his RN renewal. He reported a DUI in Dec. 2010 with a BAC of .12 and is currently on probation through Nov. 2011. The ALJ recommended his license be renewed free and clear.

**11. Patricia McElroy**

Licensee appeared in person and by counsel. Licensee was named in a malpractice lawsuit. In the malpractice suit it was alleged that she had communication issues and failed to take care of a diabetic patient. The suit was settled by the organization she works for in mediation and she still works for the organization.

**Board action:** A motion was made and seconded to refer this matter to the Office of the Attorney General and make her license valid to practice while under review. Burghduff/McIntosh 5-0-0

**Board members participating:** Burghduff, Ogle, Hall, Dolk, McIntosh

**12. Teri Miller**

Ms. Miller appeared before the ALJ regarding positive response on her RN renewal. She reports termination due to being overwhelmed with full time demands on a part-time job. She also reported terminations on her 2005 and 2007 renewals. She stated the issue was not getting documentation done on time. The ALJ recommended renewing her license on probation for 6 months with two supervisory reports from the employer.

**13. Kathleen Barrett**

Ms. Barrett appeared before the ALJ to explain answers of yes on her application for renewal of registered nurse license. She reported an arrest in Nov. 2010 for OWI in which she explained she was "sleep driving" while on Ambien. She states she takes pain medication which she cannot function without. Because she is on Suboxone, she would not qualify for ISNAP. She has criminal charges pending. The ALJ recommended denying renewal of her license. Licensee was argumentative with the ALJ and was then sent to the full Board for review. Licensee then appeared in person before the full Board. Licensee indicated to the full Board that she has been charged with an OWI in November 2010 and has criminal litigation pending. Licensee indicates she cannot recall events that occurred but woke up in jail. Licensee believes that a medication combination caused her memory loss and pending criminal charges. Licensee indicated that she no longer takes Ambien.

**Board Action:** A motion was made and seconded to conduct an ISNAP evaluation and should she require treatment or monitoring that she enter in to a recovery monitoring agreement if eligible and her license will be renewed on indefinite probation for the length of her RMA or if she is found not to be a candidate she could apply to come off of probation immediately. Applicant did not want to agree to complete an ISNAP evaluation so her request for renewal was denied. Burghduff/Ogle 5-0-0, motion carries

**14. Tamara Pigg**

Ms. Pigg appeared before the ALJ to explain answers of yes on her application for renewal of registered nurse licensure. She reported a termination and the ALJ recommended that her license be renewed; however, she has a tax hold on her license that will need to be cleared by the DOR before her nursing license can be officially renewed.

**15. Ashley Taylor**

Ms. Taylor appeared before the ALJ to explain answers of yes on her application for renewal of registered nurse license. She reported a termination in Jan. 2011 due to diverting narcotics from her employer. She has an RMA with ISNAP that runs through March 2014. ISNAP confirmed that she is fully compliant. The ALJ recommended renewing her license on probation for the length of the RMA.

**16. Teresa Hosler**

Ms. Hosler appeared before the ALJ to explain answers of yes on her application for renewal of registered nurse licensure. She reported 2 terminations: in July 2010 due to personality conflict with supervisor, and May 2011 for not reporting alleged patient abuse in a timely manner in which another employee was accused of yelling at a patient and she did not report this immediately per agency policy. The ALJ recommended renewing her license after she submits 12 hours CE in patient abuse. She was given three months to submit the CEs to the ALJ.

**17. Lora McFall**

Ms. McFall was requested to appear to explain yes answers on her registered nurse licensure renewal. She reported the termination was unjust. The ALJ recommended that she have an ISNAP evaluation and then her license will be renewed.

**18. Rosemarie Allemeier**

Ms. Allemeier appeared before the ALJ to explain answers of yes on her application for renewal of registered nurse licensure. She reported a work discipline due to attendance, work improvement plan and inappropriate conversation with a patient. The work discipline was cited from 12/09 through 6/11. She stated she is currently working for the same employer on a different floor since 11/10. The ALJ recommended renewing her license.

**19. Danita Evitts**

Ms. Evitts appeared before the ALJ to explain answers of yes on her application for renewal of registered nurse licensure. She reported a termination in March 2011 due to violating the smoking policy at work. She states she was not smoking and was also told her work area was disorganized. She states she is now working in home health care and doing well. The ALJ recommended renewing her license.

**20. Cynthia Wasielewski**

Ms. Wasielewski appeared before the ALJ to explain answers of yes on her application for renewal of registered nurse licensure. She reported a Nov. 2010 OWI conviction which she pled down to a public intoxication charge after completing a deferral program. She stated her BAC was .14. The ALJ recommended that she have an ISNAP evaluation and that her license will be renewed on probation if she is eligible for an RMA. If not her license will be renewed free and clear.

**21. Shannon Rayford**

Ms. Rayford appeared before the ALJ to explain answers of yes on her application for renewal of registered nurse license. She reported an arrest in March 2010 for a class D felony for shoplifting. She has had previous board action on her LPN license due to forgery for falsifying time cards and payments. Ms. Whitten appeared before the ALJ regarding the positive response on her RN renewal. She reported a termination in 2010 due to diverting narcotics at work. Ms. Sliter appeared before the ALJ regarding the positive response on her RN renewal. **1. Jill Renihan**

Ms. Renihan appeared before the Board of Nursing ALJ regarding a positive response on her application for license by examination. She reported an alcohol possession charge at age 18 at a concert and an underage drinking charge on campus at age 19. The ALJ recommended allowing her to test and that she complete an ISANP evaluation. She is to sign an RMA if eligible then her license will be issued free and clear.

**2. Jeffrey Dunham**

Mr. Dunham appeared regarding his licensure application by examination. He reported a conviction for mail fraud and served time in federal prison in 1998. This was regarding an investment scheme. The ALJ recommended he be allowed to test and that his license be issued on probation for 1 year and that he not work in home health care during that year. Quarterly employer reports will be required.

**3. Richard Clark**

Mr. Clark appeared before the ALJ regarding his application for licensure by endorsement. He reported 2 OWIs in 2008, both with a BAC of .008. It was recommended that he complete an ISNAP evaluation and sign an RMA if eligible. His license will be issued on probation for six months with full compliance of the RMA. He may petition to have the probation lifted after 6 months if not eligible.

**4. Courtney Elliott**

Ms. Elliott appeared before the ALJ regarding her application for licensure by examination. She completed nursing school in 2007 and has not tested yet. She states she has been working in a residential setting with clients and has been reviewing course materials to prepare for the NCLEX. It was recommended that she complete a formalized review course and that she be allowed to test.

**5. Tiffany Rogers**

Ms. Rogers reports a DUI in 2011 and provided a letter of explanation although she did not answer yes to any questions on her application. She stated she is on unsupervised probation for three years as part of her plea deal. She reports her BAC was .12. It was recommended that she complete an ISNAP evaluation and sign an RMA if eligible. Her license is to be issued on probation for 6 months with full compliance with her RMA.

**6. Darlene Bergdoll**

Ms. Bergdoll appeared before the ALJ regarding her application for licensure by endorsement. There was a conversion change on her criminal background check from 1983 that she could not explain. She did explain the 1988 charge of disorderly conduct for interfering with a police officer arresting her boyfriend for DUI. She graduated from nursing school in 2011. The ALJ recommended that her license be issued free and clear.

**7. Ashley Brouse**

Ms. Brouse appeared before the ALJ regarding her application for licensure by examination. She reported alcohol related incidents in 2007 and 2008 and last drank one year ago. The ALJ recommended an ISNAP evaluation and that she be allowed to test. Her license will be issued on probation for 6 months of full compliance with the RMA. If not eligible for an RMA, the license will be issued on probation for 6 months and she may petition to have the probation lifted after six months.

8. **Katie O'Keefe**

Ms. O'Keefe appeared before the ALJ regarding her application for licensure by examination. She reported minor consumption of alcohol and OWI in 2005 and minor consumption again in 2007. The ALJ recommended allowing her to test and that she have an ISNAP evaluation with an RMA if eligible. Her license is to be issued free and clear.

9. **Lora Dillman**

Ms. Dillman appeared before the ALJ regarding her application for licensure by examination. She completed school in 2008 and has failed the NCLEX twice. She stated she is taking a review course. The ALJ recommended she take a formal review course and that she be allowed to test.

10. **Ashlee Nickless-Lopez**

Ms. Nickless-Lopez appeared before the ALJ regarding her application for licensure by examination. She reported in 2008 she was charged with shoplifting and also reported losing her driver's license in 2010 for failure to pay a penalty resulting from a car accident. The ALJ recommended she be allowed to test and that her license will be issued on probation for 1 year with quarterly reports from her employers, or self reports if not employed.

11. **Lisa Sipes**

Ms. Sipes appeared before the ALJ regarding her application for licensure by examination. She reported DUI's in 1990 in Florida and 1995 in Indiana, along with a domestic battery charge. There additional DUI's on the criminal background check but it was unclear whether these were the same or different locations. Due to the time passage, the ALJ recommended that she be allowed to test and that her license be issued free and clear.

12. **Jackson Wright**

Mr. Wright appeared before the ALJ regarding his application for licensure by examination. He reported a charge of voyeurism resulting in conviction in 2006. He reports all matters resolved and the ALJ recommended he be allowed to test and the license be issued free and clear.

13. **Amy Beyers**

Ms. Beyers appeared before the ALJ regarding her application for licensure by examination. She has failed the NCLEX 3 times previously and reports test anxiety as the issue. The ALJ recommended her application be denied and that she may reapply with proof of 95% or higher probability of passing the NCLEX as documented by formal participation in a review course.

14. **Amanda Hubbard**

Ms. Hubbard appeared before the ALJ to explain answers of yes on her application for licensure by examination. She reported 8 arrests and 2 convictions for auto/traffic violations for driving while suspended. She stated she is a CNA and QMA with no job concerns but brought no supporting documents. The ALJ questioned her judgment and procrastination in not resolving these matters. The ALJ recommended she be allowed to test and issued a probationary license for 1 year with quarterly reports from her supervisor.

15. **Thomas Loveless**

Mr. Loveless appeared before the ALJ regarding his 4 previous attempts to pass the ALJ. When he appeared before the BON in November 2010, it was voted upon that his license would be issued on probation due to a positive response; however he has yet to pass the NCLEX. It was recommended that he attend a formal NCLEX review and provide proof of 95% or higher probability of passing. Then he will be allowed to test. The license is still to be issued on probation as stated in the November 2010 BON minutes.

16. **Kimberly Hardiman**

Ms. Hardiman appeared before the ALJ to regarding her application for licensure by examination. She has failed the NCELX 4 times since completing school in 2009. The ALJ voted to deny her application and that she may attend a formal review course and submit documentation of a 95% or higher probability of passing with her next application.

17. **Alonzo White**

Mr. White was requested to appear to explain yes answers on his application for registered nurse licensure by endorsement. He explained some of his yes answers and the criminal background check revealed a lengthily criminal history, Since he did not appear as requested in September or October, the ALJ recommended the his application be denied.

18. **Patricia Holman**

Ms. Holman appeared before the ALJ regarding her application for licensure by examination. She completed nursing school in 2007 and has not taken the NCLEX to date. The ALJ recommend the complete a review course before attempting the NCLEX and that she be allowed to test and issued a free and clear license.

19. **Adeola Ajayi**

Ms. Ajayi was rescheduled from the September meeting regarding her application for licensure by examination due to completing school in 2008. She sent a response that she is currently taking a refresher course. The ALJ recommended that her meeting be rescheduled for November.

20. **Cody Allen**

Mr. Allen was requested to appear regarding the positive response on his application for licensure by endorsement. His meeting was rescheduled from September since he did not show up. He did not appear at today's meeting and the ALJ recommended that his application be denied due to action on his OH license.

21. **Pamela Bernhard**

Ms. Bernhardt did not appear before the ALJ to provide more detail about her application for licensure by endorsement. She had been asked to provide more details about the background check for which she had answered no to all questions on her application. Her meeting will be rescheduled to November.

22. **Shana Iuro**

Ms. Iuro appeared before the ALJ regarding a positive response on her application for licensure by examination. She reported an OWI in 2009 and that she served probation that ended 8/25/10. She has contacted ISNAP. The ALJ recommended that she be allowed to test and that she receive an ISNAP evaluation, entering an RMA if eligible. Her license will be issued free and clear once the ISNAP evaluation is complete.

23. **Hayley Elkins**

Ms. Elkins appeared before the ALJ regarding her application for licensure by examination. She has failed the NLCEX 4 times previously and stated she did not fee her nursing program prepared her adequately. The ALJ recommended her application be denied and she may reapply with proof of 95% or higher probability of passing the NCLEX.

24. **Helena Fontaine**

Ms. Fontaine did not appear before the ALJ in September regarding the positive response on her registered nursing license renewal application and was re-scheduled to October 6; she sent a response stating she would not appear and the ALJ recommended denying her license renewal.

25. **Karil Willenbrink**

Ms. Willenbrink was rescheduled from the ALJ in September regarding the positive response on her registered nursing license renewal application and was re-scheduled to October 6. She appeared with her counsel and stated her KY nursing license was disciplined due to failure to destroy narcotics per policy. She also had a documentation/assessment error. She paid a fine, completed CEs, and received a letter of reprimand. She provided a copy of the KY board order. Since she has complied with all terms of that board order, the ALJ recommended that her license be renewed free and clear.

26. **Patti Derr**

Ms. Derr appeared before the ALJ regarding positive response on her R.N renewal application. She reported a termination due to medical error and then falsifying documentation. The ALJ recommended renewing her license on probation for 1 year with 24 CEs which are to be 6 in assessment, 6 in documentation, 6 in ethics and 6 in pharmacology. She must present quarterly supervisor reports or self reports if unemployed.

27. **Angela Corcoran**

Ms. Corcoran was requested to appear before the ALJ to provide more detail about her application for licensure by examination. She had been requested to provide more details about the background check for which she had answered no to all questions on her application. She explained that she had shoplifting charges in 2001 and again in 2003. She stated in 2001 she was with people who shoplifted and was charged for being with them. In 2003 she shoplifted tennis shoes. The ALJ recommended that she be allowed to test and that her license be issued on probation for 1 year with quarterly reports from her supervisor or self reports if not employed.

28. **Holly Longnecker**

Ms. Longnecker appeared before the ALJ regarding her licensure application by examination. She reported a conviction in 2000 for forgery for using her grandmother's checks and for theft for using her own bad checks at a grocery store. She served jail time and completed probation. She states all matters have been resolved. The ALJ recommended that she be

allowed to test and that her license be issued on probation and that she is to have no work in a home health agency during her probation. She is to provide quarterly supervisory reports from her employer or self reports if not employed.

29. **Sue Vanderbeck**

Ms. Vanderbeck's attorney has requested that her personal appearance meeting be rescheduled for October 20.

30. **Cinda Curless**

Ms. Curless requested that her meeting be rescheduled. It will be set for October full board or November ALJ.

31. **Leslie Batty**

Ms. Batty appeared before the ALJ with counsel regarding the positive response on her RN renewal application. She stated she is an NP and there is a pending complaint from a patient who claims she wasn't seen before b/p meds were prescribed. The ALJ recommended that her license status be made Valid to Practice and the matter be referred to the AG's office.

32. **Lisa Scholl**

Ms. Scholl appeared before the ALJ regarding the positive response on her RN license renewal application. She reported reckless driving charge in August 2010 and May 2011 OWI. She stated she has sought alcohol treatment on her own. The ALJ recommended an ISNAP evaluation with an RMA if eligible and that her license is renewed on probation for 6 months with full compliance of the RMA. If not eligible, she can petition for the probation to be lifted after 6 months.

33. **Marcia Ng**

Ms. Ng appeared before the ALJ regarding the positive response on her RN license renewal application. She reported a termination she claims is due to discrimination. When asked why she was told she was being terminated, she stated it was due to delegating her duties to others. She is suing the employer for discrimination and the document she provided stated she was terminated for insubordination. The ALJ recommended that her license be renewed free and clear.

34. **Margaret Resiert**

Ms. Reisert appeared with counsel before the ALJ regarding the positive response on her RN license renewal application. She reported terminations on this renewal and it was noted she reported terminations on her 2005 and 2009 renewals. The latest termination was due to a HIPPA violation when discussing patient care with a doctor in the elevator at work. She provided supporting documentation that she completed HIPPA training. The ALJ recommended that her license be renewed free and clear.

35. **Jill Wagoner**

Ms. Wagoner appeared before the ALJ regarding the positive response on her RN license renewal application. She reported a 2009 DUI right after she renewed her license in 2009. She reported a BAC of .11 and states she completed 1 year probation successfully and provided supporting documents. The ALJ recommended that her license be renewed free and clear.

36. **Carrie Anne Holly**

Ms. Holly appeared before the ALJ regarding the positive response on her expired LPN license renewal application. She reported a September 2009 arrest for conversion due to taking items from a store without paying for them. She is currently on criminal probation. The ALJ recommended renewing her license on probation for the duration of her criminal probation. Ms. Holly stated she is trying to clear her Indiana license so she can get a license in MI.

37. **Taunya Ismail**

Ms. Ismail's attorney requested that her personal appearance be rescheduled to the November ALJ meeting.

38. **Karen Sweet**

Ms. Sweet appeared before the ALJ regarding the positive response on her RN license renewal application. She reported 3 DUIs in May 2008, April 2010 and January 2011. She did not report the 2008 DUI on her 2009 renewal. She stated she has contacted ISNAP to sign an RMA. The ALJ recommended that her license be renewed on probation for the length of the RMA.

39. **Michelle Myers**

Ms. Myers appeared before the ALJ regarding the positive response on her RN license renewal application. She reported she was in full compliance with her RMA through ISNAP and finished it 1/4/11. She also showed documentation that the AG's office has closed investigation of a pending complaint. The ALJ recommended that her license be renewed free and clear.

40. **Bret Givens**

Mr. Givens requested that his personal appearance meeting be rescheduled to the Oct. 20 board meeting.

41. **Kristy Barley**

Ms. Barley appeared before the ALJ regarding the positive response on her RN license renewal application. She reported a termination and that she is in ISNAP and is in full compliance. Her license was previously on probation and the probation was lifted in 2010. The ALJ recommended that her license be renewed free and clear.

42. **Jayne Dodd**

Ms. Dodd appeared before the ALJ regarding the positive response on her RN license renewal application. She reported a termination due to ordering a CT scan without doctor's order based on another nurse's description of a patient's symptoms. The ALJ recommended that her license be renewed free and clear.

43. **Storey Gardner**

Ms. Gardner did not appear before the ALJ as requested regarding the positive response on her RN license renewal. The meeting will be rescheduled for November ALJ.

44. **Kimberly Antrim**

Ms. Antrim appeared before the ALJ regarding the positive response on her RN license renewal application. She reported termination in March 2010 due to not "following core values of the organization" and was not given any explanation. She stated she felt it was a personality conflict. She brought a letter of support from her current supervisor; the ALJ recommended that her license be renewed free and clear.

45. **Sally Stecher**

Ms. Stecher appeared before the ALJ regarding the positive response on her RN license renewal application. She reported a termination due to medication error for reversing tube lines. She stated she had medical problems at the time that led to exhaustion and she made mistakes. She was placed on probation at work and states she didn't know she was signing termination papers following a suspension. The ALJ recommended that her license be renewed free and clear.

46. **Heather Sharpe**

Ms. Sharpe appeared before the ALJ regarding the positive response on her RN license renewal application. She reported a DUI in November 2010 with a BAC of .18. In April 2011 she was placed on probation for 1 year. She states she is compliant with her ISNAP RMA. The ALJ recommended her license be renewed free and clear.

47. **Kelly Toney**

Ms. Toney appeared before the ALJ regarding the positive response on her RN license renewal application. She reported a termination from her first nursing job due to two medication errors in which she gave insulin to the wrong patient and gave too much Darvocet to an elderly patient. The ALJ felt the termination was appropriate in addressing the situations and recommended her license be renewed free and clear.

48. **Patricia Cranford**

Ms. Cranford did not appear before the ALJ as requested regarding the positive response on her RN license renewal application. She sent a response stating she would not appear and had submitted documentation previously regarding her licenses be disciplined in other states. The ALJ recommended that her license renewal be denied.

49. **M. Judy Reardon**

Ms. Reardon appeared before the ALJ regarding the positive response on her RN license renewal application. She reported termination in January 2011 following a 3-day suspension. She felt it was due to retaliation for filing complaints about employer's policies. She was reported to be rude to a patient and to a co-worker. When asked about other terminations, she reported one in 2007 she did not previously report to the board, stating she felt she was exonerated because she was given unemployment benefits. She provided documentation from her previous employer. The ALJ recommended her license be renewed on probation for 6 months with quarterly employer reports of self reports if not employed. She is also to complete CEs as follows: 6 in assessment, 6 in documentation and 6 in cultural diversity.

50. **Ashley Crane**

Ms. Crane appeared before the ALJ regarding the positive response on her RN license renewal application. She reported termination due to documenting falsely that vital signs had been taken when they had not. She stated she did this because she did not want to be reprimanded for not doing them. The termination occurred in July 2011. The ALJ recommended that her license be renewed on probation for 6 months with 2 quarterly reports from her supervisor and that her employer sign the board order. She is also to complete 6 CEs in patient assessment, 6 in documentation, and 12 in ethics.

51. **Monte Wood**

Mr. Wood appeared before the ALJ regarding the positive response on his RN license renewal application. He reported a termination on 8/3/11 due to errors in documentation. He states other people made mistakes but they weren't disciplined. He




stated the mistakes occurred on three patients in one day because the computer did not save the data he had entered. He stated he had been trained on the computer system. The ALJ recommended that his license be renewed.
