- I. **CALL TO ORDER AND ESTABLISHMENT OF QUORUM** **8:30 a.m.**
Kim Cooper, Vice President of the Indiana State Board of Nursing, called the meeting to order at 8:34 a.m. and established a quorum in accordance with IC § 25-23-1-5(b).

- III. **ADOPTION OF THE MINUTES FROM THE AUGUST 18, 2016 MEETING OF THE BOARD**
A motion was made and seconded to adopt the minutes from the August 18, 2016 meeting with the following changed: Number 14. Tammy Broaddrick is an endorsement not an exam. Dekoninck/Russell, 6-0-0, motion carries.
- IV. **INDIANA STATE NURSES ASSISTANCE PROGRAM**
Mr. Chuck Lindquist, Director of ISNAP addressed the board. He supplied the board with INSAP's month report, annual report, and compliance report. Mr. Lindquist addressed the students to inform them what ISNAP is.
- V. **EDUCATION**
A. Indiana University School of Nursing Request for Substantive Change (Dr. Susan Hendricks)
Dr. Hendricks appeared on behalf of the program. Board member Coper asked the number of students involved in the enrollment increase and was told the increase only pertains to the Bloomington campus. Having no other questions, Ms. Cooper moved to approve the request for the curriculum change. Board member Russell seconded. Approved 6-0-0.

B. Results of MJS College site visit and monthly report (Annette Murray)
Annette Murray, Dr. Oranau Ibekie, Jeanette Rivers and two MJS graduates, in addition to several members of the MJS College Board of Directors appeared on behalf of the program. Education Compliance Officer Toni Herron presented the results of the site survey that was done on September 8, 2016. The site visit was prompted by the direction of the Board due to the volume of student complaints both written and in person. Board member Kim Cooper accompanied Ms. Herron on the visit and Mr. Ross Miller of the Board of Proprietary Education also conducted a survey for BPE at the same time. The accreditation level is currently conditional.
In trying to arrange the date of the visit, a change in location was discovered that had not been disclosed to ISBN or BPE prior to the move as required. During the visit, contradictory explanations were received from faculty, administration and students regarding the timing and the necessity of the move. The program is now

located in a strip mall that is reminiscent of a setting similar to a physician's office or clinic. The rooms are very small, with the largest being able to accommodate no more than 10 students. The skills lab has two beds with static manikins, and various other equipment arranged along the outer walls of the room. The site visitors were told that the medium fidelity manikin was stored in a closet since this location did not have enough space to accommodate it. Projection of Power Points are onto a painted wall in the room. Faculty offices are all in one large room which did not contain a telephone at the time of the visit.

A review of the curriculum showed content that was inconsistent. A text in use for an introductory course was seven years old. It also used abbreviations that were incorrect and misleading. Review of course examinations revealed very few alternate format questions as found in NCLEX, even though MJS received previous specific direction from ISBN to increase these type questions. Most questions were at the knowledge and comprehension level and are multiple choice in format. The end of program progression is very lengthy and confusing. It involves ATI book review and an exit exam, followed by 12 weeks of Virtual ATI and another exit exam. Ms. Cooper stated that once the student completes VATI, they are done with the program and cannot be kept longer. Due to the Capstone/ATI process and repeats to meet exit exam benchmarks, most students interviewed could not tell the site visitors their effective graduation date.

There is concern because the abrupt change in locations appears to be another example of MJS failing to conform to the rules of ISBN for nursing education programs. Examples include failure to obtain prior Board approval for pharmacology revisions and extension of program length with VATI. The recommendation of the site visitors include (1) immediate suspension of all admissions; (2) begin proceedings to initiate withdrawal of accreditation and closure of the program and (3) submission of proof of fire inspection.

The program produced evidence of a completed fire inspection for Board review. Ms. Murray, Dr. Ibekie, both of the graduates and one member of the MJS board stated that MJS provided a vital service to an otherwise underserved population and would do whatever was necessary to continue to operate the program. After discussion, Ms. Rock moved to accept the site visitor's report. Board member DeKoninck seconded. Motion passed 6-0-0. Ms. Russell then moved to accept the recommendations of the site visitors. Dr. De Koninck seconded. Motion passed 5-1-0 with Ms. Cooper abstaining.

C. Brown Mackie South Bend monthly written report

The written report was reviewed as submitted. Board member Morrison moved to accept the report as submitted. Board member Russell seconded. Motion carried. 6-0-0.

D. Fortis College monthly written report

1. **Allison Balay** **RN Exam** **Grad Date 2010/Previous Testing Attempts**
Allison Balay appeared for a personal appearance. Ms. Balay applied for an RN license by examination. She has taken and failed the NCLEX three times. Ms. Balay has taken the ATI review course and has received a 97% predictability. ALJ Coto recommends Ms. Balay be allowed to test and upon successfully passing, her license be issued free and clear.
2. **Anya Dehkam** **LPN Endo** **Failure to Disclose**
This matter is to be reset one time.
3. **Lindsay Keepes** **RN Endo** **Positive Response**
Ms. Keepes appeared for a personal appearance. Ms. Keepes applied for an LPN license by endorsement. Ms. Keepes holds an active license in Illinois. She answered yes to question 4 of her application. She was terminated from Wabash Hospital in June 2016 for violation of HIPAA. Ms. Keepes states she looked into a patients' chart while working in SDS department. She states she had to go thru a search to reach her patients and accidentally clicked on another patients charts. Ms. Keepes states she has a job waiting for her in Indiana. Her license has not been disciplined in Illinois. ALJ Coto recommends Ms. Keepes license be issued free and clear.
4. **Colinda Purkett** **RN Endo** **Positive Response**
Ms. Purkett appeared for a personal appearance. Ms. Purkett applied for an RN license by endorsement. She answered yes to question 4 of her application. Ms. Purkett was terminated from her place of employment in Illinois for medication discrepancy. She has been a nurse since 2005 and has made Illinois aware of her termination at the time of her renewal. ALJ Coto recommends Ms. Purkett license be issued free and clear.
5. **Amber Bell** **LPN Exam** **Grad Date 2012/Previous Testing Attempts**
Ms. Bell appeared for a personal appearance. Ms. Bell applied for an LPN license by examination. She graduated September 2012 and has last taken the NCLEX February 2015. Ms. Bell states she has taken Harrison review and is using study guides to prepare herself. This will be the third attempt to pass the examination. ALJ Coto recommends Ms. Bell be allowed to test and upon successfully passing, her license be issued free and clear and if she fails the exam for the third time, she must take a review course.
6. **Yolanda Trent-Lowery** **RN Exam** **Positive Response**
Ms. Trent-Lowery appeared for a personal appearance. Ms. Trent-Lowery applied for an RN license by examination. She graduated in July 2016 and has not taken the NCLEX. Ms. Trent-Lowery was arrested for shop lifting. She was entered into a diversion agreement that consisted of community service, court cost and fees. She completed the program February 2004. ALJ Coto recommends Ms. Trent-Lowery be allowed to test and upon successfully passing, her license be issued free and clear.
7. **Taylor Hill** **LPN Exam** **Positive Response**
Ms. Hill appeared for a personal appearance. Ms. Hill applied for an LPN license by examination. She answered "yes" to question 3 on the application. Ms. Hill pleaded guilty to reckless driving in 2014. She was placed on probation and received a Class B misdemeanor. Ms. Hill states that she thinks her blood alcohol level was .08 at the time of the arrest. She states her last drink was in August 2014 and currently she has completed all terms of the probation and paid all cost and fees associated with the case. Ms. Hill graduated in July 2016 and holds an active CNA certification in Indiana. ALJ Coto recommends Ms. Hill be allowed to test and upon successfully passing, her license be issued free and clear.
8. **Krista Howe** **RN Exam** **Positive Response CONTINUED**
9. **Donald Avery Jr.** **RN Endo** **Positive Response VACATED**
10. **Lindsay Carson** **LPN Endo** **Failure to Disclose**
Ms. Carson appeared for a personal appearance. Ms. Carson applied for an LPN license by endorsement. She failed to disclose the arrest in 2008 for animal cruelty. Ms. Carson failed to take her dog to the veterinarian for

giving her a green light. ALJ Coto recommends Ms. Cox be approved to test upon completion of a review course.

21. **Shonte Kirby** **RN Exam** **Grad Date 2010/Previous Testing Attempts**
Ms. Kirby appeared for a personal appearance. Ms. Kirby applied an RN license by examination. She graduated in 2010 and has taken the NCLEX three times, the last being in 2015. Mr. Coto directed Ms. Kirby to go to website in order to review information for renewal in order to get on board with meeting board standards. Mr. Coto recommends Ms. Kirby completes a review course with a 95% probability of passing the NCLEX. Once received, then she will revisit with the Indiana State Board of Nursing.
22. **Maaria Minardo** **RN Exam** **Failure to Disclose**
Ms. Minardo appeared for a personal appearance. Ms. Minardo applied for an RN license by examination. She graduated in December 2015 and has not taken the NCLEX exam. In 1991 she was arrested for OWI. ALJ Coto recommends Ms. Minardo be allowed to test and upon successfully passing, her license be issued free and clear.
23. **Megan Ziemer** **RN Exam** **Failure to Disclose**
Ms. Ziemer appeared for a personal appearance. Ms. Ziemer applied for an RN license by examination. She graduated in 2014 and has taken the NCLEX exam two times. Ms. Ziemer failed to disclose her 2010 OWI arrest. She states she was never arrested or convicted, but records show that she was arrested and all terms from the arrest were completed. ALJ Coto asked Chuck Lindquist with ISNAP, if Ms. Ziemer would need to be evaluated. Mr. Lindquist states, not at this time since it's been six years. Ms. Ziemer states she has completed Hurst review course. ALJ Coto recommends Ms. Ziemer be allowed to test and upon successfully passing, her license be issued free and clear.
24. **Tracy Jennings** **LPN Exam** **Positive Response**
Ms. Jennings appeared for a personal appearance. Ms. Jennings applied for an LPN license by examination. She answered "yes" to question 4 of her application. Ms. Jennings was terminated from her place of employment for smelling like alcohol. A co-worker noticed the smelled alcohol on Ms. Jennings, reported Ms. Jennings to the supervisor and because she still had an alcoholic container in her car, she was terminated. Ms. Jennings states that a breathalyzer was not conducted. She is currently employed. However, her employer is waiting for licensure in order to employ her as a nurse. Ms. Jennings currently holds a CNA certification and graduated from nursing school in July 2016. ALJ Coto recommends Ms. Jennings be allowed to test and upon successfully passing, her license be issued free and clear.
25. **Jonathan Kim** **RN Exam** **Positive Response**
Mr. Kim appeared for a personal appearance. Mr. Kim applied for an RN license by examination. He answered "yes" to question 3 of her application. Mr. Kim was arrested for operating a vehicle while intoxicated with a blood level of .11. He states she completed an outpatient program and 180 days probation. Mr. Kim graduated August 2016. ALJ Coto asked if he drinks, Mr. Kim stated "occasionally". ALJ Coto recommends Mr. Kim be allowed to test and upon successfully passing, his license be issued free and clear.
26. **Kimberly Hollopeter** **RN Exam** **Grad Date 2013/Previous Testing Attempts**
Ms. Hollopeter appeared for a personal appearance. Ms. Hollopeter applied for an RN license by examination. She graduated May 2013 and has taken the NCLEX three times. ALJ Coto recommends Ms. Hollopeter completes a refresher course with a 95% probability of passing the NCLEX. Once received, then she will revisit with the Indiana State Board of Nursing.
27. **Carol Miller** **Rn Endo** **Positive Response CONTINUED**
28. **Alisa Griffin** **RN Exam** **Positive Response**
Ms. Griffin appeared for a personal appearance. Ms. Griffin applied for an RN license by examination. She answered "yes" to question 3 of her application. In June 2016 Ms. Griffin was arrested for operating a vehicle while intoxicated. ALJ Coto recommends Ms. Griffin be allowed to take the NCLEX. Ms. Griffin must have an ISNAP evaluation. If she meets criteria for an RMA, her license will be issued on probation for the length of her RMA. If she does not meet criteria, her license will be issued free and clear.
29. **Katherine Reaves** **RN Endo** **Failure to Disclose***
Ms. Reaves appeared for a personal appearance. Ms. Reaves applied for a license by endorsement. She failed to disclose a positive response on her application. In June 2011, Ms. Reaves failed to stop at a stop sign. She states she continue to drive to her residence and go inside. She was arrested for obstruction of justice and charged with disorderly conduct. Ms. Reaves holds an active license in Ohio and Kentucky. ALJ Coto recommends Ms. Reaves be allowed to endorse free and clear.
30. **Amy Johnson** **RN Endo** **Failure to Disclose***

Ms. Johnson failed to appear for a personal appearance. Ms. Johnson previously failed to appear on August 4, 2016. Ms. Johnson applied for a RN license by endorsement. ALJ Coto recommends Ms. Johnson's application be denied for failure to appear twice.

31. **Ronan Onita** **LPN Exam** **Grad Date 2012***
Ms. Onita failed to appear for a personal appearance. Ms. Onita applied for a LPN license by examination. Ms. Onita previously failed to appear on August 4, 2016. AJL Coto recommends Ms. Onita be reschedule to appear before the Indiana State Board of Nursing.
32. **Doris Jordan** **RN Exam** **Grad Date 2002/Previous Testing Attempts***
Ms. Jordan failed to appear for a personal appearance. Ms. Jordan previously failed to appear on August 4, 2016. Ms. Jordan applied for a RN license by examination. ALJ Coto recommends Ms. Jordan's application be denied for failure to appear.
33. **Angela Dean** **RN Exam** **Failure to Disclose***
Ms. Dean failed to appear for a personal appearance. Ms. Dean applied for a RN license by examination. This is Ms. Dean's second failure to appear and she is requesting approval to take the NCLEX for the third time. Ms. Dean failed to disclose a positive response on her application. She was charged with unlawful use of weapon. ALJ Coto recommends Ms. Dean's application be denied for failure to appear.
34. **Nancy Monfiston** **LPN Exam** **Grad Date 2012/Previous Testing Attempts***
Ms. Monfiston appeared for a personal appearance. Ms. Monfiston applied for a LPN license by examination. She graduated in October 2012 and has taken NCLEX through Illinois three times. Her last attempt to pass the exam was February 15, 2015. Mr. Coto informed her that she is not allow to test until she takes a refresher course. Ms. Monfiston states she has taken a review course in February 2016. Mr. Coto instructed her to submit the predictability. Mr. Coto recommends Ms. Monfiston completes a review course with a 95% probability of passing. Once received, she will be allowed to test and upon passing, her license will issued free and clear.
35. **Shakia Lewis** **RN Exam** **Failure to Disclose***
Ms. Lewis failed to appear for a personal appearance. Ms. Lewis previously failed to appear on August 4, 2016. Ms. Lewis applied for a RN license by examination. This is Ms. Lewis's second failure to appear. She graduated in May 2016 and holds an active LPN license in Illinois and Indiana. ALJ Coto recommends Ms. Lewis's application be denied for failure to appear.
36. **Christine Pinkard** **RN Exam** **Previous Testing Attempts/Positive Response***
Ms. Pinkard failed to appear for a personal appearance. Ms. Pinkard previously failed to appear on August 4, 2016. Ms. Pinkard applied for a RN license by examination. This is Ms. Pinkard's second failure to appear and fourth attempt to pass the NCLEX. She graduated in December 2013. ALJ Coto recommends Ms. Pinkard's application be denied for failure to appear.
37. **Tasia Cohen** **LPN Exam** **Failure to Disclose***
Ms. Cohen appeared for a personal appearance. Ms. Cohen applied for a LPN license by examination. She graduated in April 2010 and has taken the NCLEX in Illinois in June 2010. Six years has passed since the last time Ms. Cohen has taken the NCLEX. She currently holds an active CNA certification. Ms. Cohen was arrested in July 2013 for damages to property. Charges were dismissed August 2013. ALJ Coto recommends Ms. Cohen completes a review course with a 95% probability of passing. Once received, she will be allowed to test and upon passing, her license will issued free and clear.
38. **Jeremy McDaniels** **LPN Exam** **Positive Response**
Mr. McDaniels appeared for a personal appearance. Mr. McDaniels applied for a LPN license by examination. He answered "yes" to question 3 of the application. Mr. McDaniels was arrested in 2012 for disorderly conduct and resisting arrest. He was placed on probation for 363 days, 12 weeks of anger management counseling, and 40 hours of community service. Mr. McDaniels presented the board with character reference letters that are not signed, ALJ. Coto informed Mr. McDaniels that they weren't accountable because of no signature. ALJ Coto recommends Mr. McDaniels be allowed to test and upon successfully passing, his license be issued free and clear.
39. **Tiffanie Scott-Cook** **LPN Exam** **Previous Testing Attempts**
Ms. Scott-Cook appeared for a personal appearance. Ms. Scott-Cook applied for a LPN license by examination. She graduated in 2013 and has taken the NCLEX examination four times. Ms. Scott-Cook states she has taken the Kaplan review in 2015 and received a 95% probability of passing. She states she has passed two sections of the exam. ALJ Coto states he cannot approve her to re-take the NCLEX until she has taken a review course and receives a passing predictability. Once this is done she will be allowed to test and her license is to be issued free and clear.

40. **Ashely Hinen** **RN Exam** **Grad Date 2006/Previous Testing Attempts**
 Ms. Hinen appeared for a personal appearance. Ms. Hinen applied for a RN license by examination. She graduated in May 2006 and has taken the NCLEX examination twice. ALJ Coto recommends Ms. Hinen completes a review course with a 95% probability of passing. Once received, she will be allowed to test and upon passing, her license will issued free and clear.
41. **Michelle Hein** **RN Exam** **Positive Response- FULL BOARD**
 Ms. Hein appeared for her personal appearance regarding her application for licensure. She graduated August 2016. She answered yes to question number 3. She was arrest in July 2013 for drinking and driving. She hit a parked car. Her BAC was .14. She went to court in December 2013. She plead guilty. She was on probation for a year. She successfully completed all the requirements of the probation. This was a wakeup call for her. She learned that she wanted to do better and she didn't want her life to be about drinking. She had a problem with drinking but does not currently. She struggled with drinking a lot her first two years of college. She has not been arrested for anything else. A motion was made to allow her to test. Her license will be issued on probation with the following terms: must have an ISNAP evaluation, six months of active practice, quarterly reports. Her probation will last the length of an RMA or the six months active practice, whichever is longer. Cooper/Russell 5-0-0, motion carries.
42. **Eric Vicars** **RN Exam** **Positive Response**
 Mr. Vicars appeared for a personal appearance. Mr. Vicars applied for a RN license by examination. He answered "yes" to question 3 of the application. Mr. Vicars was arrested for DUI in 2015. He states he had no alcohol in his system. After blowing .00 in the breathalyzer, the officer asked when was the last time he smoked marijuana, he replied five hours before getting pulled over. Mr. Vicars was arrested for possession of marijuana, possession of paraphernalia, and operating a vehicle while intoxicated. He was charged with OWI. He spent 18 days in jail, paid fines, and he's driver license suspended for 60 days. Mr. Vicars has been released from probation since December 6, 2015. He graduated in April 2014 and has taken the NCLEX examination once. Mr. Vicars presented character reference letters to Mr. Coto. ALJ Coto recommends Mr. Vicars be allowed to take the NCLEX. He must have an ISNAP evaluation. If he meets criteria for an RMA then his license will be issued on probation for the length of the RMA. If he does not meet criteria then his license will be issued free and clear.
43. **Ann Pell** **RN Exam** **Positive Response**
 Ms. Pell appeared for a personal appearance. Ms. Pell applied for an RN license by examination. She answered "yes" to question four of the application. Ms. Pell was reprimanded due to not following the instructions of documenting a patients charts correctly. She graduated in July 2016. ALJ Coto recommends Ms. Pell be allowed to test and upon successfully passing, her license be issued free and clear.

 Ms. Adams failed to appear for her personal appearance regarding her application for renewal. Ms. Adams previously failed to appear on August 4, 2016. This is the second time she has failed to appear. ALJ Coto recommends Ms. Adams application for renewal be denied.
2. **Jerri Clinkenbeard** **LPN Renewal** **Failure to Provide Statement**
 Ms. Clinkenbeard appeared for a personal appearance regarding her application for renewal. She was arrested in December 2014 for OWI. Ms. Clinkenbeard went to an afternoon Christmas party where she had margaritas. On her drive home the car got stuck in mud. When officers showed up, she was standing outside the car. She was asked if she had been drinking, she stated "yes" and was arrested. Mr. Lindquist with ISNAP asked about her blood alcohol level. She stated it was .08. Mr. Coto asked if she, at any time contacted ISNAP. She said she called and because she hadn't had a court date, to mark yes on her renewal. Mr. Lindquist states since it's been two years and she's completed everything associated with case, she wouldn't need an RMA. ALJ Coto recommends Ms. Clinkenbeard's license be renewed free and clear.
3. **Amanda Wood** **LPN Renewal** **Positive Response**
 Ms. Wood appeared for a personal appearance regarding her application for renewal. She answered "yes" to question 5 on the renewal. Ms. Wood was terminated for not charting and/or documenting. ALJ Coto asked if anyone died, was hospitalized, or injured. Ms. Wood replied "no". Mr. Coto recommends Ms. Wood license is renewed free and clear.
4. **Vickie Morris** **LPN Renewal** **Positive Response**

Ms. Fulford appeared for her personal appearance regarding her application for licensure. She has taken the NCLEX three times. She has been taking the Hurst review and using you world. ALJ Coto recommends that she complete a review course and provide documentation showing that she has at least a 95% chance of passing. Once this documentation is submitted she will be allowed to test. Upon successful passage her license is to be issued free and clear.
2. **Amanda Johnson RN Exam Grad Date 2002/Previous Testing Attempts**
Ms. Johnson failed to appear for her personal appearance. This matter is to be rescheduled one time.
3. **Sureece Jeffers LPN Exam Positive Response**
Ms. Jeffers appeared for her personal appearance regarding her application for licensure. She graduated from school in January 2016. She answered yes to number 3 on her application. She has had two DUIs, one in 2012 and the other in 2014. She has completed everything that needed to be done with the criminal court. Ms. Jeffers provided a copy of her limited criminal history for review. Due to two DUIs within two years ALJ Coto recommends that she be allowed to take the NCLEX. She must have an ISNAP evaluation. If she meets criteria for an RMA then her license will be issued on probation for the length of the RMA with quarterly reports. If she does not meet criteria then her license is to be issued free and clear.
4. **Varinder Khehra LPN Exam Positive Response**
Ms. Khehra appeared for her personal appearance regarding her application for licensure. She graduated from school in 2016. In October 2015 she was charged with theft. She had to complete 24 hours of community service. There were no fines or probation. She provide court documents to be reviewed. Due to the fact that she is not on criminal probation and completed her community service, ALJ Coto recommends that she be allowed to take the NCLEX. Upon successful passage her license is to be issued free and clear.
5. **April Gosnell RN Exam Previous Testing Attempts**
Ms. Gosnell appeared for her personal appearance regarding her application for licensure. She has previously taken the NCLEX. Since the last time she tested she has taken the Kaplan review. She provided the board with the 95% predictability document. Due to the fact that she has taken the review and provided the board with documentation, ALJ Coto recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.
6. **Mollie Pajakowski RN Exam Positive Response**

She had a charge for public intoxication. She pled guilty and paid a \$25.00 fine. This was her first offense. She provided court documents for the board to review. Due to the fact that this was her only issue, it took place 10 years ago, and she is currently in the process to get it expunged, ALJ Coto recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.

9. Kelly Tiemens RN Exam Failure to Disclose
Ms. Tiemens appeared for her personal appearance regarding her application for licensure. She failed to disclose that she had let a friend use ID her when she was 19 years old. The matter was dismissed on the State's motion. This happened over 13 years ago. ALJ Coto recommends she be allowed to test. Upon successful passage her license is to be issued free and clear.
10. Danielle Afton RN Exam Positive Response
Ms. Afton appeared for her personal appearance regarding her application for licensure. She graduated from school in 2014 and has tested twice. In 2011, she had a criminal matter that involved her taking a vicodin. She completed her criminal probation in May 2011. This happened during a very bad time in her life. She went to Fairbanks for treatment. Due to this being her only issue, ALJ Coto recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.
11. Kaila Crager RN Exam Positive Response
Ms. Crager appeared for her personal appearance regarding her application for licensure. She answered yes to question number 5 on her application. One of her employees took a video of a resident and she did not report it. She was terminated for not being an advocate for her patient. She has learned from this mistake. ALJ Coto recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.
12. Joyce Madison RN Endo Failure to Disclose
Ms. Madison appeared for her personal appearance regarding her application for licensure. She is currently licensed in Virginia. Her home state is South Carolina. Her Virginia license is current with no restrictions. She has never had any discipline or restrictions on any license. She failed to disclose a 1998 issue on her application. Due to the time frame of this issue and the fact that she has never had issues with her license, ALJ Coto recommends the endorsement of her license free and clear.
13. Lomita Wilson LPN Exam Positive Response
Ms. Wilson appeared for her personal appearance regarding her application for licensure. She graduated from school in 2015. She answered yes to question number 3. She was arrested on a bench warrant due to truancy and neglect of a dependent. She was arrested on a Saturday and bonded right out. She was never on any type of criminal probation. Her daughter was in jail at the time she was arrested. Nothing ever happened with the criminal matter. Due to the fact that the criminal matter was dropped, ALJ Coto recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.
14. Johnna Zarazee RN Endo Failure to Disclose
Ms. Zarazee appeared for her personal appearance regarding her application for licensure. She currently has a license in Kansas and Kentucky. These are active, with no restrictions or under any kind of investigation. In 2014, she was charged with assault. This happened during a dispute between her and her spouse, at their house. This occurred in Kentucky. She renewed her Kentucky license last year and her Kansas license in 2014. She was ordered to complete a domestic violence class. Once this was done, that matter was dismissed. She provided documentation showing that this was completed. She would like an Indiana license because she is a travel nurse. ALJ Coto recommends that her license be issued free and clear.
15. Aaron Jackson LPN Exam Positive Response
Ms. Jackson appeared for her personal appearance regarding her application for licensure. She was arrested for driving while on a suspended license. She spent six days in jail. She is not on criminal probation. Her license was suspended due to not having any insurance. She currently has her license back. ALJ Coto recommends that she be allowed to take the NCLEX. Upon successful passage her license is to be issued free and clear.
16. Ellen Smith RN Endo Failure to Disclose
Ms. Smith appeared for her personal appearance regarding her application for licensure. She is a travel nurse with a license in Illinois, Maryland, and New York. In 1995 there was a warrant for her arrest due to a fight with her boyfriend. Her boyfriend hit her, and she went to hit him back, a bouncer got in-

between them. The prosecutor did not follow up on the issue. This happened in Illinois. There has been no issues on her license. Due to the time frame and the fact that her licenses are free and clear, ALJ Coto recommends her license be endorsed free and clear.

17. **Kimberly Davis RN Exam Positive Response**
Ms. Davis appeared for her personal appearance regarding her application for licensure. She graduated in 2016. She answered yes to number 3 on her application. She received a DUI in 2005. She kept driving after her license was suspended, and she kept getting into trouble for it. The last time she got in trouble was 2009. In 2009, she was charged with possession of marijuana. She completed her criminal probation in 2011. Since this time she has started going to church and turned her life around. She does not drink or smoke anymore. She provided character references for the board to review. Due to the time frame of the matter, ALJ Coto recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.
18. **Lexis Henriques RN Exam Failure to Disclose**
Ms. Henriques appeared for her personal appearance regarding her application for licensure. She graduated in May 2016. She submitted her application in January of 2016, and at that time, she could answer no to all of the questions. In February 2016, she was involved in an accident and was charged with leaving the scene of an accident. She had sideswiped another car. She was going down to turn around and return to the accident. Before she made it back to the site, a police officer pulled her over. Alcohol and/or drugs were not involved in this matter. She entered into a plea agreement. She completed community service. She failed to disclose an incident that took place in 2001. She was 19 at the time. She took a cab but did not have enough money to cover the fare. She called her grandma who was bring over the rest of the money needed. The cab driver did not want to wait and called the cops. There were no charges filed. Due to the fact that no charges were filed, ALJ Coto recommends that her license be endorsed free and clear.
22. **Cynthia Cox RN Exam Grad Date 2010/Previous Testing Attempts**
Ms. Cox appeared for her personal appearance regarding her application for licensure. She graduated in 2010 and has taken the NCLEX 4 times. The reason for a gap in between taking the test was due to her son being young. He is older now, and she can devote more time to studying. She took a review course in January, but due to paperwork, she didn't test until April. She has audited classes for help. On her last exam, she was passing in some and near passing in all. ALJ Coto recommends that she take a review course and provide the board with documentation showing she has at least a 95% chance of passing. Once that is received, she will be allowed to test. Upon successful passage she is to be licensed free and clear. It is recommended that she take a refresher course before practicing.
23. **Simone Billings RN Exam Grad Date 2007/Previous Testing Attempts**
Ms. Billings appeared for her personal appearance regarding her application for licensure. She has an LPN license in Michigan. She cannot take the NCLEX for her RN anymore in Michigan so she would like to take it in Indiana. She currently works in Michigan as an LPN. She last took the NCLEX in 2010. ALJ Coto recommends that she take a review course. She must submit documentation showing she has at least a 95% chance of passing. Once this is received she will be allowed to test. Upon successful passage her license is to be issued free and clear.
24. **Brittany Marten LPN Endo Failure to Disclose***
Ms. Marten failed to appear for her personal appearance. Her application is denied.

25. **Kimberly Lee RN Endo Failure to Disclose***
Ms. Lee failed to appear for her personal appearance. Her application is denied.
26. **Yolanda Slaughter RN Exam Grad Date 2009**
Ms. Slaughter appeared for her personal appearance regarding her application for licensure. She graduated in 2009. She currently has an LPN license in Illinois. She has taken the NCLEX the maximum times in Illinois for her RN license. She is currently taking the Kaplan review course. In 2013, she was arrested for driving on a suspended license. Her license was suspended due to an unpaid ticket. She paid the fine and her license was reinstated. She received a Letter of Reprimand from the Illinois Board of Nursing for failure to document in a patient's chart. ALJ Coto recommends that she provide documentation showing she has at least a 95% chance of passing the NCELX. Once this is received she will be allowed to test. Upon successful passage her license is to be issued free and clear.
27. **Kadie Maier LPN Exam Positive Response**
Ms. Maier appeared for her personal appearance regarding her application for licensure. She answered yes to question number 3. In 2005, she was charged with minor consumption. That case was closed. In 2010, she had a DUI. She doesn't remember her BAC but remembers it was high. She has completed her criminal probation. She was on probation for a year, took alcohol classes, and group counseling. Robin Riebsomer, Intake Coordinator with ISNAP, does not believe she would meet criteria for an ISNAP RMA. She no longer drinks. Due to the fact that she would not meet criteria for ISNAP and she successfully completed her criminal probation, ALJ Coto recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.
28. **Melissa Weber RN Endo Failure to Disclose**
Ms. Weber appeared for her personal appearance regarding her application for licensure. She currently holds a RN license in Illinois. She works as a hospice nurse. She failed to answer yes to question number 3. In 1999, she was pulled over. There was a bb gun in the glove box. She had to remove the bb gun to get the registration. The police officer thought it was a real gun. There were no charges ever filed. She did not realize this was on her record. Due to the time frame of the matter, ALJ Coto recommends her license be issued free and clear.
29. **Jonathon Sullivan LPN Endo Failure to Disclose**
Mr. Sullivan appeared for his personal appearance regarding his application for licensure. He currently has an active LPN license in Kentucky. He also has an expired SRNA license in Kentucky. His Kentucky license does not have any discipline against it. He failed to answer yes to question number 3 on his application. When he was 18 years old he was charged with shoplifting from Walmart. He completed a diversion program and the charges were dismissed. ALJ Coto recommends his license be issued free and clear.
30. **Benjamin Karikari RN Exam Previous Testing Attempts CONTINUED**
31. **Hannah Watkins LPN Exam Positive Response**
Ms. Watkins appeared for her personal appearance regarding her application for licensure. She answered yes to question number 3 on her application. Two weeks before her 21 birthday she was at the Kentucky Derby. She received a ticket for minor possession. She had to complete 5 hours of community service. Due to completing her community service, ALJ Coto recommends she be allowed to test. Upon passage her license is to be issued free and clear.
32. **Karina Baltazar-Martinez RN Exam Grad Date 2011/Previous Testing Attempts**
Ms. Baltazar-Martinez appeared for her personal appearance regarding her application for licensure. She has taken the NCLEX twice. The last time she took it, it shut off at 81 questions. She was way below standard. She took a live on site Kaplan review. ALJ Coto recommends that she complete a review course. She must submit documentation showing she has at least a 95% chance of passing. Once this document is submitted she will be allowed to test. Upon successful passage her license is to be issued free and clear.
33. **Karryn Walker RN Endo Failure to Disclose**
Ms. Walker appeared for her personal appearance regarding her application for licensure. She currently has a license in Michigan that is in good standing. She checked no to question number 3 on her application. In 2007, she was charged with careless driving. She was pulled over after crossing the

centerline. Her driver's license was on probation for 90 days and she paid a fine. ALJ Coto recommends her license be issued free and clear.

34. Orlando Longoria RN Exam Previous Testing Attempts
Ms. Longoria appeared for her personal appearance regarding her application for licensure. She has tested 3 times. She has an inactive CNA license. She provided documents showing some of the testing she has been doing. She previously took the Kaplan review. ALJ Coto recommends that she complete a review course. She must provide documentation showing she has at least a 95% chance of passing the NCELX. Once this documentation is submitted she will be allowed to test. Upon successful passage her license is to be issued free and clear.
35. Lisa Craven RN Endo Positive Response **CONTINUED**
36. Kristina Perry LPN Exam Positive Response
Ms. Perry appeared for her personal appearance regarding her application for licensure. She answered yes to question number 3 on her application. In 2011, she was charged with consumption of alcohol. The matter was dismissed after she completed a deferral program. This was her only issued. ALJ Coto recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.

Ms. Barrow appeared for her personal appearance regarding her application for licensure. She answered no to question number 3 on her application. In 1987, she was charged with retail theft. She thought the matter was expunged. She was 18 at the time. This is the only issue she has ever had. ALJ Coto recommends that she be allowed to test and her license be issued free and clear.
38. Ibrahim Drammeth LPN Endo Failure to Disclose
Mr. Drammeth appeared for his personal appearance regarding his application for licensure. He has an active license in Maryland that is unencumbered. He has an expired license in District of Columbia and Virginia. He failed to disclose a positive response on his application. In 2014, he had a domestic abuse charge that was thrown out. In 2015, he had a domestic abuse charge that went to trial and he was found not guilty. In 2016, a restraining order was issued. He and his wife are still married. They are trying to work on their marriage. They have been married for 26 years. He states he does not have an anger management problem. They are currently attending counseling with their church. Maryland is aware of these issues. ALJ Coto recommends that his license be issued free and clear.
39. Krista Howe RN Exam Positive Response
Ms. Howe appeared for her personal appearance regarding her application for licensure. Six years ago, she had a physical altercation with a female acquaintance at her boyfriend's apartment. She spent the night in jail. No charges were filed in the matter. She has not had any other issues. ALJ Coto recommends that she be allowed to test. Upon successful passage her license is to be issued free and clear.

If she meets criteria for an RMA her probation will be for the length of the active practice or the RMA, whichever is longer. Ms. Rudisill agrees to the terms of this probation.
2. Stephanie Trueblood LPN Renewal Positive Response
Ms. Trueblood appeared for her personal appearance regarding her application for renewal. She was arrested in 2014 for marijuana, paraphernalia, and legend drugs. Her criminal matter was not finalized until 2016. She is on criminal probation until 2017. She did complete a 2 year RMA. She did not work while she was in her RMA. She has been sober since 2014. She still has a sponsor and attends AA meetings. She provided documents to be reviewed. ALJ Coto recommends that her license be renewed on probation with the following terms: Active practice while on criminal

probation, quarterly reports, signed board order, completion of criminal matter, and completion of a one year RMA. Ms. Trueblood agrees to the terms of this probation.

They thought she did not spend enough of time with a juvenile patient. She has not had any issues with her license. She provided documents to be reviewed. She had a rocky start in ISNAP but has been in full compliance for the last year. She has been at her current job for a year and a half. She is still completing her criminal probation. ALJ Coto recommends that her license be renewed on probation with the following terms: completion of her ISNAP RMA, completion of criminal probation, quarterly reports, and signed board order. Ms. Sisk agrees to the terms of this probation.
7. **Aimee Main RN Renewal Positive Response**
Ms. Main appeared for her personal appearance regarding her application for renewal. Her license has been expired in Indiana since 2005. She had a Florida license that she surrendered in 2011. After her daughter passed away she began drinking. She then went to rehab. She was in the Florida's IMP program. She found out she was pregnant. At that time she was overwhelmed and didn't want to deal with her nursing license so she surrendered it. The last time she practiced was 2010. She submitted documents to be reviewed. She still attends AA and is very involved in her recovery group. ALJ Coto recommends that her license be renewed on probation with the following terms: six months active practice, quarterly reports, signed board order, ISNAP evaluation. If she meets criteria for an ISNAP RMA the probation will last for 6 months active practice or the length of an RMA, whichever is longer. Ms. Main agrees to the terms of this probation.
8. **Barbara Andrews RN Renewal Expired over 10 year**
Ms. Andrews appeared for her personal appearance regarding her application for renewal. Her license has been expired since 2003. She last worked as a nurse over 15 years ago. She let it expired due to having a job in another field. ALJ Coto recommends that she complete a refresher course with a clinical component. Once this has been completed she will be renewed free and clear.
9. **Lynne Benson LPN Renewal Positive Response**
Ms. Benson appeared for her personal appearance regarding her application for renewal. She answered yes to question number 5 on her renewal application. She left a TB needle in the room where she was doing the test. The cap was on the needle. She works at an adult daycare. This happened in June 2016. ALJ Coto recommends that she complete some continuing education regarding knowing her surroundings and medication. Her license is to be renewed free and clear.
10. **Shawn Tabelman LPN Renewal Positive Response**




