#### IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT

Ernest Klein, Executive Director of the ISNAP Program, presented the monthly report to the Board. Mr. Klein informed the Board that the program is fully staffed and up and running. They have hired Roxanne Thomas as a Case Manager and Mary Schroeder as Assistant to the Case Managers. Mr. Klein informed the Board that twenty RMA's have been completed and returned and ten have been sent out and are waiting to be returned. Mr. Klein also explained to the Board that they are working to straighten out the backlog from the previous contractor of the program. Upon request of the Board, Mr. Lindquist, explained the ISNAP program to the nursing students present in the audience.

#### V. EDUCATION

##### A. Indiana Graduate School of Management

Corey Dabney, CEO of Indiana Graduate School of Management, presented an application for accreditation to the Board. Mr. Dabney explained the philosophy and purpose of the school to the Board. He stated that the scholarship fund is currently the only program that they have available to students and that the IGSM loan is a loan within their organization available to students. He informed the Board that they also have other programs, such as, Bachelors in Business Program, MBA Degree Program, and several certificate degree programs.

Mr. Dabney explained that they have one entrance exam. They also do not have any remedial courses for students. If a student does not meet the minimum requirements, they would not be accepted into Indiana Graduate School of Management. Indiana Graduate School of Management would refer them to another college, such as, Ivy Tech. Mr. Dabney informed the Board that they currently have two full time faculty members and fifteen part time faculty members. They also have a part time secretary that is currently handling two programs. The Board informed Mr. Dabney that according to the rules the majority of the faculty must be full time and full time means with the school not with employment. The Board questioned the facility and nursing labs. Mr. Dabney informed the Board that the campus office is located in the same location as the classrooms. The nursing labs will be at Bishop Knowles Institute, which is located ten to twelve miles from the facility. Mr. Dabney explained that they would like to admit their first class of approximately thirty students in January 2006. Beginning in 2007 they would like to admit approximately thirty students three times a year, January, May, and September. The Board requested that Mr. Dabney submit a more specific and clearer report explaining the areas that were misunderstood.

Ms. Glyshaw appeared before the Board. The Board stated that Ms. Glyshaw has been compliant with her probation order. The Board stated that she may reappear in less than six months if she wants.

Ms. Rambo appeared before the Board regarding the positive response on her renewal application. Ms. Rambo was recently incarcerated and released on parole on February 28, 2005. She was charged with a Class D Felony for heroin. Heroin was her drug of choice. Ms. Rambo's date of sobriety is November 30, 2003. She stated that she attends counseling and has completed three substance abuse programs. Ms. Slagle and Ms. Little recommended the Board renew Tracy Lynn Rambo's application for renewal pending the results of an evaluation by ISNAP.

**1. Nikki Jade Lee – Examination Applicant**

Ms. Lee appeared before the Board regarding the positive response on her examination application. Ms. Lee was charged with operating a vehicle while intoxicated. The charges were dropped on May 31, 2005. Ms. Lee provided documentation to Ms. Slagle and Ms. Little regarding the charges being dropped. Ms. Slagle and Ms. Little recommended the Board approve Nikki Jade Lee's application for examination.

**2. Jonnea R. Dye – Examination Applicant**

Ms. Dye appeared before the Board regarding her positive response on her examination application. Ms. Dye was charged with operating a vehicle while intoxicated in 1994, criminal conversion in 1998 and driving while intoxicated on February 2, 2005. Ms. Dye has already contacted ISNAP and ISNAP has set up an RMA for her to sign. Ms. Slagle and Ms. Little recommended the Board approved Jonnea R. Dye application for examination.

**3. Jamie Michael Carter – Examination Applicant**

Mr. Carter appeared before the Board regarding the positive response on his examination application. Mr. Carter was charged with operating a vehicle while intoxicated in 1995. Mr. Carter stated that a person died in his car. Mr. Carter was arrested in 1999 for fleeing and for operating a vehicle while intoxicated. He informed Ms. Slagle and Ms. Little that he has not had any charges since 1999. Mr. Carter stated that he worked as a CNA for eighteen months prior to going to nursing school. Ms. Slagle and Ms. Little recommended the Board make Jamie Michael Carter eligible to take the exam and refer him ISNAP for an evaluation.

**4. Wendy Harsha – Examination Applicant**

Ms. Harsha appeared before the Board regarding the positive response on her examination application. Ms. Harsha received a ticket for public intoxication on August 5, 1990. In 1993 Ms. Harsha had cashed a check for her friend in the amount of \$300.00. She was charged with theft and receiving stolen property and attempted theft. Ms. Harsha was charged with a DUI on September 18, 1994. She stated that she began drinking around the age of thirteen. Her date of sobriety is October of 2000. Ms. Harsha stated that she does not attend AA meetings any longer and has a good support system. Ms. Slagle and Ms. Little recommended the Board make Wendy Harsha eligible to take the exam and refer her to ISNAP for an evaluation.

**5. Lisa Polak – Examination Applicant**

Ms. Polak appeared before the Board regarding the positive response on her examination application. Ms. Polak entered a drug rehab program in Cincinnati Ohio in the fall of 1988. On August 11, 1989 Ms. Polak was charged with prostitution, possession of and possession for sale of cocaine in Hamilton Ohio. She was fined and given probation with six months sentence suspended. On October 5, 1991 she was charged with trafficking of cocaine and contempt of court. She received a five year suspended sentence, five years of probation, and random drug testing. Ms. Polak stated that her sobriety date is November 17, 1989. She fulfilled all of her obligations of her probation in 1995. Ms. Slagle and Ms. Little recommended the Board approve Lisa Polak's application for examination.
