**INDIANA STATE NURSES ASSISTANCE PROGRAM**

Donna Goch, Program Director of the Indiana State Nurses Assistance Program (ISNAP) was present. Donna Goch reported that there are a total of 360 nurses being actively monitored. Donna informed the Board that educational outreach continued to be a priority. Ms. Goch and the Board briefly discussed pain management. They will continue this discussion in approximately two months.

## DISCUSSION

Renewal application of Rhonda Reddy Davis – Respondent was present, and was represented by Joan Isaacs regarding this matter. Ms. Reedy appeared before the Board in August 2003 concerning a yes response on her renewal application. Ms. Isaacs explained to the Board that Ms. Reddy appeared before the Board in January 2002, concerning this renewal application. The Board at that time moved to neither renew nor deny but referred it to the Attorney General’s Office for an expedited investigation. It has been over a year and nothing has been resolved. Ms. Reddy explained to the Board in 1999 she was fired from Methodist for a blood administration error. They have a no tolerance policy on blood administration errors. She also explained that the patient was not hurt in any way due to her error. She also explained that while she was working at a different facility a patient fell out of bed and hung himself. She was the manager on duty when this happened. She indicated that she was fired from the facility two weeks later but this death was never mentioned in relationship to her termination. At the August 21, 2003 Board meeting Ms. Davis’s request for renewal was denied. The Board further requested that the Attorney General’s Office do an expedited investigation. At this time the Attorney General’s Office has not filed charges therefore Ms. Isaacs requested that the Board to renew Ms. Reddy’s license. After discussion, the Board moved to RENEW Ms. Davis’s license on PROBATION for a period of three (3) months with terms and conditions.

Correspondence from the Indiana State Department of Health RE: Renal clinics providing nursing services by unlicensed staff

Lana Richmond, BSN, RN, BC represented the State Department of Health regarding this matter before the Board. Ms. Richmond requested that the Board give an advisory opinion concerning unlicensed staff performing duties such as administration of medication by intravenous and subcutaneous injections and performing nursing assessment and executing the regime. Ms. Richmond explained that during surveys of End Stage Renal Clinics, it was found that unlicensed technicians were performing such duties as mentioned above. The techs have no medical background and very little on-the-job training. She also informed the Board that 8 out of 10 times there have been errors in the draw-ups, and this caused patient harm. The RNs supervise the techs. She stated that the RNs are not doing a very good job of supervising, with delegation being a key problem. The RN is not available at times and does not check the work that the tech has performed. Ms. Richmond informed the Board that the State Department of Health is taking steps to combat the problem and that they will be filing complaints on the RNs that are doing the supervising. Ms. Richmond will supply the Board with a copy of the survey report and information regarding pending lawsuits. She also informed the Board that at this time the surveys are done once a year, but with the budget cuts it is likely to go to every three (3) years. She respectfully requests the Board's opinion on this matter. Ms. Peters expressed her concern that an RN is not always on site and that indeed some of these functions are that which an RN should be performing, not an unlicensed tech. The Board informed Ms. Richmond that they will take this matter under advisement and they will inform her of their opinion.

Correspondence from Desiree Walker RE: Request to reconsider Permanent Voluntary Surrender of License – Ms. Walker did not appear in person and was not represented by counsel regarding this matter. Ms. Walker's letter requested a hearing to have her license reinstated. Her final order states that it was a permanent voluntary surrender. Upon advise of counsel and after discussion the Board moved to DENY Ms. Walker's request and ordered that the final order stand as it is.
