#### IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT

Charles Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of August, 2006, 438 active clients, 23 new intakes, 59 intakes in process and 11 RMA's returned.

Mr. Lindquist invited the Board to the upcoming ISNAP Fall Conference, "Impaired Nurses – Reclaiming Careers" will be on September 29, 2006. The conference is, in part, a fund raiser for the "scholarship fund" to assist clients with their urine drug screens and monitoring.

Mr. Lindquist also informed the Board of the recent staff change. Mary Schroeder, Case Manager Assistant, has decided to pursue her master's degree in nursing and has resigned from ISNAP. Devan Crowder has been hired to replace her.

Mr. Lindquist informed the Board that he is continuing to conduct in-service trainings for workplaces, EAP's, schools, etc. He is currently scheduled for St. John's Hospital in Anderson and for new hires at Methodist Hospital in Indianapolis.

Mr. Lindquist also invited the Board members to attend the quarterly provider meeting at St. Francis Hospital on October 24, 2006. Mr. Lindquist addressed the audience about the ISNAP program at the request of the Board.

**V. EDUCATION**

**A. MedTech College – Report of Survey Visit** Ann Parker and Traci Little arrived.

Margaret Broadus and Mary Harmon appeared before the Board on behalf of MedTech College. Paulette Worcestor conducted a site visit on August 28, 2006. Paulette found that the nursing lab does not have a sink with running water. The administrator confirmed that plans do include some remodeling to include a sink.

The course Medical Law, Ethics and Liability is the same one taken by medical assistants and has a medical focus rather than a nursing focus. Ms. Broadus stated that they have changed this and it is now called Law in Nursing, which focuses more on nursing.

The Board asked them about their clinical sites. Ms. Broadus informed the Board that they will be using six clinical sites and already have some of those in place.

The Board discussed their concern regarding the PSB test being used as an admissions test with Ms. Broadus and Ms. Harmon.

Ms. Broadus informed the Board that they plan on admitting nineteen to twenty students four times a year.

A motion was made and seconded to approve MedTech College's survey visit and place them on initial accreditation.

**C. Ivy Tech Community College, Gary – Request for Generic ASN Program in 2007**

Gail Smith-Estes appeared before the Board on behalf of Ivy Tech State College, Gary. This generic ASN track for the non-nurse was initially approved by ISBN on November 30, 1993 but not activated at the time due to articulation agreements with Indiana University Northwest and Purdue University Calumet. The generic ASN students will be with the PN students for the first two semesters and then will merge with the transitional LPN to RN students for the last two semesters and graduate with them as one class under the new multi-entrance/multi-exit nursing curriculum.

A motion was made and seconded to approve their request to activate traditional program track and keep the same program code.

**VI. PERSONAL APPEARANCES**

**A. Appearances by Applicants for Licensure**

A motion was made and seconded to affirm the recommendations of Carolyn Slagle for the Board, as follows:

**1. Teena Lynn Terrell**

Ms. Terrell appeared before the Board regarding the positive response on her examination application. Ms. Terrell is licensed in Texas. She voluntarily surrendered her license in TX in 2000. She is currently in ISNAP and has been compliant. Ms. Slagle recommended issuing Teena Lynn Terrell's license with no restrictions.

**2. Tamara Hill**

Ms. Hill appeared before the Board regarding the positive response on her examination application. On Memorial Day weekend in 2005, Ms. Hill was stopped by a Hobart police officer and failed the breathalyzer test. Ms. Hill's driver's license was suspended and she was instructed to attend classes at the Adult Behavior Clinic. Ms. Slagle recommended that Tamara Hill be evaluated by ISNAP. Further, the Board must have approval from ISNAP before Tamara Hill's license can be issued.

**3. Chester Dean Walls**

Mr. Walls appeared before the Board regarding the positive response on his examination application. In 1993 Mr. Walls was arrested for a class B felony drug charge. Mr. Walls was sentenced to ten years; all was suspended but three years. He received inpatient treatment for drug and alcohol abuse during his sentence. Mr. Walls informed the Board that he has completed all of the required programs. Mr. Walls stated that his date of sobriety is August 8, 1993. Ms. Slagle recommended issuing Chester Dean Walls license with no restrictions.

**4. Elizabeth Meyer**

Ms. Meyer appeared before the Board regarding the positive response on her examination application. Ms. Meyer was charged with an OUI in January, 2006. She is currently ordered to attend Southern Hills for alcohol classes. Ms. Meyer stated that she will be on probation for one year and she has to submit to random alcohol and drug test. Ms. Meyer must also serve one hundred eighty hours of community service and pay \$1,200.00 dollars in fines and fees. Ms. Slagle recommended that Elizabeth Meyer be evaluated by ISNAP. Further, Ms. Meyer's license is to be placed on Indefinite Probation for a period of six months of compliance with her ISNAP contract.

**5. Nichole Snyder**

Ms. Snyder appeared before the Board regarding the positive response on her examination application. Ms. Snyder has a DWI case pending against her from 2004. Ms. Snyder informed the Board that the charge was reduced to reckless driving. Ms. Slagle recommended Nichole Snyder be evaluated by ISNAP. Further, the Board must have approval from ISNAP before Nichole Snyder's license can be issued.

**6. Carol Stogsdill**

Ms. Stogsdill appeared before the Board regarding the positive response on her examination application. Ms. Stogsdill was in treatment program from February through March of 2004. Ms. Stogsdill stated that she currently maintains treatment at the Mayo Clinic. Ms. Slagle recommended Carol Stogsdill be made eligible to take the examination and issue her license with no restrictions once she passes.

**7. Elizabeth Camacho**

Ms. Camacho appeared before the Board regarding the positive response on her examination application. Ms. Camacho stated that she was babysitting in April, 2001 when she struck one of the babies on the right cheek and left a bruise. She confessed and voluntarily spent the night in jail. She was charged with a class D felony, battery of a minor. Ms. Camacho was given eighteen months of probation, which she served. She was also ordered to take anger management classes and parenting classes. Ms. Slagle recommended Elizabeth Camacho be made eligible to take the examination. Further, once Ms. Camacho passes the examination, her license will be placed on Indefinite Probation for a period of six months of active nursing practice.

**8. Alicia Kay Nuncio**

Ms. Nuncio appeared before the Board regarding the positive response on her examination application. She was suspended from Colonia Health Care Facility in November of 2005 for not passing a drug screen test. She stated that since that time she has been clean of any illegal substances. Ms. Nuncio was also fired from Wesleyan Health Care Facility in June of 2006. She was accused of being involved in a verbal altercation with another employee. Ms. Slagle

recommended that Alicia Kay Nuncio be made eligible to take the examination. Once she passes, she can be issued a license with no restrictions.

**9. Alicia Hart**

Ms. Hart appeared before the Board regarding the positive response on her examination application. Ms. Hart was arrested on July 6, 2000 for possession of marijuana and possession of alcohol by a minor. She was sentenced to ten days in jail, probation for twelve months, her driver's license was suspended for one hundred eighty days and she went to a thirty day treatment center for drugs and alcohol. Ms. Hart then went to a women's half-way house and lived there for approximately nine months. Ms. Hart stated that since March of 2001 she has been sober and she currently goes to therapy every two weeks. Ms. Slagle recommended Alicia Hart be made eligible to take the examination. Further, once Ms. Hart passes the examination, her license will be issued with no restrictions.

**10. Kenyatta Kennedy**

Ms. Kennedy appeared before the Board regarding the positive response on her examination application. Ms. Kennedy appeared before the Board at their August 17, 2006 meeting. Ms. Kennedy was arrested in February, 2005 for a DUI. Ms. Slagle recommended Kenyatta Kennedy be evaluated by ISNAP. Further, once the Board receives approval from ISNAP, Ms. Kennedy's license is to be placed on Indefinite Probation for a period of six months of compliance with her ISNAP contract.
