I. **CALL TO ORDER AND ESTABLISHMENT OF QUORUM**

I. **ADOPTION OF THE AGENDA**

A motion was made and seconded to adopt the agenda as amended. Dolk/Ogle 8-0-0

II. **ADOPTION OF THE MINUTES FROM THE AUGUST 18, 2011 MEETING OF THE BOARD**

A motion was made and seconded to adopt the August 18, 2011 nursing board minutes. Narwold/Dolk 8-0-0

III. **INDIANA STATE NURSES ASSISTANCE PROGRAM**

Chuck Lindquist reported on behalf of ISNAP. Intakes are up at 22 over last month. The ISNAP quarterly provider meeting is set for October 28, 2011 at Tara Treatment Center in Franklin, Indiana. ISNAP is working on more accurate reporting of compliance and is utilizing three different categories: Compliance A (denoting full compliance); Compliance B (denoting missing reports or UDS) and Compliance C (denoting workplace safety issues, etc.) Chuck indicated in response to a Board question that a first time relapse would be pulled off of work and placed in a higher level of treatment, on a second relapse licensees are referred to the Board. Ms. Ogle asked for a presentation of the capabilities of the electronic records management system from Affinity Online Solutions that ISNAP indicates is currently set for a November 1, 2011 implementation date.

V. **EDUCATION**

(Note: The calculation for one standard deviation below the national pass rate for these years were as follows: 2008-86.1% 2009-87.8% 2010-86.8%)

**A. Ivy Tech Greencastle ASN Program- Proposal for Restructuring Program**

Staff from Ivy Tech Greencastle appeared before the Board. The campus has had some changes in administration and long term faculty due to retirements since 2009. They have had trouble securing clinical sites and their NCLEX results have suffered. They did not enroll a class in the Fall of 2010. They set up mentorships with Terre Haute/Greencastle faculty and continued to look for credentialed faculty in a state wide search. They would propose to maintain a separate PN ISBN number for Greencastle and Terre Haute but to have a single item number for Terre Haute for RN testers.

Greencastle does currently have a number and would like to maintain that number in order to complete those students remaining that did not graduate on time in their individual cohorts (about 10 students total). The last student should be graduating in December 2011. Greencastle has had ASN program since 2006 and PN program since 2004.

**Board Action:** A motion was made and seconded to accept the program in place for restructuring the PN program for the Greencastle campus and to shut down the RN program effective with the last of the remaining cohorts' graduation from the RN program. Laux/Ogle 7-0-1, motion carries (Dolk abstains)

**B. Indiana State University BSN Program– Proposed Curriculum Change, Changes in Faculty and Plan of Correction**

NCLEX Pass Rates: 2008-83.3% 2009-72.22% 2010-78.3%

**1. Proposed Curriculum Change-**

Staff appeared on behalf of Indiana State. Indiana State has not had a major curriculum change in 10 years. They looked at program outcomes to bring them in line with current health outcomes. They had a 2 semester pre-nursing program and will increase to a 3 semester program before being admitted into the major. Pharmacology and pathology are combined into one course with increased credit hours. They have added a nutrition course and have decreased their mental/social courses from three to one course. They have combined their pediatrics and obstetrics courses. They are doing a freestanding NCLEX review course for 2 credit hours at the end of the program. They have started an accelerated second degree program that will begin in May, run for 4 semesters and complete in August. Their first class has 15 students and the maximum capacity will be 30 with admission once per year. Ms. Laux asked about the total number of hours for the child class. Overall the course will be 4 hours of didactic and 2 hours of clinical.

**Board Action:** A motion was made and seconded to accept curriculum changes. Laux/Narwold 8-0-0, motion carries

**2. Plan of Correction-**

In regards to their plan of correction they are looking at outcomes and looking at student input as well. They looked at admission criteria into the program and at faculty who may have left the profession or retired. Admission criteria now are open admission to the university level. They had 480 pre-nursing majors come to the university with 200 with SAT's below 900. These students filter out through the failure of anatomy, chemistry, math etc. and realize this may not be a good fit for them. Academic advising is completed on the front end for student success. Students apply to the nursing program in the first semester of their sophomore year with ATI testing and putting grades forward for review. The lowest GPA is a 2.5 and they cannot have taken a course over more than once with a total of three course do-overs. They admit undergraduate traditional students up to 60 every spring and 60 every January. Online LPN to BSN program they admit 60 students in the Spring and 60 in January. They run nursing courses in the summer as well. They have four faculty searches open at this time. Currently they have one open search in progress and four more opening after this semester. They also had grade inflation due to bonus points and they are working with faculty to understand the standards and good assessment processes and writing good critical thinking questions. In looking at both the PN to BSN and high school to BSN programs, students are weak in pharmacology and medical surgical areas. They had a poor first quarter in 2011 but a better second quarter in 2011. Laux asked what level the ATI's are set at. They are looking at 10% of the grade and a sliding scale of points is awarded based on what variables are hit. You could pass the class if you are level 1 but did well in the class. For students that fall below that level they may receive individual tutoring classes. They started the state board review course 5 semesters ago. They have had 1 student fail PN outside state of Indiana but none yet based on this policy. A board member asked whether data shows that students pass courses but do not pass NCLEX and the response was yes. The campus is using the TEAS system and admits at slightly above the national average. Mr. Burghduff expressed concerns that a BSN program is failing to meet the standards of an ASN program. Faculty current believes their 2011 NCLEX average will be 80-83% overall but Dr. Miller is projecting they will not hit national average. They have not made their quotas as they only admitted 53 eligible students this fall but they did not purposely decrease their enrollment. The average GPA was higher than 2.5, about a 2.7 or 2.75. They do not maintain or expect a 100% graduation rate but have about a 70% graduation rate. Their next graduating class will be December 2011. They will have an NLNAC visit in October 2011.

**Board Action:** A motion was made and seconded to accept the Corrective Action Plan. Narwold/Ogle, 4-4-0, motion fails. A motion was then made and seconded to table the Corrective Action Plan and invite ISU to present again in November 2011. Burghduff/Laux 5-3-0, motion carries (Narwold, Dolk, Ogle against)

C. FYI Only- Fortis College, Indianapolis Kathy Plankenhorn is now the Director of the Nursing Program as of June 23, 2011. Dr. James R. Cox is now the President of Fortis College, Indianapolis as of August 12, 2011.

D. ITT Tech Indianapolis- Change in Grading Policy for All Campuses (Fort Wayne, Merrillville, Indianapolis, Newburgh, South Bend)

**Board Action:** A motion was made and seconded to request ITT Tech representatives to come discuss the rationale behind these changes with the full Board in October 2011. Laux/Ogle 8-0-0, motion carries

**E. Ivy Tech Nursing Schools Scheduled for Plan of Correction Discussions:**

**1. Ivy Tech Greencastle, ASN- NCLEX Pass Rates: 2008-52.9% 2009-65% 2010-80%**

Staff appeared on behalf of Ivy Tech Greencastle. Their POC was started ahead of their 2010 final results. They merged with Terre Haute and looked at this with a perspective of best practices. They have established a mentorship between the Terre Haute and Greencastle campuses. They also looked at availability of clinical space and utilized resources in psych nursing and advanced medical surgical course in the Terre Haute area. They have also started meeting with each student individually to map out an NCLEX plan. Most students did not have good direction in preparing for boards and the students they met with took the advice to heart. The Board asked if students have advisors and they do as of December 2010. Students do not have to take a review course prior to taking the NCLEX at this time.

**Board Action:** A motion was made and seconded to approve the Corrective Action Plan. McIntosh/Ogle 7-0-1, motion carries (Dolk abstains)

**2. Ivy Tech Lafayette, ASN- NCLEX Pass Rates: 2008- 82.7% 2009-73.03% 2010-85%**

Staff appeared on behalf of Ivy Tech Lafayette. They have two faculty members on corrective plans as they are progressing from their bachelors to masters degrees. They have worked on faculty development with completion of item writing courses through NCSBN, simulation conferences, NLN Summit attendance in September, ATI summit attendance and an increase in the number of culturally diverse admissions with ESL student admissions. They have a student services department that helps with ESL students that currently comprise 5 of the 57 students admitted this semester. They admit 60 students in the ASN fall class, 15 PN to ASN students and did not admit a PN class this fall. Admission criteria is objective based on points for anatomy/physiology, English and psychology with grade of "C" or better, composite score from TEAS, with a total maximum point range of 190. Point range for the Fall admitted class was 107-183. ASN students must complete college level algebra and because of that requirement there was some natural filtering out of students. Their application pool was approximately 153 students with 19 not being able to be considered for the program. They utilize ATI and it is a part of the grade for each course. Students get 5% added to their grade if they achieve Level 3, etc. Students have the opportunity to go and remediate with the non-proctored test with a 90% to get remediation points added. 95% of grade comes from how well they do on the test with a maximum of 5% from the non-proctored exam and remediation process. Ms. Laux suggested implementing a time period before remediation so that students do not memorize the answers and retake non-proctored exams immediately.

**3. Ivy Tech South Bend, ASN- NCLEX Pass Rates: 2008-2008-75.6% 2009-68.54% 2010-72.2%**

Staff appeared on behalf of Ivy Tech South Bend. The Dean is new as of August 2010. They have looked at curriculum content and using the ATI system for course testing and comprehensive predictors. They were not using the ATI correctly. Pharmacology was not testing well and peds/ob was not testing well either. As a faculty state-wide they have split out these courses. They have also split out the maternal/ob classes as well. In clinicals they were using adjunct faculty but each of them were doing it differently and not on the same page looking at standardization and use of less adjuncts. They have decreased enrollment from 50 in ASN to 40 and now this year to 30 in ASN program. Faculty is all MSN prepared as full time but part-time is BSN working on plan towards MSN with completion in 2013. There were inconsistent grading practices as well so that all new and adjunct faculty now has a full time faculty mentor. There was no sufficient rigor in their exams so they have had some testing seminars in order to write good test questions. They have peer review of exams in year to year comparisons and across the specialities so that they can insure the rigor is there. They are increasing the use of NCLEX-type questions and alternative item questions. They are now using audit exam processes for students that fail exams at a 75% rate or lower and going through item by item with the students on a one to one basis. The student also has a midterm learning contract if they are not doing well in the class. Students were not carrying their knowledge forward in preparing for the NCLEX. ATI is coming in to talk to students in the beginning and the end of the program. ATI talks to faculty as well. Students are receiving one to one counseling after taking the predictor course in their second year beginning as of the Spring semester of 2011. Their second quarter pass rates were up to 84%. They also continue to work with students who are not successful at NCLEX. They will provide a review course for students for NCLEX but it is not mandatory at this time. They had 21 students take the review and 18 of them passed state boards.

**Board Action:** A motion was made and seconded to approve the Corrective Action Plan. Laux/Narwold 6-0-1, motion carries (McIntosh abstains, Dolk recused)

**4. Ivy Tech Muncie, ASN- NCLEX Pass Rates: 2008-80.8% 2009-80.19% 2010-72.8%**

Staff appeared on behalf of Ivy Tech Muncie. Their pass rate for the second quarter is 96%. The entire faculty has been included and participated in the PAC in both monthly and regional meetings. They have had changes in didactic and clinical instruction. They are working on case scenarios with instructors, started to work on group concept mapping and alternate questions in the classroom and on exams, have changed some personnel and are working on faculty development. They have had a reduction of 20% in the number of students admitted. The nursing faculty advises their nursing students that are admitted so the advising load has been cut down for all faculty. They have 15 MSN prepared

full time faculty, 3 full time staff are working towards Masters, part-time 25% are MSN prepared and the rest are on plans towards MSN completion. They had a live ATI review in May 2011. They are using faculty mentors for new faculty. Their GPA for admission is 2.0 but she is not aware of their GPA average at this time. ATI is part of the grade for the final exam at a 5% rate and remediation is the same as other Ivy Tech campuses.

**Board Action:** A motion was made and seconded to approve the Corrective Action Plan.

**5. Ivy Tech Terre Haute ASN- NCLEX Pass Rates: 2008-75.3% 2009-81.19% 2010-85.9%**

For the Terre Haute campus they began a decline in pass rates in 2008. In 2010 they added two out of state testers for an 86.25%. In 2011, they have had 68 first time NCLEX candidates and 67 have passed. They have 5 testers that remain outstanding as of this year. They have worked with faculty resources and all faculty are MSN prepared as last two faculty members completed in 2011. They are not presently using any adjunct faculty. Ivy Tech is also working with the Rural Health Initiative program to utilize additional lab experience at their local hospital with infant and maternity program. A student council was established in 2010 for PN and ASN students that meets twice per semester. Their enrollment was decreased as transition students were decreased by 10. Normally they took in 20 students and are now taking in 10 students once a year. They did not reduce any other program enrollments. Ms. Laux recommended that all faculty go to test writing seminars.

**Board Action:** A motion was made and seconded to approve the Corrective Action Plan.  
Narwold/Ogle 7-0-0, motion carries (Dolk recused)

**F. Ivy Tech Columbus ASN Program- Conditional Accreditation Site Revisit**

NCLEX Pass Rates: 2008-63.4% 2009-68.24% 2010-72.2%

Ms. Laux presented information from the site visit conducted on 9/1/11 with Ms. Hall. Ms. Laux found things that were consistent with Ivy Tech's systematic implementation of their corrective action plan. They are utilizing new faculty with appropriate test writing skills. Students they met with were handpicked by the faculty and Dean who overall were positive and had noticed tremendous changes in engagement with and access to faculty. Students also felt their advising needs were being met. They have had a great turnaround in their NCLEX scores. Recommendation is to continue conditional accreditation until the campus can provide four 4 quarters of NCLEX scores above the pass rate.

**Board Action:** A motion was made and seconded to accept the recommendation. Laux/Narwold 7-0-0, motion carries (Dolk recused)

## VIII. PERSONAL APPEARANCES

Personal appearances were held in conference room 14 before Ms. Laux and Ms. Presley. A motion was made and seconded to approve all recommendations made on this date. Narwold/Presley 8-0-0, motion carries

### 1. **Latasha Sims**

Ms. Sims appeared before the Board of Nursing (BON) regarding a positive response on her application for license by endorsement. She reported a 2004 incident in which her bank card was stolen and used, resulting in her arrest in 2008 for theft by deception. She states the matter has been resolved without further incident. The BON voted to approve her application.

### 2. **Christina O'Sullivan**

Ms. O'Sullivan appeared regarding her licensure application by examination. She has failed the NCLEX 3 times since completing her nursing program in 2007. She is taking a review course at IU East. The BON voted to deny her application and she may reapply with proof of passing at 95% or higher.

### 3. **Rachel Hopkinson**

Ms. Hopkinson appeared before the BON regarding her application for licensure by examination. She reported problems with alcohol since 2005. Her sobriety date is 1/3/11. She is currently on probation. It was recommended that she complete an ISNAP evaluation and be allowed to test. Her license will be issued on probation for the length of the RMA or her criminal probation, whichever is longer. Quarterly employer reports will be required.

### 4. **Brooke Hodo**

Ms. Hodo appeared before the BON regarding her application for licensure by endorsement. She reports an arrest during nursing school for public intoxication/disorderly conduct. She states there have been no further incidents and she was not driving at the time. The BON voted to approve her application and issue her license free and clear.

### 5. **Megan Smith**

Ms. Smith appeared before the BON regarding her application for licensure by examination. She reported a public intoxication charge in 2009 during nursing school in which the misdemeanor was deferred. The BON voted to allow her to test and a free and clear license to be issued.

### 6. **Patricia Bortoli**

Ms. Bortoli appeared before the BON regarding her application for licensure by examination. She reported an OWI in Jan. 2011 with a BAC of .15. This resulted in an accident for which she is currently on probation until Dec. 2011. The BON recommended an ISNAP evaluation and an RMA if eligible. She will be allowed to test and the license will be issued on probation for the length of her criminal probation or length of RMA, whichever is longer.

### 7. **Veronica Watkins**

Ms. Watkins appeared before the BON regarding her application for licensure by examination. She reported that a 1987 arrest for bad checks has been resolved. She also reported a termination in March 2011 as a QMA for practicing outside the scope of practice. She had given insulin to a patient under the direction of a nurse and did not report it in a timely manner. The BON recommended she be allowed to test and her license will be issued on probation for 1 year with quarterly reports from her employer.

### 8. **Kelly Hall**

Ms. Hall appeared before the BON regarding her application for licensure by examination. She reported minor consumption of alcohol in 2003 and also driving under the influence and possession of cocaine later that year. In 2004 she violated probation and served jail time for testing positive for amphetamines. The BON voted to allow her to test and that she have an ISNAP evaluation. Her license is to be issued on probation for 6 months with 2 quarterly supervisor reports.

### 9. **Robert Stewart**

Mr. Stewart appeared before the BON regarding his application for licensure by examination. He reported a 1999 arrest at age 20 for being a minor in possession of alcohol. In 2004 he was arrested for OWI with a BAC of .16 at age 25. He states he no longer drinks. The BON voted to allow him to test and that he complete an ISNAP evaluation and enter into an RMA if eligible. His license will be issued free and clear.

### 10. **Jessica Bisping**

Ms. Bisping appeared before the BON regarding her application for licensure by examination. She reported in 2005 she was charged as a minor with transportation of alcohol and prescription drugs belonging to someone else were found in the car. She was charged with OWI in 2006 for which we served probation. In 2007 she was charged with driving while suspended. She stated she has completed all requirements, has not drunk alcohol since 2006, and these matters are

resolved. The BON recommended she be allowed allow to test, complete an, ISNAP evaluation and that her license be issued on probation for the length of the RMA.

**11. Benjamin Scarbro**

Mr. Scarbro did not appear before the BON as requested regarding his application for licensure by endorsement to explain the positive responses on his application. The BON voted to deny his application.

**12. Scott Martin**

Mr. Martin appeared before the BON to explain answers of yes on his application for renewal of registered nurse licensure. He stated that in 2009 he was charged with OWI in which his actions caused his friend to suffer a traumatic brain injury. He self-reported to ISNAP and completed monitoring on 9/14/11. He will be on criminal probation until July 2012. The BON voted to renew his license on probation for the length of his criminal probation with quarterly reports from his employer.

**13. Theda Miller**

Ms. Miller appeared before the BON to explain answers of yes on her application for renewal of registered nurse licensure. She reported two terminations since her last renewal. One was in 2009 for personal use of Internet at work and the other was in 2010 from a home health agency for patient care. She worked the night shift and the patient reported Ms. Miller fell asleep during her shift. She was also reported to have been spending the time away from the patient in another room of the house while reading her schoolbooks. The BON voted to renew her license on probation for 6 months with 2 quarterly reports from her employer.

**14. Karole Gutzweiler**

Ms. Gutzweiler appeared before the BON to explain answers of yes on her application for renewal of registered nurse licensure. She reported a DUI in Feb. 2010 with a BAC of .11 but was unsure of the exact percentage. She stated she went to jail and then had a court appearance where she pled guilty and then a completed drug and alcohol program as of August 2011. The BON voted to approve her renewal.

**15. Jennifer Stump**

Ms. Stump appeared before the BON to explain answers of yes on her application for renewal of registered nurse licensure. In Nov. 2010 she failed a drug screen at work and was terminated. She has been treated for opioid dependency due to self-medicating but reports being on no medication at this time. The BON recommended an ISNAP evaluation with an RMA and that her license be renewed on probation for the length of the RMA with quarterly reports.

**16. Lauren Hake**

Ms. Hake appeared before the BON to explain answers of yes on her application for renewal of registered nurse licensure. Her license was issued in July 2011 and she was charged with DUI in August 2011. The BON voted to renew her license on probation for 6 months with full compliance with ISNAP RMA.

**17. Catherine Roberson**

Ms. Roberson was requested to appear to explain yes answers on her registered nurse licensure renewal. She reported a termination in March 2010 for charting treatments due to busy caseload. She did not appear and requested to withdraw her renewal request. The BON voted to approve withdrawal of her renewal application.

**18. Helen Pell**

Ms. Pell appeared before the BON to explain answers of yes on her application for renewal of registered nurse licensure. She reported a reprimand in July 2011 for raising her voice and sending an unprofessional email to a co-worker. Based on her explanation of the details, the BON voted to renew her license.

**19. Christine Stinson**

Ms. Stinson appeared before the BON to explain answers of yes on her application for renewal of registered nurse licensure. She reported a DUI in March 2011 in KY with a BAC of .192. She contacted ISNAP and enrolled 3/11/11. She is in full compliance with her RMA which goes through March 2014. She did not receive probation for the DUI. The BON voted to renew her license on probation for the length of the RMA.

**20. Tracy Peckinpaugh**

Ms. Peckinpaugh appeared before the BON to explain answers of yes on her application for renewal of registered nurse licensure. She reported she was verbally disciplined at work due to documentation of home care visits and charting paperwork following implementation of a new system. She presented copies of CE she has completed on documentation, assessment and charting. The BON voted to renew her license.

21. **Angela Duniven**

Ms. Duniven appeared before the BON to explain answers of yes on her application for renewal of registered nurse licensure. She reported an OWI arrest in July 2011 in which she was texting and had her child in the car when an accident occurred. She will go to court at a later date regarding these charges. The BON recommended an ISNAP evaluation and that her license be renewed on probation for the length of her RMA or pending criminal probation, whichever is longer.

22. **Nicole Anderson**

Ms. Anderson appeared before the BON to explain answers of yes on her application for renewal of registered nurse licensure. She reported a DUI in Sept. 2010 with a BAC of .11. She is on probation for this until November 2011. ## XII. APPROVAL OF ALJ RECOMMENDATIONS

**Board Action: A motion was made and seconded to approve all Administrative Law Judge recommendations presented on this date. Ogle/Narwold 8-0-0, motion carries**

**1. Megan Outhwaite**

Ms. Outhwaite appeared before the ALJ regarding her application for RN licensure by examination. She reported an OWI in 2009 that occurred during nursing school. She stated she thought she blew .14% and that it was a one-time occurrence. Based on this, it was recommended she be allowed to test and her license be issued free and clear.

**2. Terry Stewart-Davis**

Ms. Stewart appeared before the ALJ regarding her application for licensure by examination. She has failed the test 6 times since completing school in 2007. She reports she has test anxiety and plans to take a review course and may seek treatment for test anxiety. The ALJ recommendation was to deny her request to test and that she take an NCLEX review course and provide proof of 95% or higher probability of passing.

**3. Laticia Garcia**

Ms. Garcia appeared before the ALJ regarding her application for RN licensure by examination. She has failed the NCLEX 2 times previously since completing school in 2006. She has been working as a CNA and therefore the ALJ voted to allow her to sit for the NCLEX.

**4. Brittany Lewis**

Ms. Lewis appeared before the ALJ regarding her license application by examination. She has failed the NCLEX twice since graduating in 2007. She stated she has not completed a review course at this time. The ALJ recommendation was to allow her to test one more time.

**5. Lisa Clark**

Ms. Clark appeared before the ALJ regarding her application for licensure by examination. She has failed the NCLEX 4 times since completing school in 2007. She reports she has test anxiety and ADD and is working with a therapist. She has done the Kaplan review course. Because she has failed more than three times, the ALJ recommended denying her request and she must show proof of 95% or higher probability of passing. It was noted the ALJ will accept 94% if this is what Kaplan's policy is.

**6. William Bugg**

Mr. Bugg appeared before the ALJ regarding his licensure application for RN by endorsement. He reported that his license in AR is on probation until 2013 and he voluntarily surrendered that license in 2008. He reports a DUI in 2009 and is in monitoring in AR. He has contacted ISNAP due to earlier diversion of narcotics in AR. The ALJ recommended granting a probationary license after completion of the ISNAP evaluation and that his license will be subject to the same conditions as his AR probationary order. The IN license will be on probation for the length of the RMA.

**7. Alonzo White**

Mr. White was to appear before the ALJ regarding the positive response on his licensure application by endorsement and the lengthy report from his criminal background check. He did not appear and the personal appearance meeting will be rescheduled.

**8. Beth Koartge**

Ms. Koartge completed nursing school in 2007. She requested that the personal appearance meeting be rescheduled because she is completing a review course. The PA meeting will be rescheduled for December or earlier at her request.

**9. Patricia Holman**

Ms. Holman did not appear before the ALJ regarding her license application by examination. She completed nursing school in 2007. The ALJ recommended that her personal appearance meeting be rescheduled.

**10. Adeola Ajayi**

Ms. Ajayi did not appear before the ALJ regarding her application for RN licensure by examination. She completed nursing school in 2008. The ALJ recommended that her personal appearance meeting be rescheduled.

11. **Geoffrey Hager**

Mr. Hager appeared before the ALJ regarding his application for licensure by examination. He reported a DUI in 2009 in which his BAC was .11%. He reported no other alcohol related incidents before or since. The ALJ recommended that he complete an ISNAP evaluation and that he sign an RMA if eligible. He will be allowed to test and his license will be issued free and clear.

12. **Anne McDevitt**

Ms. McDevitt has failed the NCLEX 6 times since completing nursing school in 2005. She was requested to appear before the board then requested that the meeting be cancelled and that her application be withdrawn.

13. **Cody Allen**

Mr. Allen did not appear before the ALJ regarding his RN application by endorsement. He reported a DUI arrest and termination. OH board of nursing has requested that he not renew his license there. The PA meeting will be rescheduled.

14. **Michelle Songer**

Ms. Songer appeared before the ALJ regarding her LPN licensure by examination application. She reported a criminal conversion charge for bad checks. She took money from her employer to pay for the checks and intended to pay it back. She stated she completed all requirements of her probation and community service. The ALJ recommended that she be allowed to test and that her license be issued on probation for 6 months with 2 quarterly employer reports.

15. **Angela Huffmeyer**

Ms. Huffmeyer appeared before the ALJ regarding her APN/CSR application, there is a pending complaint in AG's office due to her advising someone via Facebook "to kill yourself." Ms. Huffmeyer stated this posting was in response to someone harassing her son. The ALJ recommended that her APN and CSR application be approved and that the AG's office complete its investigation of the complaint filed on her RN license.

16. **Carrie Ricci**

Ms. Ricci had requested that her Aug. 18 PA be rescheduled for Sept. 1. She has attempted the NCLEX in 2005 and 2006 and failed since completing her nursing school program in 2004. She has been working as a medical assistant. She stated she has done the ATI review online. The ALJ recommended denying her request to test until she has completed a nursing refresher course with a clinical component.

17. **Erica Burch**

Ms. Burch had requested that her PA be rescheduled from Aug. 18 to Sept. 1. She has applied for RN licensure by examination and has failed the NCLEX five times since completing nursing school in 2003. The ALJ recommended denying her request to test and that she enroll in an NCLEX review course. She may reapply with proof of 95% or higher probability of passing.

18. **Helena Fontaine**

Ms. Fontaine requested that the personal appearance meeting be rescheduled and the ALJ recommends that the meeting be rescheduled.

19. **Sara Dembowski**

Ms. Dembowski appeared before the ALJ regarding her expired RN license renewal. She reported a DWI arrest in May 2009; her RN license expired in October 2009. She reported no previous violations and that she completed three months' probation. The ALJ recommended an ISNAP evaluation and that the license be renewed free and clears following the ISNAP evaluation. She is expecting and her baby is due in December.

20. **Nichole Snyder**

Ms. Snyder appeared before the ALJ regarding her RN license renewal. She reported issues relating to termination, medication errors and treatment errors. There is a pending complaint with the AG's office. The ALJ recommended that her license be renewed on probation for 6 months with 2 quarterly employer reports and that she complete 6CEs each in assessment, medication safety, documentation and ethics.

21. **Tammy Reed**

Ms. Reed appeared before the board regarding renewal of her LPN license. The renewal was previously denied. She reports a conviction for meth possession in 2008 and has not been working as a nurse since 2005. She resides in KS. Her sons were also in the house and were placed in custody of child welfare authorities. She is on probation until Jan. 2012. The ALJ recommended renewing her license on probation for the duration of an ISNAP RMA. She is requesting that her IN license be cleared so she can get a KS license.

22. **Lori Handy**

Ms. Handy appeared before the ALJ regarding her RN renewal. She reported a positive drug screen in January 2011 and she has been in ISNAP since July 2011. ISNAP confirmed diagnosis of substance abuse disorder secondary to depression. She was terminated in March 2011 due to the drug screen results. The ALJ recommended that she continue in ISNAP and that her license be renewed.

23. **Thomas Runyon**

Mr. Runyon appeared regarding his RN renewal on which he reported a class C misdemeanor. Upon farther questioning, he disclosed an OWI arrest in Nov. 2010 for which he was convicted in June 2011. He reported an accident at that time and his BAC was .014. The ALJ recommended an ISNAP evaluation and RMA be entered into if eligible. Once he completes the ISNAP evaluation, his license can be renewed.

24. **Karil Willenbrink**

Ms. Willenbrink's attorney requested that her personal appearance meeting be rescheduled and the ALJ approved the request.

25. **Jeffrey Handy**

Mr. Handy appeared before the ALJ for renewal of his R.N license. He reported a termination for scope of practice issues which he states was due to poor communication between his supervisors and himself. The ALJ recommended that his license be renewed.

26. **Patricia Smith**

Ms. Smith appeared before the ALJ regarding renewal of her R.N license. She reported two terminations due to documentation issues and lack of recent clinical experience. She was previously a surveyor with the state department of health. There were no practice issues reported. The ALJ recommended renewing her license free and clear.

27. **Crystal Torres-Roberts**

Ms. Torres-Roberts did not appear as requested to discuss her RN renewal and positive response. The ALJ recommended that the PA meeting be rescheduled.

28. **Stephanie Fischer**

Ms. Fischer appeared regarding her RN renewal. She reported an Oct. 2010 arrest for OWI and is currently on probation until Feb 2012 THE ALJ recommended ISNAP evaluation and signing an RMA if warranted. Her license will be renewed on probation for the duration of her criminal probation.

29. **Susan Batey**

Ms. Batey reported a termination on her RN renewal. She is in ISNAP due to issues raised on her 2009 renewal. The ALJ recommend that her license be renewed.

30. **Jonathan Pierce**

Mr. Pierce appeared regarding his RN renewal. He reported a March 2010 arrest for DUI with a BAC of .15. He reported no previous arrests or any since. In April 2011 he completed criminal probation and all requirements. The ALJ recommended he complete an ISNAP evaluation before his license can be renewed.

31. **Harvey Guthery**

Mr. Guthery appeared regarding his RN renewal. He reported an Apr. 2010 termination due to "not meeting expectations" but did not provide details in his positive response statement. He stated he had difficulty going from a nurse role to a supervisory role. The ALJ recommended renewing his license.

32. **Ruth Alexander**

Ms. Alexander appeared regarding her RN renewal. She had a 2009 renewal personal appearance due to charges of possession of a controlled substance and possession of stolen property for writing prescriptions for herself from her employer's prescription pad. She has been compliant with ISNAP since Oct. 2009. The AG's office is still investigating. The ALJ recommended renewing her license free and clear.

33. **Sheila Grimes**

Ms. Grimes appeared before the ALJ regarding renewal of her RN license. She reported a termination due to issues with her nursing skills. The ALJ felt the termination was appropriate and no further action by the BON was necessary. It was recommended that her license be renewed.

34. **Ebony Hawkins**

Ms. Hawkins appeared before the ALJ regarding renewal of her RN license. She reported a demotion due to skill issues and that she is working with her employer to find a better fit within the facility. The ALJ felt the demotion was appropriate and no further action by the BON was necessary. It was recommended that her license be renewed.

35. **Kathy Arney**

Ms. Arney appeared regarding her RN renewal. She reported a July 2010 arrest for OWI with a BAC of .09. She reported neither prior arrests nor any since. She completed all court ordered requirements in Aug. 2011. The ALJ recommended an ISNAP evaluation and signing an RMA if eligible. Her license will then be renewed free and clear.

36. **Dawn Fox**

Ms. Fox and her attorney appeared before the ALJ regarding renewal of her RN license. She reported a May 2010 termination from St. Francis due to suspected diversion of narcotics. She states she was falsely accused and was suspended from work during the employer's investigation. She was referred to ISNAP but the ISNAP representative stated she did not return the RMA or answer their follow up phone call and letter. Dr. Hinchman did the assessment and the ISNAP closure memo was sent to the AG's office. The ALJ recommend a reassessment by ISNAP and sign an RMA if eligible. The ALJ also recommended an MMPI-II. The license is to be renewed on indefinite probation for six months.

37. **Kay Ellen McElmurry**

Ms. McElmurry and her attorney appeared before the ALJ regarding renewal of her RN license. She reported a lawsuit pending due to patient care issues and provided additional documentation that her role in the matter has been closed. The ALJ recommended that no further action by the BON was necessary, and that her license be renewed.

38. **Lisa Dawn Jones**

Ms. Jones appeared before the ALJ regarding renewal of her expired LPN license. She was requested to provide documentation of CEs or active license in another state but had not responded. She reports that she has been working in private home health care. The ALJ recommended that her license be renewed upon proof of completion of 24 CEs in 6 hours of each of the following: documentation, assessment, ethics and medication safety.

39. **Linda Romer**

Ms. Romer appeared before the ALJ regarding renewal of her expired RN license. It expired in 2005 and she had a positive response regarding a termination for creating a negative working environment. She felt this was due to personality conflicts. She has an active OH nursing license. The ALJ recommended that her license be renewed free and clear.

40. **Jeanann Drees**

Ms. Drees appeared before the ALJ regarding renewal of her expired LPN license. She is licensed as an LPN in KY and reports a 2005 charge of criminal conversion for writing bad checks due to a bad relationship she was in. The ALJ recommended that her license be renewed free and clear.

41. **Peter Solly**

Mr. Solly appeared before the ALJ regarding renewal of his LPN license that expired in 2000. he reported that his OH license was suspended in 2001 due to theft pertaining to falsification of time records at work. His OH license is currently still suspended. The ALJ recommend that he attend a refresher course and his license will be issued on indefinite probation so he can attend the refresher course. He may petition that the probation be lifted so he can complete the clinical portion of the refresher course. He may not practice as a nurse until he completes the refresher course.


