IV. INDIANA STATE NURSES ASSISTANCE PROGRAM (ISNAP) REPORT

Charles Lindquist, ISNAP Program Director, presented the monthly report to the Board. Mr. Lindquist informed the Board that ISNAP has, as of August 2007, 469 active clients, 27 new intakes, 51 intakes in process and 21 RMA's returned.

Mr. Lindquist stated that the second quarter 2007 compliance reports have been completed.

Mr. Lindquist stated that ISNAP staff met on August 15, 2007 to review applicants that have applied for the Needs Assistance Fund. They reviewed thirteen applications and eight of them qualified for assistance and vouchers were mailed to them.

Mr. Lindquist addressed the audience at the request of the Board.

VII. PERSONAL APPEARANCES

A motion was made and seconded to affirm the recommendations of Jerry Burghduff for the Board, as follows:

A. Appearance by Applicants for Licensure

1. Charlotte Bradshaw

Ms. Bradshaw appeared before the Board regarding the positive response on her application for licensure by endorsement. Ms. Bradshaw's license in Kentucky is on probation. Her license was placed on on limited/probated for two years in October of 2006. Ms. Bradshaw has limitations on her license; she can not be employed by a nurse registry, temporary nurse employment agency or home health agency. Jerry Burghduff recommended issuing Charlotte Bradshaw a license on Indefinite Probation. Ms. Bradshaw may apply to withdraw the probation from her license after the probation on her Kentucky license is withdrawn.

2. Steve Aaron Brown

Mr. Brown appeared before the Board regarding the positive response on his application for licensure by examination. On June 27, 1994 the police searched her vehicle and found approximately one gram of marijuana in his vehicle. He was arrested and charged with possession of marijuana. He pled guilty to the misdemeanor offense and was fined. On July 11, 2000 he admitted himself to Chicago Lakeshore Hospital for alcohol and drug detoxification. He completed the program and has been clean and sober since July 11, 2000. Jerry Burghduff recommended Steve Aaron Brown be evaluated by ISNAP. Once we receive approval from ISNAP, his license can be issued.

3. Lisa Hull Meredith

Ms. Meredith appeared before the Board regarding the positive response on her application for licensure by endorsement. Ms. Meredith was convicted of a misdemeanor of disorderly conduct. Additionally, Ms. Meredith was terminated from Baptist Hospital East in November of 2006 for poor attendance, eating at the nurses station, family/patient complaints, and leaving IV fluids hanging on an IV pole after a patient was discharged. Jerry Burghduff recommended Lisa Hull Meredith's license be issued.

4. Lisel Erski

Ms. Erski appeared before the Board regarding the positive response on her application for licensure by examination. Ms. Erski was charged with operating a vehicle while intoxicated on November 21, 2006. Jerry Burghduff recommended Lisel Erski be evaluated by ISNAP. Once we receive approval from ISNAP, her license can be issued.

5. Tracy Richardson

Ms. Richardson appeared before the Board regarding the positive response on her application for licensure by examination. Ms. Richardson was charged with failure to reduce speed or reckless driving in May 1991. She pled guilty to this misdemeanor and was fined, and received three months court supervision. On June 28, 2007 Ms. Richardson pled guilty to a charge of reckless driving. She received twelve months of court supervision, community service and alcohol evaluation. Jerry Burghduff recommended Tracy Richardson be evaluated by ISNAP. Once we receive approval from ISNAP, her license can be issued.

6. Nichole Thompson

Ms. Thompson appeared before the Board regarding the positive response on her application for licensure by examination. In May of 2006 she voluntarily decided to check herself into the Bloomington Hospital Psychiatric Unit in an effort to detoxify from opiates. Jerry Burghduff recommended Nichole Thompson be evaluated by ISNAP. Once we receive approval from ISNAP, her license can be issued.

7. Angela Morales

Ms. Morales appeared before the Board regarding the positive response on her application for licensure by examination. On March 1, 2006 Ms. Morales was convicted of operating while intoxicated as a class A misdemeanor. She has completed sixty hours of community service, Victim Impact Panel and alcohol classes. She is currently on criminal probation. Jerry Burghduff recommended Angela Morales be evaluated by ISNAP. Once we receive approval from ISNAP, her license can be issued.

8. Amy Blair

Ms. Blair appeared before the Board regarding the positive response on her application for licensure by examination. In 2004 Ms. Blair was charged with a misdemeanor for a domestic dispute. She received one

year of probation and alcohol classes. In 2007 she was charged with a misdemeanor for battery. Ms. Blair is currently on criminal probation. Jerry Burghduff recommended Amy Blair be evaluated by ISNAP. Once we receive approval from ISNAP, her license can be issued.

9. Ashley Miller

Ms. Miller appeared before the Board regarding the positive response on her application for licensure by examination. In April 2005 Ms. Miller was ticketed for minor consumption and public intoxication. Ms. Miller paid a fine and completed alcohol awareness. Jerry Burghduff recommended Ms. Miller be evaluated by ISNAP. Once we receive approval from ISNAP, her license can be issued.

10. Brian McDonald

Mr. McDonald appeared before the Board regarding the positive response on his application for licensure by endorsement. Mr. McDonald received a DUI on June 9, 2002. He was sentenced to surrender his driver's license for thirty days, pay a \$200 dollar fine, and complete twelve sessions of alcohol treatment. On January 26, 2003 Mr. McDonald received a DUI. He had to pay a \$350.00 fine plus court costs, surrender his license for one year, 180 days incarcerated with 166 days conditional discharge, 14 days of home incarceration and complete 52 session of alcohol treatment. On August 9, 2003 he received a citation for alcohol intox. Jerry Burghduff recommended Brian McDonald be evaluated by ISNAP. Once we receive approval from ISNAP, his license can be issued.

11. Debra Westergren

Ms. Westergren appeared before the Board regarding the positive response on her application for licensure by examination. On November 26, 2005 Ms. Westergren took a drug screen for her place of employment and tested positive for marijuana. Jerry Burghduff recommended Debra Westergren be evaluated by ISNAP. Once we receive approval from ISNAP, her license can be issued.

12. Kimberly Cripe

Ms. Cripe will be rescheduled for the October Board meeting.

13. Amy Martin

Ms. Martin appeared before the Board regarding the positive response on her application for licensure by endorsement. Ms. Martin was terminated after she had major health issues on August 15, 2005 from Hospice of Lancaster County. She was terminated from Lancashire Hall Nursing and Rehabilitation Center on June 6, 2006 after she had been sick and in the hospital for dehydration. On March 6, 2007 Ms. Martin was terminated from Masonic Village because they felt it was going work out with her working there. Jerry Burghduff recommended issuing Amy Martin's license on Indefinite Probation with employer reports and copies of all prescriptions Ms. Martin is taking.

The Board denied Jerry Burghduff's recommendation for Amy Martin and requested Ms. Martin submit an evaluation from a pain medical specialist prior to approval for licensure. Carolyn Slagle will review the evaluation for approval.
