Derivation Table for Indiana Code 23-0.5 (Section 5 of P.L. 118-2017)
Uniform Business Organizations Administrative Provisions Act

Section 5 of P.L. 118-2017, the Uniform Business Organizations Administrative Provisions Act, creates a new Article 0.5 in Title 23 of the Indiana Code. This article consolidates and harmonizes to the extent appropriate certain administrative provisions governing filing, entity name, registered agents, foreign entities, and administrative dissolution for business corporations, professional corporations, benefit corporations, limited liability partnerships, limited partnerships, non-profit corporations, limited liability companies, and series limited liability companies previously set forth in IC 23-1, IC 23-1.3, IC 23-1.5, IC 23-4-1, IC 23-16, IC 23-17, IC 23-18, and IC 23-18.1, respectively. It also contains definitions, fees, and other provisions that are generally applicable to all business entities. This article is based on Article 1 of the Uniform Business Organizations Code, adopted by the Uniform Law Commission in 2011 (last amended in 2013) (Uniform Act). This Derivation Table shows, with respect to the provisions of Article 0.5, (a) where they constitute new law; or (b) the provisions of former law from which they were derived or relate. Some but not all such derivation information is also included in the Comments. This Derivation Table has not been prepared by the Indiana General Assembly or its Legislative Services Agency, and has no official status. Rather, it has been prepared by the Indiana Business Law Survey Commission (BLSC) which believes it to be correct. Please notify the BLSC, c/o Business Services Division, Office of the Indiana Secretary of State, of any errors. The BLSC is also preparing, but has not yet completed, Comments to Sections 5 and 6 of P.L. 118-2017, based in part on comments to the Uniform Act adopted by the Uniform Law Commission which such changes as the BLSC deemed necessary or appropriate.

Uniform Business Organization Transaction Act

Section 6 of P.L. 118-2017, the Uniform Business Organization Transaction Act, creates a new Article 0.6 in Title 23 of the Indiana Code. This article consolidates and harmonizes to the extent appropriate certain provisions governing merger, interest exchange, conversion, and domestication transactions involving business corporations, general partnerships, limited liability partnerships, limited partnerships, non-profit corporations, and limited liability companies, previously set forth in IC 23-1, IC 23-4-1, IC 23-16, IC 23-17, and IC 23-18, respectively. This article also applies to such transactions involving professional corporations, benefit corporations, and series limited liability companies in the circumstances and to the extent authorized by IC 23-1.3, IC 23-1.5, and IC 23-18.1, respectively. This article is based on Model Entity Transactions Act, adopted by the Uniform Law Commission in 2007 (last amended in 2013) (Model Act). This Derivation Table has not been prepared by the Indiana General Assembly or its Legislative Services Agency, and has no official status. Rather, it has been prepared by the Indiana Business Law Survey Commission (BLSC) which believes it to be correct. Please notify the BLSC, c/o Business Services Division, Office of the Indiana Secretary of State, of any errors. The BLSC is also preparing, but has not yet completed, Comments to Sections 5 and 6 of P.L. 118-2017, based in part on comments to the Uniform Act adopted by the Uniform Law Commission which such changes as the BLSC deemed necessary or appropriate.
