Mail Policy


Indiana law prohibits a dealer from having a mailing address other than their established place of business.*

One of the most common reasons mail is returned to our office is because the dealer does not have a mail receptacle. In the past, dealers have been permitted to come pick up this returned mail from our office. **We are discontinuing this practice.** Dealers will be allowed to pick up their mail one final time to allow for the transition.

Processing returned mail takes up a lot of time for our licensing clerks. We'd much rather they spend their time doing the work that helps keep your businesses running.

Change in Location

Please be sure our office is on the list of people you notify when your dealership moves! For a step that might seem obvious, this is frequently missed. You are required to submit your change of address form to our office no later than 10 days after you have moved.

Just like your original location, your new location must be approved by our office. In order for your change of address to be approved, you need to submit:

- a Retail Merchant Certificate with your new address
- a current bond with your new address
- current insurance with your new address
- a completed zoning affidavit (IC 9-32-11-2)

The examiner for your area may ask for pictures of your new location. Please be prepared to provide those upon request.

Ownership Changes

When a dealer first applies for a license, they are required to list the owners. Unfortunately, many dealers fail to keep this portion of their license updated as business partners move on to new ventures, retire, etc. Not only is this a statutory violation, it leaves the dealer open to license tampering by former business partners. It can also add time and hassle to processes with our office down the line.

You must notify our office if a dealer owner* or dealer manager^ changes. You are required to notify our office no later than <u>10 days</u> after the change has occurred.


Please remember that new dealer owners or dealer managers coming on board must submit to a criminal background check.



Vehicle Inspection

Please note that employees of licensed Indiana dealers do not need approval from our office to perform vehicle inspections. This change was effective July 1, 2016 but we continue to receive applications (State Form 43724). Please update your policies and procedures accordingly.





License Application Form

Effective January 1, 2020, the application for a new license is only available as an online form. Paper applications are no longer accepted. The application is available on your dealer portal and a help guide is available here.

This change will only impact dealers who are applying to be granted a license. Please note this change does not impact any other application or request.
