#### **Hoosier Helping Hoosiers effort a success statewide**

The Hoosiers Helping Hoosiers Food Drive, held in February, was a great success and state employees all over Indiana are to thank. During the month, Employees donated their

collections to area food banks, but it didn't stop there. Portions of statewide donations were delivered directly to tornado victims in Southern Indiana.

On March 2, a tornado struck in the small Ripley County town of Holton causing severe damage. In response, Ripley County Department of Child Services (DCS) employees came in the following weekend and delivered most of their donations to Holton to help the relief effort.

"[Our employees] went door to door to deliver food directly to those in need and also dropped some off at the emergency shelter in Holton," said Ripley County DCS food drive coordinator Colbi Lehman. Her office collected a whopping 198 items per person, thanks to an in-house collecting contest, as well as donations from local businesses and churches.

"We had success with a silent auction of food and other items and that doubled our donation from other areas," Lehman added.

Ripley County was in direct competition with their next door

neighbors in Dearborn County, which finished third in the county and district offices category. Dearborn's office collected an outstanding 163 items per person. Lehman noted that the

Dearborn office now owes the Ripley office lunch.

This year, more than 60 agencies and 261 divisions collected more than 118,100 non-perishable food items and \$19,000 in cash for the annual food drive sponsored by the Office of First Lady Cheri Daniels.

"The 2012 food drive was a success due to the generous spirit of state employees," First Lady Cheri Daniels said. "This year, state employees contributed more non-perishable food items and financial donations to the drive than ever before. These contributions will help countless Hoosiers in need, including those

affected by the recent tornadoes that hit the southern portion of our state." Success stories are plentiful when it comes to this year's drive.

> In Jennings County, DCS office coordinator Lil Shepherd reported awesome participation and great community involvement that helped her office collect more than 1,000 items for the first time. In fact, they collected 6,183 items, an astounding 257 items per person for the office of 24 employees. Overall, DCS ran away with the agency competition collecting 52,382 items and \$5,117 statewide.



#### **Governor Appointment**

#### **Connie Lawson** appointed new **Secretary of State**

On March 16, Gov. Mitch Daniels appointed Indiana State Senator Connie Lawson, of Danville, as the new Indiana Secretary of State, effective immediately.

"Connie was an obvious choice. Indiana has probably never been served by a Secretary of State better prepared on day one," said Daniels. "I want to reiterate our thanks to the staff of the



office, and in particular, Jerry Bonnet, for their superb professionalism during some difficult months. Thanks to them, the public has been well served every day."

Bonnet was appointed interim Secretary of State on February 4. He has resigned from the interim role and will return to his previous duties.

Lawson, Majority Floor Leader and a senator since 1996, brings local and state elections experience to the office. Before stepping down from the Indiana Senate, she was chair of the local government and joint rules committees. She has been a champion of local government reform efforts, authoring a bill this year to reduce nepotism and eliminate conflicts of interest. Lawson also spent six years as the chair of the Senate Elections Committee and has continued to serve as a ranking member.

Lawson was clerk of the Hendricks County Circuit Court from 1989 to 1996. During her tenure, she was named election administrator of the year by the Indiana State Election

with a "Pound for Pound Challenge." Hunter challenged her other 72 employees to pledge a donation of one dollar or a pound of food for each pound of weight she lost. Hunter started the challenge last June 1 and donations started coming in. And the pounds kept coming off for Hunter, who lost 40 pounds by the end of the food drive.

"I had some co-workers starting to get nervous as I reported the weight loss," Hunter recalled laughing. "They were asking me how long they had to get the money."

In addition, Hunter organized a competition between divisions, with the winner getting a pizza party. They also raised money with a dessert cart day, chili day, a pancake breakfast and blue jean day vouchers in exchange for donations.

Hunter said she already has a new "Pound for Pound Challenge" planned for next year.

In LaPorte, it was all about the money! The Department of Transportation

(INDOT) district office was the top money collector with \$2,253, thanks to Cindee Mckie and Pat Toth coordinating the efforts of 535 employees.

April Bentley served as the coordinator at Stout Field, where soldiers earned Friday jeans passes for donations of four canned items or two boxed items.

The big event was the "pie in the face" celebration. The top collecting teams were allowed to put pies in the faces of Adjutant General Maj. Gen. Martin Umbarger, Col. Hines, Col. Kruz, Col. Copes, Col. Westfall and Bentley.

Bentley also secured a donation of 6,500 items from the local Kroger. All of the food donations went to families of Stout Field.

The signature event for the food drive was IndiCANa, a structure building competition with cans. The team of Pete Miller, Adam Horst, Jay Collins and Brenda Mathews from the State Budget Agency took top honors recreating the Super Bowl zip line with a can structure.

## Rescinding your Tobacco Agreement could save your job, if you smoke

If you signed up during open enrollment promising not to use tobacco products during 2012 and you are still using tobacco products, your failure to keep that promise is placing your job at risk. The name of each employee who signed the agreement has been placed in a pool for random selection to be tested for tobacco throughout this calendar year.

Testing dates and locations are not identified in advance, and anyone testing positive is subject to dismissal from employment. Employees are also subject to testing under reasonable suspicion if the State receives a report that an employee who has signed the agreement is, in fact, using tobacco products.

By quitting smoking, you not only reduce your risk of lung cancer and heart disease, but also improve your overall health and even add years to your life. However, anyone who has tried to quit would agree it is very difficult. If you have tried to quit, but

are unsuccessful at this point, you need to immediately rescind your agreement by logging into PeopleSoft. To get to the Rescission Request page, go to: Self Service ⇒ Benefits ⇒ Rescind Non-Tobacco Use Agreement.

Follow the prompts to submit your request to rescind the agreement. If you need assistance, contact the State Personnel Department Benefits Division at 232-1167 or toll-free at 877-248-0007.

Once you have submitted your request and your rescission is approved, your health care insurance premium will increase by \$25 biweekly and any premiums from pay periods in which you received the incentive will be collected. However, your job will be secure. For assistance in becoming tobacco free, you may call the Indiana Tobacco Quitline at 1-800-Quit-Now. This free service is available to all Hoosiers seven days a week from 8:00 a.m. until midnight.



#### Indiana again earns national recognition for government transparency



For the second year in a row, two national organizations have recognized Indiana's

efforts to bring transparency to state government. The Sunshine Review and the United States Public Interest Research Group (US PIRG) have both awarded Indiana "A-" grades for the accessibility of state websites.

"Making state government more transparent has been one of our priorities for more than seven years. We'll continue our push to be a national leader in operating an open and honest government," Governor

Mitch Daniels said.

The Sunshine Review, a national non-partisan government transparency agency, selected the state of Indiana as one of only 214 government entities for its 2012 Sunny Award, recognizing commitment to government transparency. The organization analyzed more than 6,000 government websites for the proactive disclosure of information regarding budgets, meetings, lobbying, financial audits, contracts, academic performance, public records and taxes. The ease of use and availability of information is also taken into consideration.

US PIRG rated Indiana's transparency

portal third best in the country with a grade of "A-." The transparency site, launched in August 2010, was recognized for offering a checkbooklevel, user-friendly interface and providing information on payments to specific vendors. Additionally, users can customize their search to look for expenses incurred over a particular period of time, in a specific geographic area, by a particular government agency or of a certain dollar amount.

#### **SECC** recognizes record breaking contributions

State agencies were recently recognized for raising \$1.21 million in charitable donations, the most money in the State Employees' Community Campaign's (SECC) history at an awards ceremony at the Indiana State Library.

During the March 22 ceremony, the 2011-2012 SECC Chairman, The Adjutant General Maj. Gen. Martin

Umbarger, welcomed attendees and thanked the agency coordinators for their hard work during the campaign. He then introduced Sally Irvin, founder of Indiana Canine Assistant Network (ICAN), one of 1,500 charitable organizations that benefit from SECC donations.

Irvin spoke about how the organization works to both rehabilitate prisoners and train assistance dogs for people

with disabilities. The program engages the abilities of adults incarcerated within Indiana correctional facilities to help train the dogs for service work. ICAN is one of the few prison-based programs where clients receiving a dog visit the prison facility and are trained on-site to work with their new dog by ICAN staff and offenders working within the ICAN program. This year ICAN received more than \$2,000 in pledges through SECC.

During the ceremony State Personnel Director Dan Hackler, who helped oversee the campaign, was awarded the Indiana Distinguished Service Medal for his service to his country in South East Asia and for his "tireless efforts to improve the quality of life for fellow Hoosiers."

The pledges of more than 5,500 employees helped SECC to have its most successful year yet. 61 agencies reached the per capita giving level, meaning they raised at least \$50 per person within their agency.

Champion-level givers, those who give at least one-half hour's pay per paycheck, represented only 18 percent of the givers, but accounted for more than 50 percent of the amount given.

## Check on your FML Expiration & Recertification status

If you have a current Family Medical Leave (FML) approval for intermittent leave, you may be wondering what happens to that approval at the end of the fiscal year or if the need continues beyond June 30, 2012.

Indiana state government has designated the fiscal year as the twelve-month period to calculate FML. The fiscal year runs from July 1 through June 30. This means that all FML approval(s) for intermittent leave expire June 30, with the new fiscal year beginning July 1.

Employees who have an approval for intermittent FML in the current fiscal year (July 1, 2011 through June 30, 2012), and expect the need for FML to continue after June 30th of this year, are required to submit a new Request and Certification of Health Care Provider (CHCP) form documenting that need.

The CHCP must be from a recent, in-person medical exam. Absences for continuing conditions are foreseeable; therefore, your request and CHCP should be submitted 30 days in advance of the new fiscal year. The CHCP form must be filled out completely by the health care provider and needs to include a description and/ or details of the medical necessity for leave and the estimated frequency and duration of absences for which you are requesting leave. Timely submission of the documentation is your responsibility, not the health care provider's. Proper and timely completion of the required forms should reduce the number of requests for additional information and recertifications needed during the year.

## FML Expiration & Recertification

for the new fiscal year. Employees who have been employed less than 12 months and/or who have not worked

at least 1,250 hours in the immediately-preceding twelve-month period will not be eligible for FML in FY2012/13 until they meet those threshold requirements. Additionally, second and third medical opinions may be required.



What if you need a continuous leave for something like a surgery scheduled in May or June and your recovery will continue beyond June 30? If you receive approval for a continuous family-medical leave that crosses the fiscal year mark, then you do not need to submit new documentation just to support the part of that approved leave that occurs after June. However, if additional leave is needed in the new fiscal year beyond the initial return-towork date in the approval, then new requests and certifications must be submitted documenting the changed circumstances.
